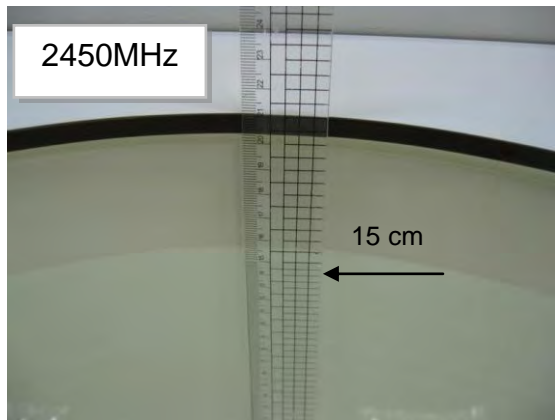

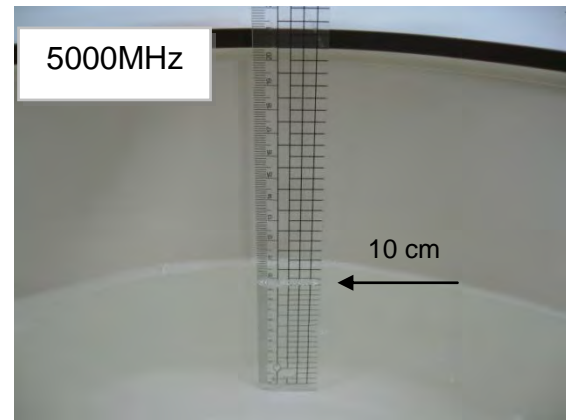

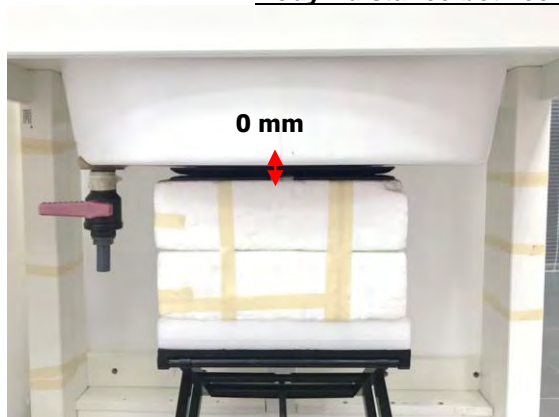

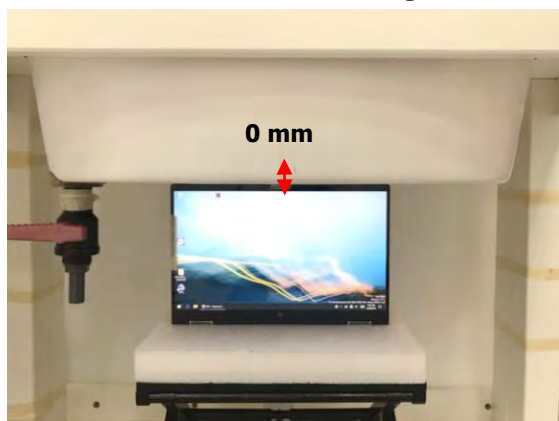

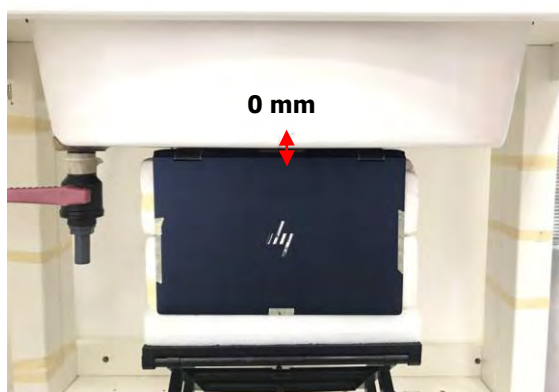

**Fig.8 EUT Bottom side (Laptop mode) to flat phantom**

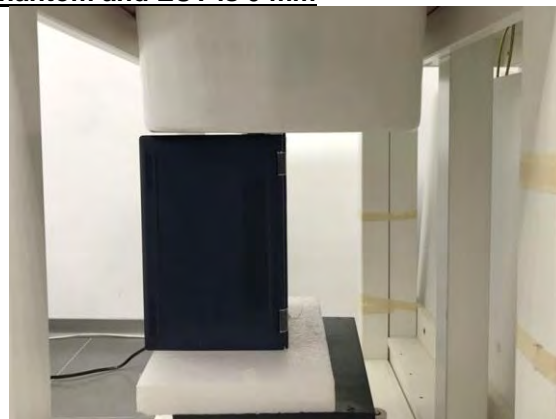
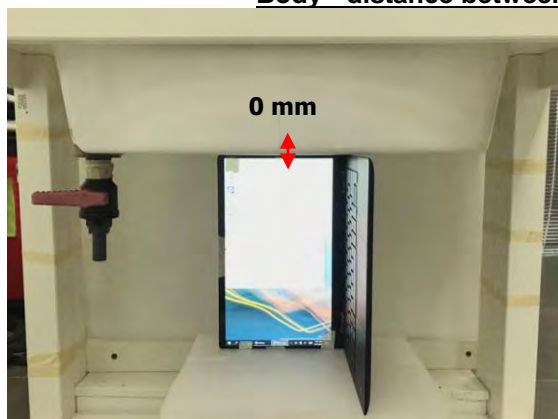

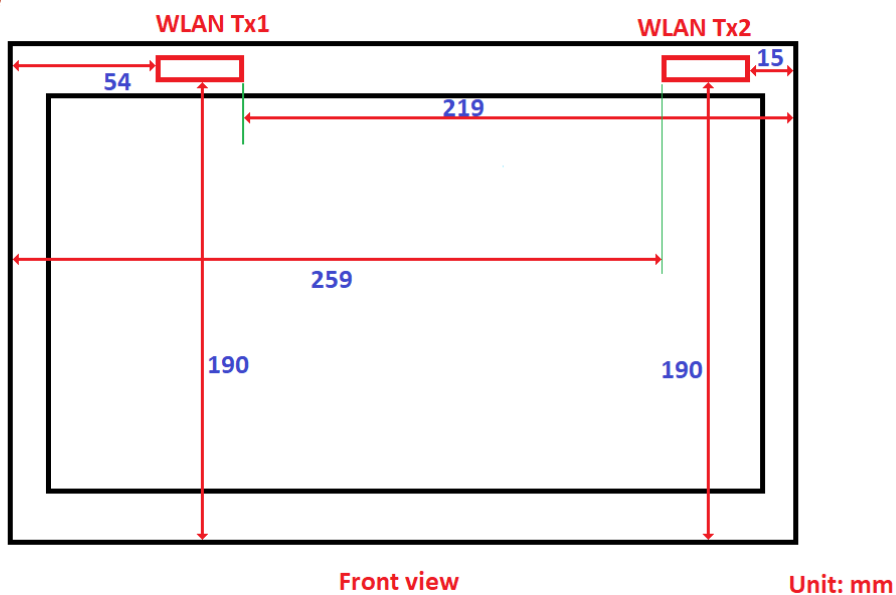


Fig.13 Antenna position of EUT (Tablet mode)

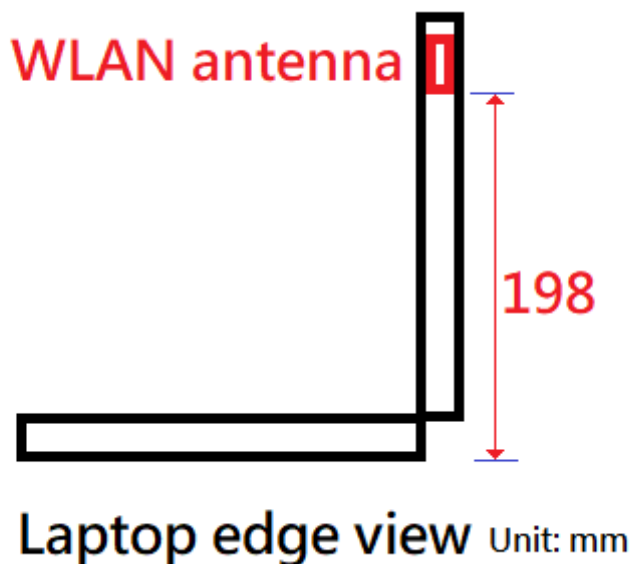


Fig.14 Antenna position of EUT (Laptop mode)

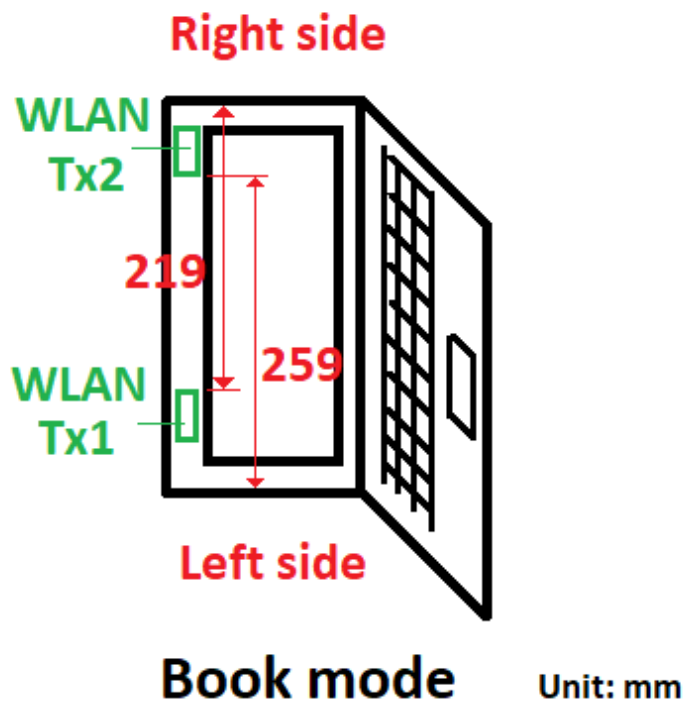


Fig.15 Antenna position of EUT (Book mode)
