Dear Alice,

On submitting our Test Reports to the FCC, along with the waiver grant that you provided us via email, we got the following response from the FCC:

- 1. Follow KDB Publication 502150 D01, most importantly, clause 6 and 7.
- 1.1 As such, provide a copy of the waiver as a supporting attachment, comply with clause 6. d)
- 1.2 The Grantee name must comply with the KDB Publication 502150D01, clause 7.
- 2.What is the Waiver number? Email correspondence is not considered as proof of Waiver. A waiver must be granted by FCC, and itmust have assigned specific waiver number by FCC. If they follow KDB Publication 502150 D01, clause 5, they must havethe proper Waiver with subsequent Waiver number. Example of Waiver is Waiver DA 23-343. If you google, "Waiver DA 23-343" orjust "DA 23-343", you can see it. "DA 23-343" is the specific number we referred to in this response. Your waiver should look like this.
- 3. Yourapplication indicates that Waiver was granted on 6th December 2023. Pleaseprovide copy of that grant. As indicated in #2 above, it must be from FCC with specificwaiver number. Example of Waiver is Waiver DA23-343. It you google, "Waiver DA 23-343" or just "DA 23-343", you can see it.
- 4. Itappears that even the FCCID: K6KSMALLSATCOM was granted incorrectly. We will take corrective actions. Ifyou have a Waiver letter from FCC with specific waiver number, we will audit theapplication and allow you to upload it. Otherwise, we will be forced to takeappropriate action. Exampleof Waiver is Waiver DA 23-343. If yougoogle, "Waiver DA 23-343" or just "DA 23-343", you can see it.

It seems that the email response indicating that the waiver has been granted is insufficient, and the waiver needs to be published, and given a "DA XX-XXX" number.

As you can also see form their response, they are retrospectively looking at our previous submission and indicating that it had been done incorrectly. Please would it be possible to publish the waiver for K6KSMALLSATCOM too, otherwise, from what I understand from their correspondence, they are potentially looking like they could revoke our FCC approval for this device.
