Band7-5MHz-QPSK-21100-1RB#0

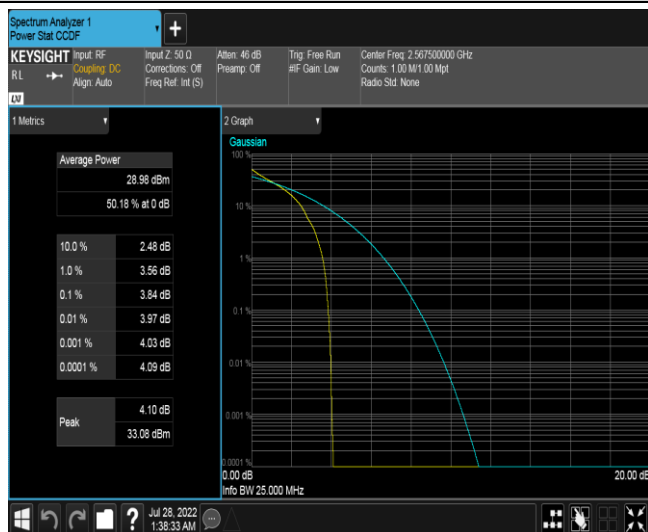


Band7-5MHz-QPSK-21100-25RB#0

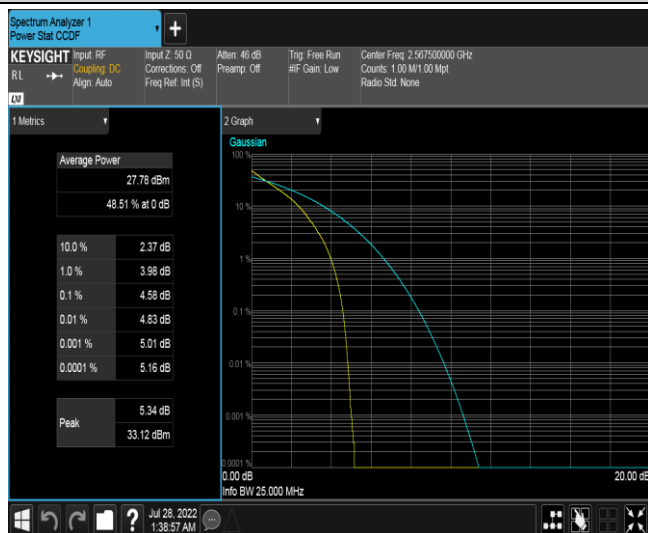

Band7-5MHz-16QAM-21100-1RB#0



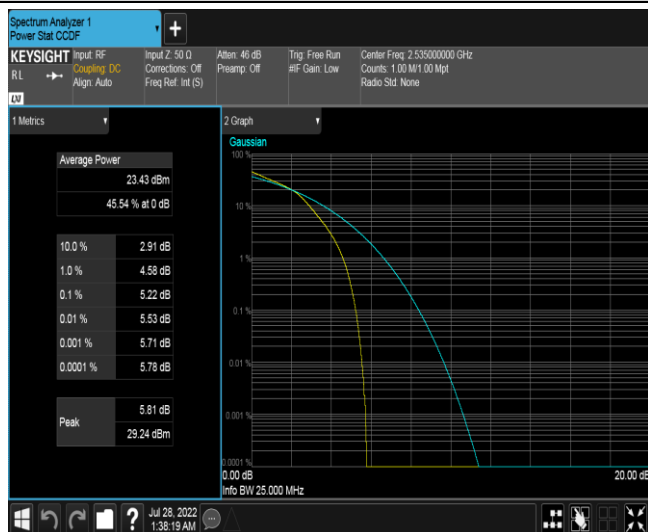

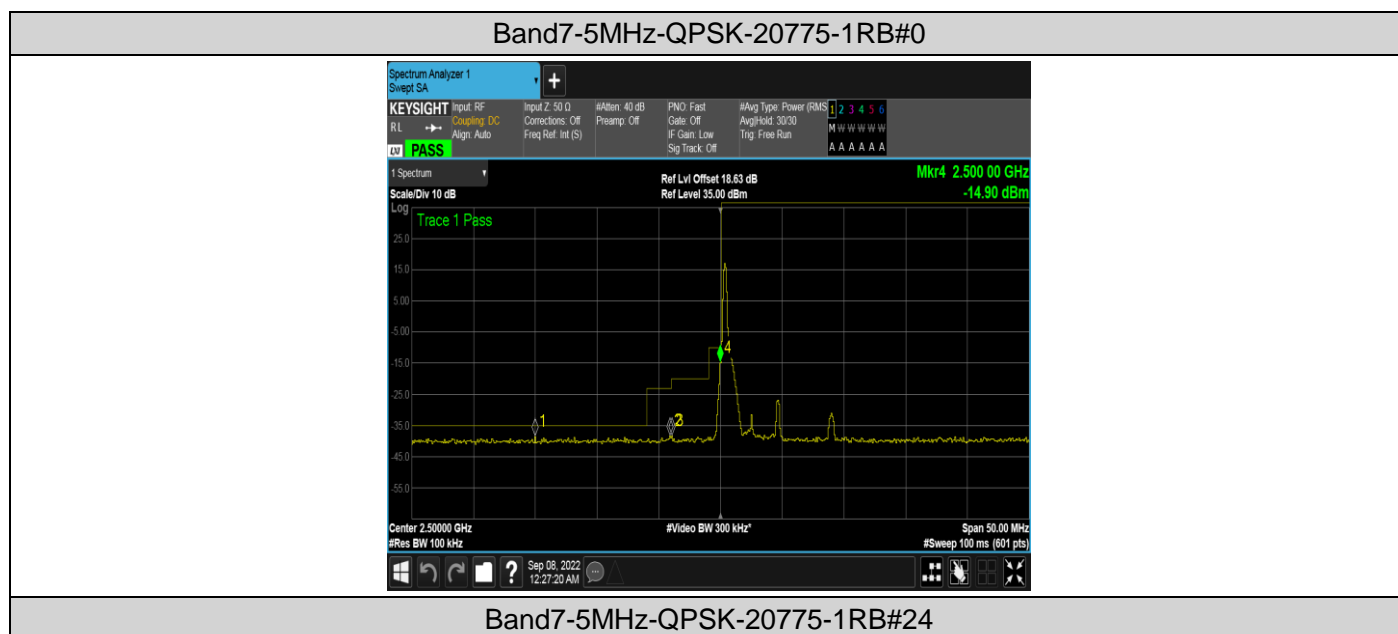
