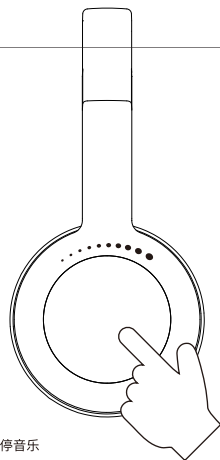

功能说明

- 1.开机:关机状态下,长按旋钮键3秒开机,设备启动自动进入蓝牙模式,LED指示灯红蓝交替闪烁。
- 2.关机:长按旋钮键5秒关机,LED 指示灯熄灭,设备关闭。配对超时自动关机,配对超时时间5分钟。

按键指引

- 1.接通电话：来电时短按旋鈕键
- 2.挂断电话：通话中短按旋鈕键
- 3.语音助手：长按旋鈕键3秒
- 3.播放音乐：正常状态下短按旋鈕键,自动打开智能设备播放音乐。
- 4.通话后继续播放：有来电时,自动暂停播放中的音乐,通话结束后继续播放。

蓝牙模式

1. 开机自动进入蓝牙模式, 听到提示音铃声, 耳机自动进入蓝牙配对模式, LED指示灯蓝红快速交替闪烁, 打开开发设备的蓝牙功能, 开启搜索并选择设备“E65”, 配对成功后LED指示灯蓝灯慢闪。
2. 后续配对: 开机后1秒内, 会自动搜索并连接最后一次与之配对的设备。
3. 最大音量警示音: “Volume Max”
4. 省电模式: 匹配状态持续5分钟无任何操作, 耳机自动关机。

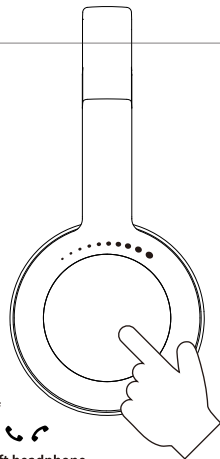

Button Function

- “  ” Long press: **Power on/Power off**
- “  ” Press 1 time large button:    
- “  ” Vol down/up: **Rotating on the left headphone**
- “  ” Next song: **Press*3 times**
- “  ” Previous song: **Press*2 times**

Function Description

1. Power on: Long press button for more than 3 seconds, the headphone turn on and enter Bluetooth Mode. The blue and red lights flash alternately.
2. Power off: Long press button for more than 5 seconds, the LED indicator light is off and the headphone turn off. Pairing timeout Automatically shuts down, Pairing timeout lasts 5 minutes.

Button Guide

1. Hang on: Short press “” button when being called.
2. Hang up: Short press “” button when calling.
3. Voice assistant: Long press “” for 3s.
4. Continue to play music after the call: When there is an incoming call, the music will be automatically suspended. After the call, the music will continue playing.

Bluetooth mode

Repairing: turn off the Bluetooth function of the connected smart devices, at this time, the Bluetooth headset and the last matching device got disconnected, LED light flashed between red and blue, and enter the Bluetooth pairing mode, then turn on the Bluetooth function of the smart devices, search the device named "E65" to get connected without a password, after pairing successfully, voice prompts "Connected", the blue LED is on and flash per 2 seconds after working.

Subsequent pairing: 1 second after powering on, it will automatically search and connect the smart device which paired last time.

Warning voice of maximum volume: "Volume Max"

Power saving mode: headset will automatically power off after pairing continuously for 5 minutes; it will cut off power supply.

LED indicator

Charging	red LED is on when charging, and blue LED is on after full charged.
Powering off	The indicator is off
Pairing	Blue and red LED flashes alternately
