In daily use, please choose a suitable size for your fingers, avoiding wear it too tightly, keep the dry contact area of the ring, and wipe it in time when it comes into water. If have symptoms such as redness and swelling appeared in the contact area, please stop using immediately and consult the doctor.</div> <div>Secure</div> <div>Please keep the charging cable and device in a dry environment when charging. Do not touch the charging cable with wet hands and avoid it being immersed in liquids such as water. Do not disassemble or modify the battery, insert foreign objects, or immerse it in water or other liquids to avoid causing battery leakage, overheating, fire, or explosion.
