Any and all acts carried out by either Amanda Wu and/or Joanna Hung of "BV CPS Taoyuan" on the matters relating to all processes required in the FCC approval and any communication needed with the national authority, shall have the same legal authority as acts on PNA's behalf.

- i) Keep a record of all complaints made known to the us relating to the product's compliance with requirements of the relevant standard and to make these records available to the Certification Division when requested;
- j) Take appropriate action with respect to such complaints and any deficiencies found in products or services that affect compliance with the requirements for certification;
- k) Document the actions taken.

This authorization is valid for one year period from the date of this letter. This application for the subject equipment has not been submitted to another TCB for certification
