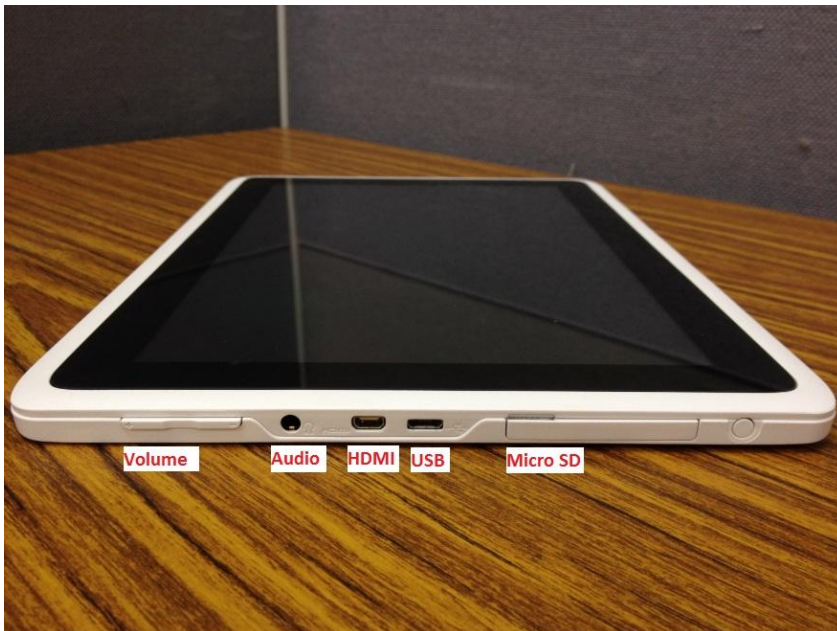

2. Insert the adapter plug into a mains micro USB jack for USB adapter option.



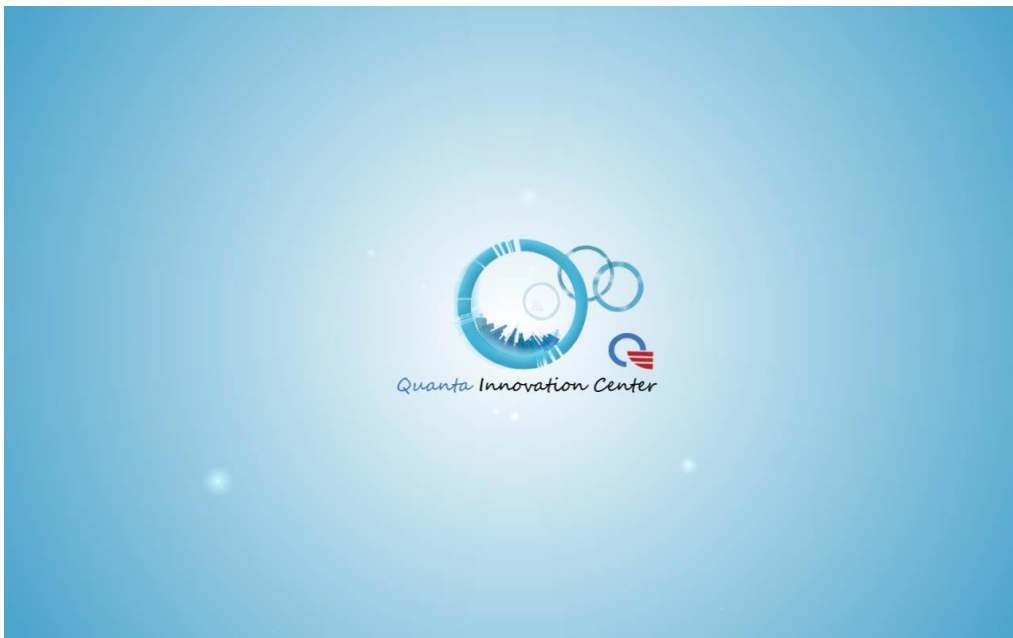

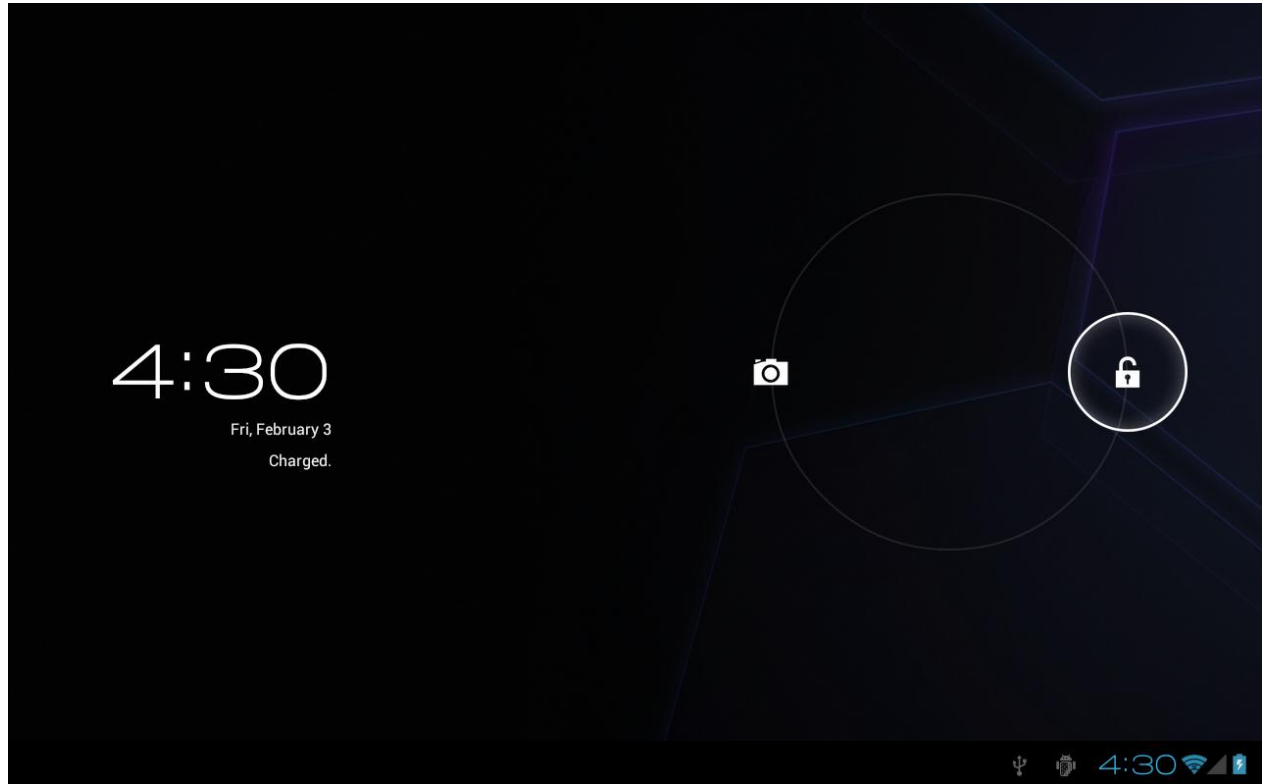


To put Tablet on suspended mode

2. To slide the lock icon in the right to “unlock” the system

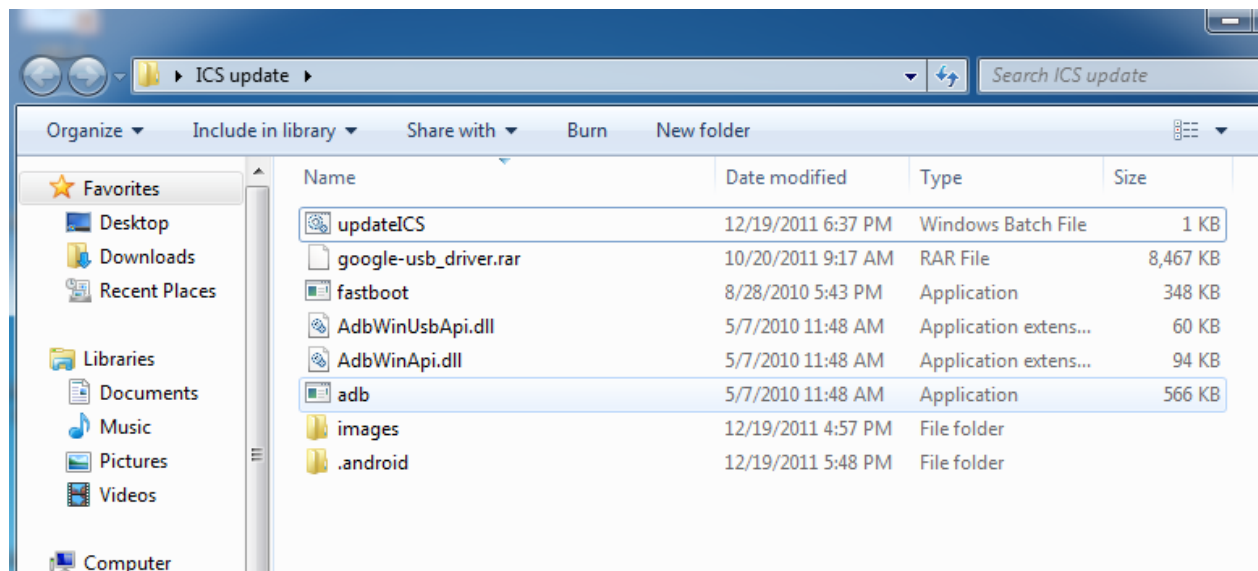

The exposure standard for wireless device employs a unit of measurement known as the Specific Absorption Rate, or SAR.
