This report details RF Exposure assessment for OCW Earpiece PTT model number PMLN7815A. This device classified as Occupational /Controlled.

4.0 Description of Devices under Test (DUT)

This device incorporates a Class 2 Bluetooth device which is a Frequency Hopping Spread Spectrum (FHSS) technology and Bluetooth Low Energy intended to provide considerable reduce power consumption. Bluetooth LE operates at frequency spectrum 2.4 GHz to 2.480 GHz with GFSK schemes with employ 40 channels (20 MHz channel bandwidth). The maximum actual transmission duty cycle is imposed by the Bluetooth standard. The maximum duty cycle for BT is 60%.

5.0 SAR Assessment at the Bluetooth band

5.1 FCC Requirement

Per guidelines in KDB 447498, the following formula was used to determine the test exclusion for standalone Bluetooth transmitter;

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] *[$\sqrt{F_{(GHz)}}$] = 0.47 W/kg, which is \leq 3 W/kg (1g)

Where:

```
Max. Power = 1.5 mW (2.5 mW*60% duty cycle)
Min. test separation distance = 5mm for actual test separation < 5mm F(GHz) = 2.48 GHz
```

Per the result from the calculation above, SAR test is not required.

5.2 Industry Canada Requirement

Based on RSS-102 Issue 5, exemption limits for SAR evaluation for controlled devices at Bluetooth frequency band with separation distance \leq 5mm is 20 mW.

Standalone Bluetooth transmitter operates at

Maximum conducted power:

- = 2.5 mW * 60%
- = 1.5 mW or 1.76 dBm

Equivalent isotropically radiated power (e.i.r.p):

- = Maximum conducted power, dBm + Antenna gain, dBi
- = 1.76 dBm 4.0 dBi
- = -2.24 dBm or 0.597 mW.

Output power level (higher of maximum conducted power or e.i.rp), conducted power 1.5 mW is below the threshold power level 20 mW (at separation distance \leq 5mm). Hence SAR test is not required.
