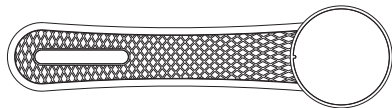


## Magnetic Charger

### What's included

- Wireless charger

### Installation Instructions

Recommended use:

- Wipe surface with alcohol pad and keep clean before applying adhesive tape
- Peel off adhesive tape and stick the hook and loop base to the desired surface
- Allow adhesive to sit for about 2 hours to ensure proper attachment
- Attach the charger to the hook and loop and bend the handle part of the charger to the desired angle
- Plug the provided power cable into a proper power source and into the back of the charger
- Place your phone on the center of the wireless charging area and watch as it begins to charge

### Attention

- Use with a phone case will affect the magnetic attraction
- Remove phone case for best charging results
- Avoid bending the charger past 180 degrees

- Only use provided power cable for charging product
- Product may become hot during charging, this is normal
