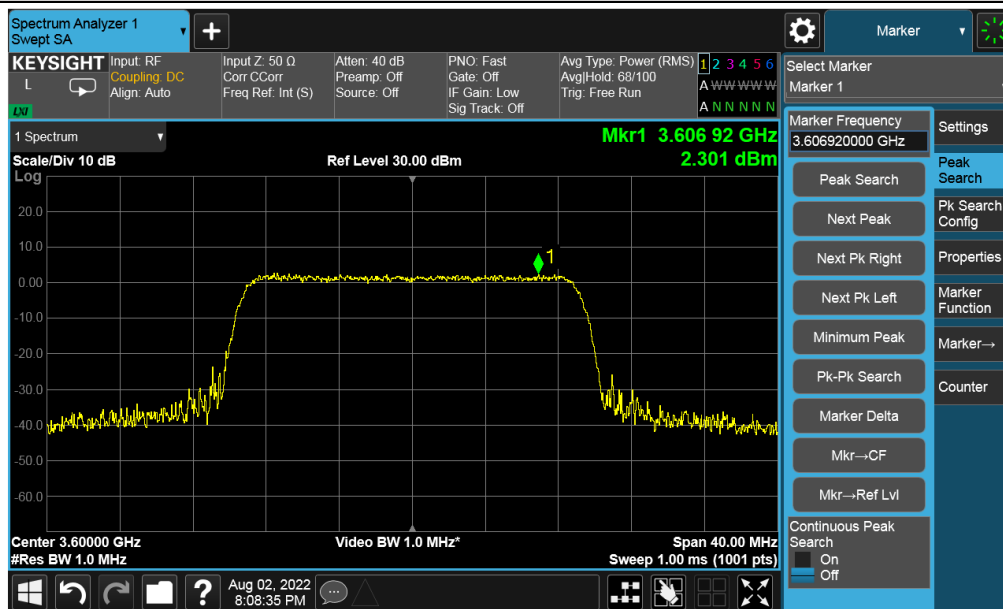

Check EUD Tx Frequency and power



EIRP PSD=2.301+1+6.02=9.321dBm/MHz, loss of Cable and Splitter is 1dB, Antenna gain is 0dBi.
6.02dB is corrected antenna gain and MIMO power factor
