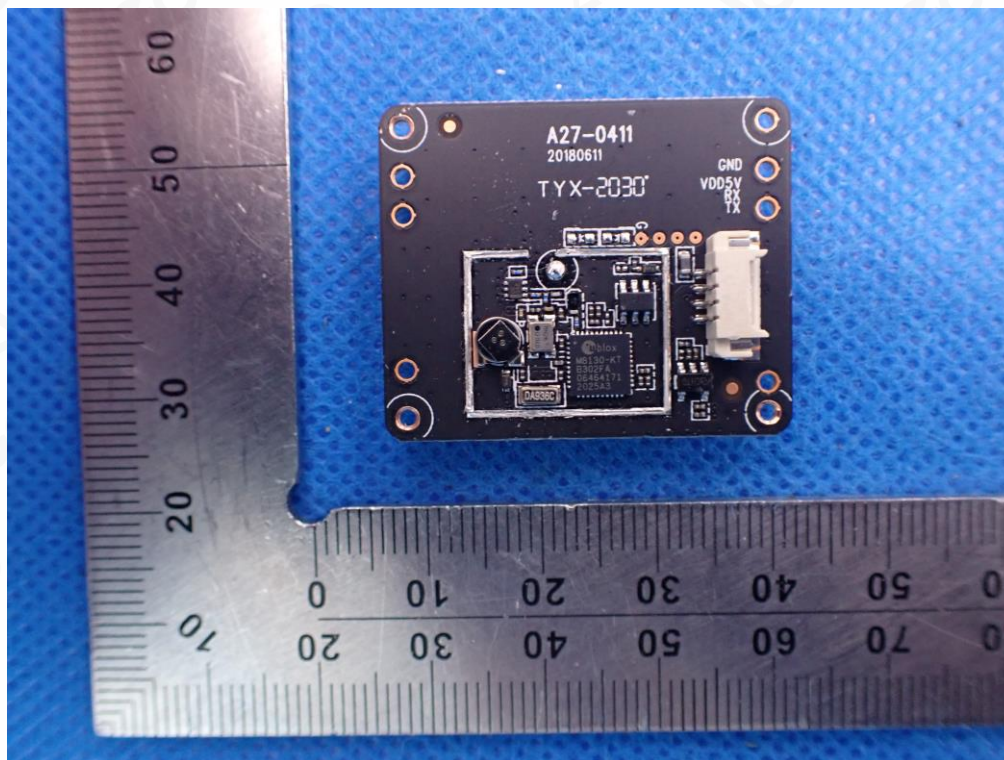




INTERNAL VIEW-2 OF EUT

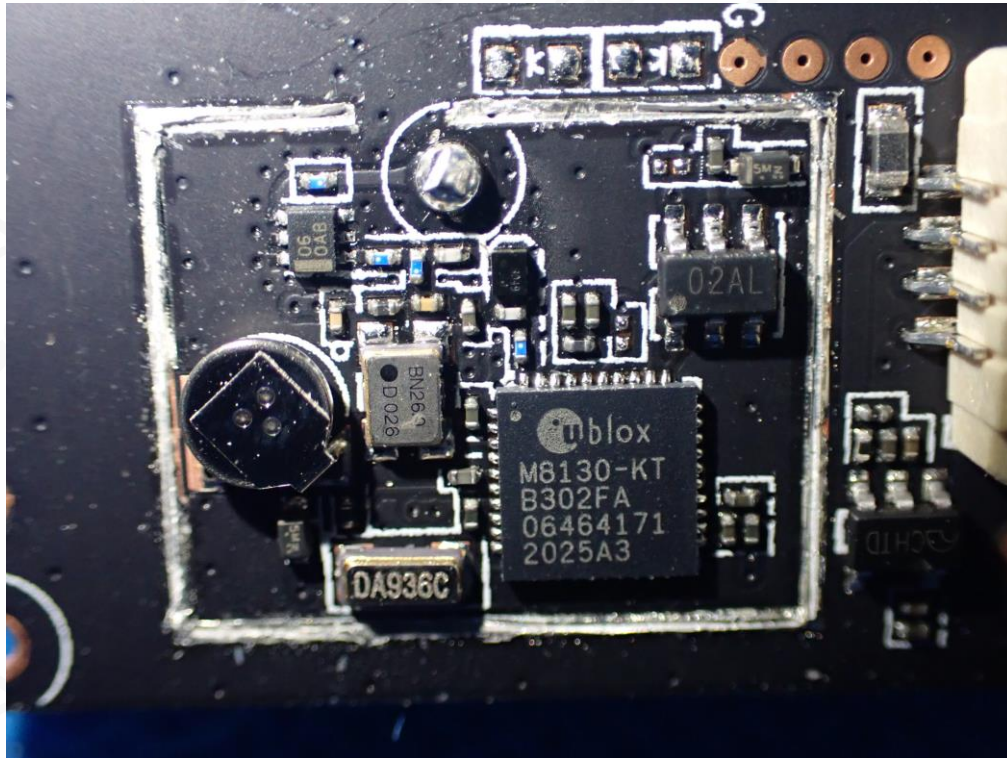

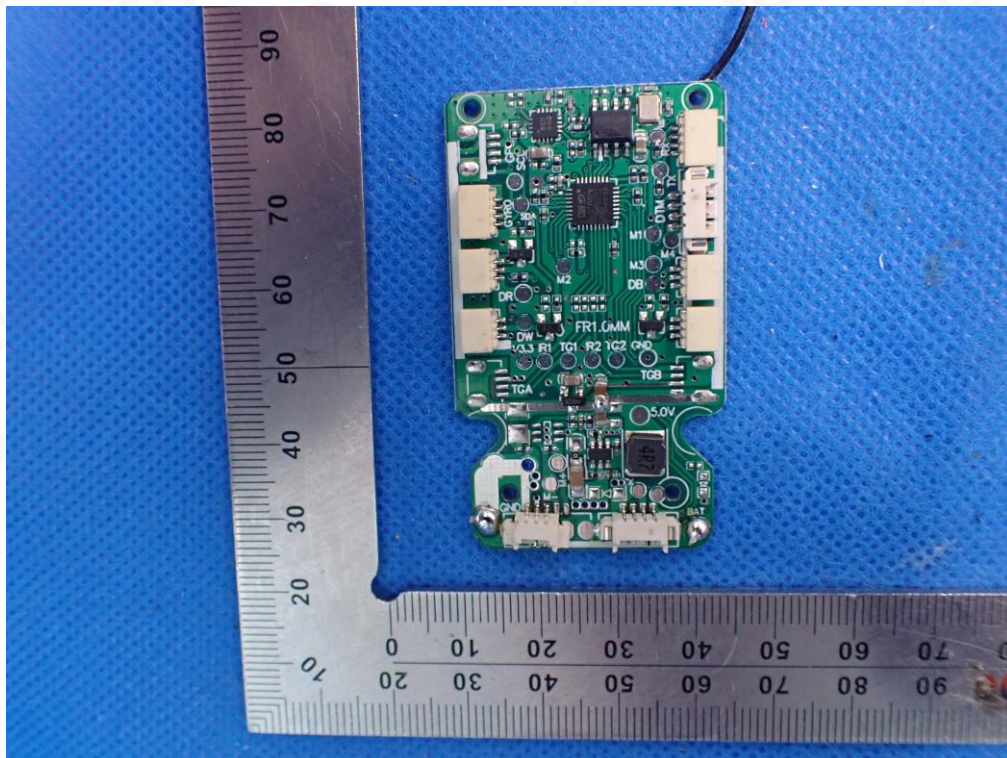




INTERNAL VIEW-4 OF EUT



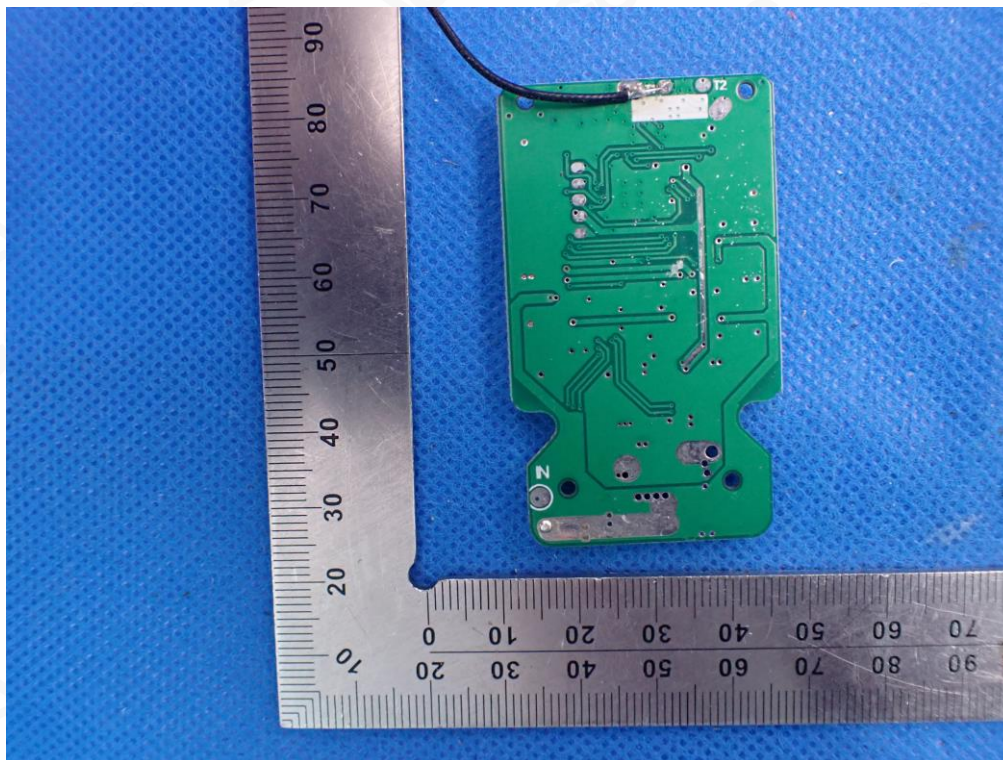

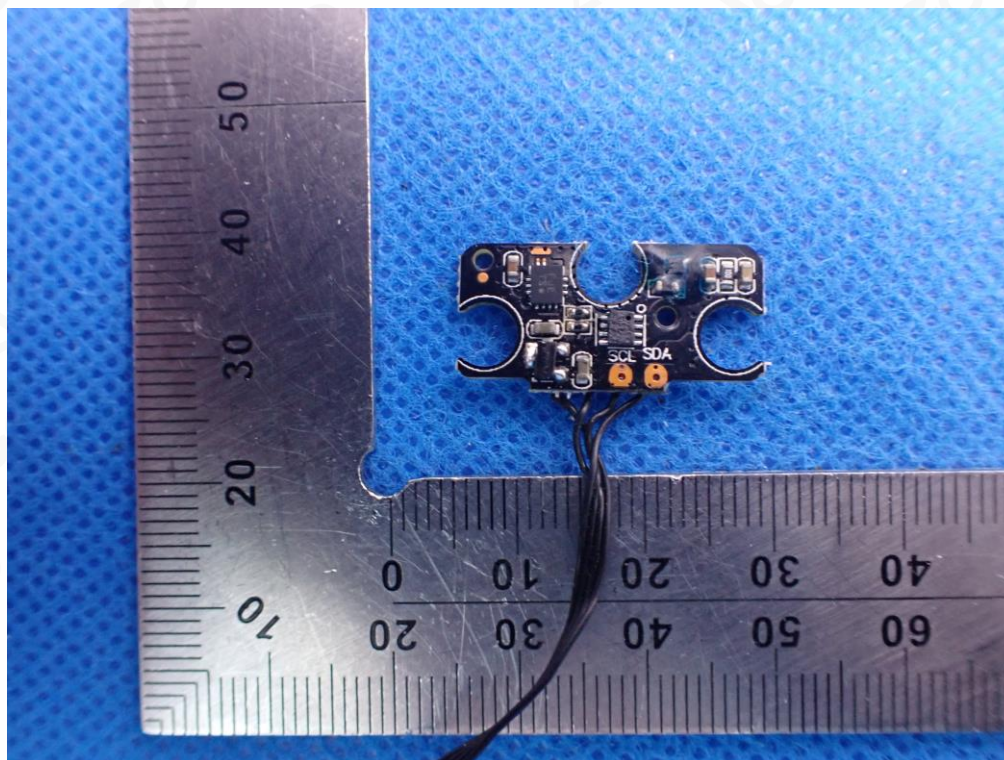

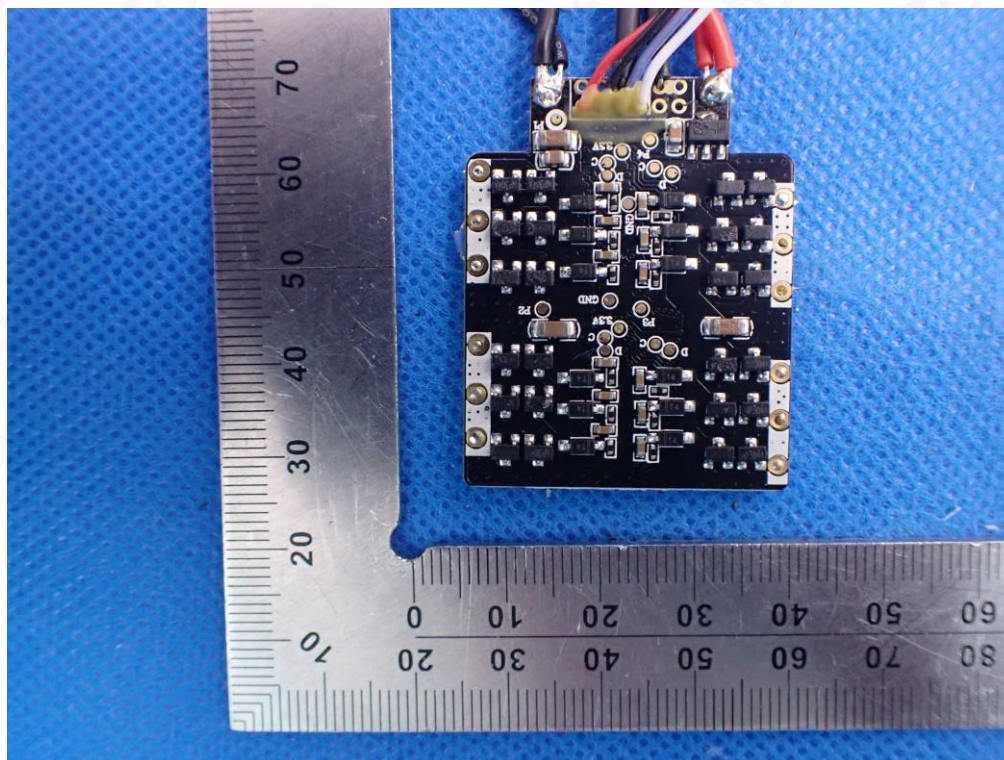

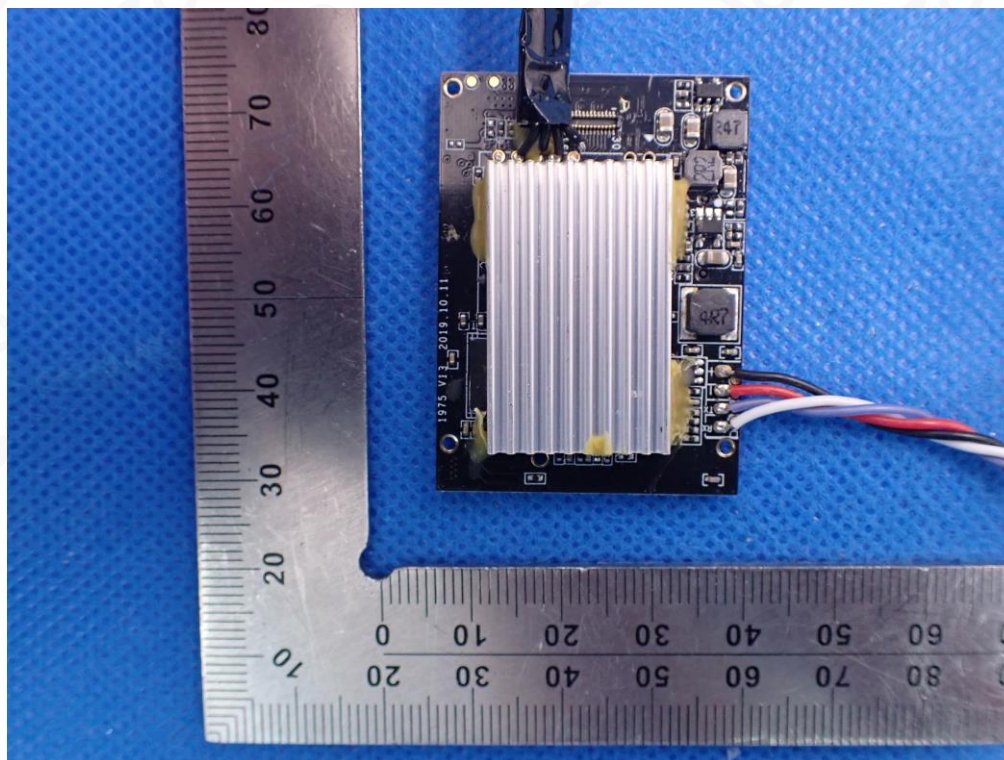




INTERNAL VIEW-12 OF EUT

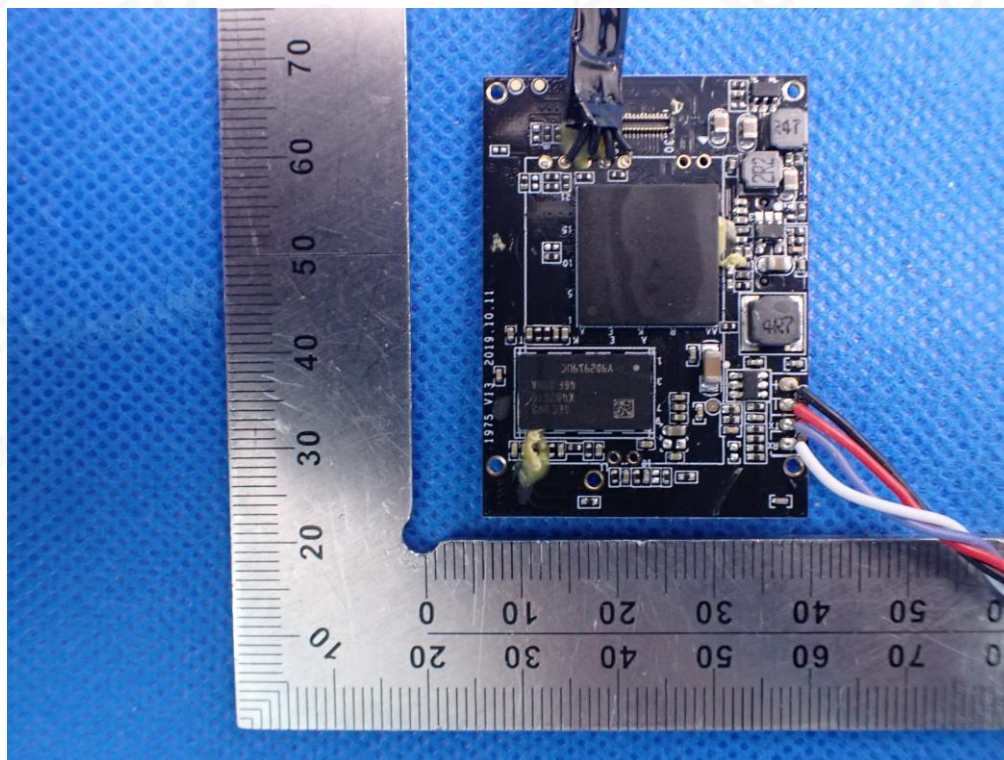

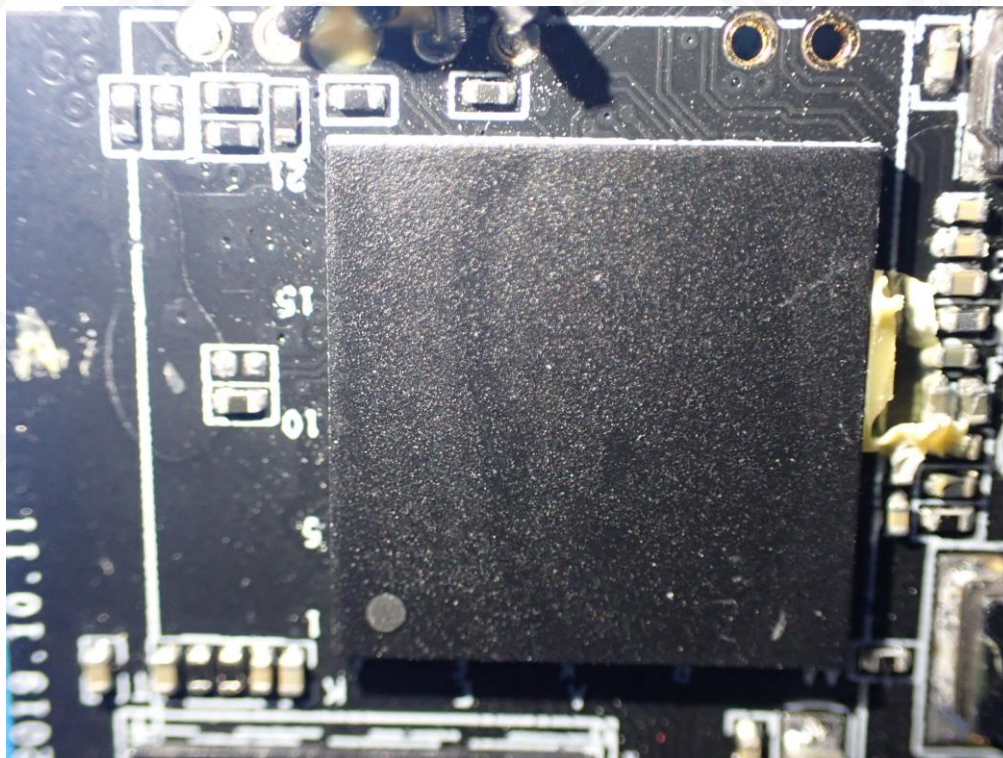

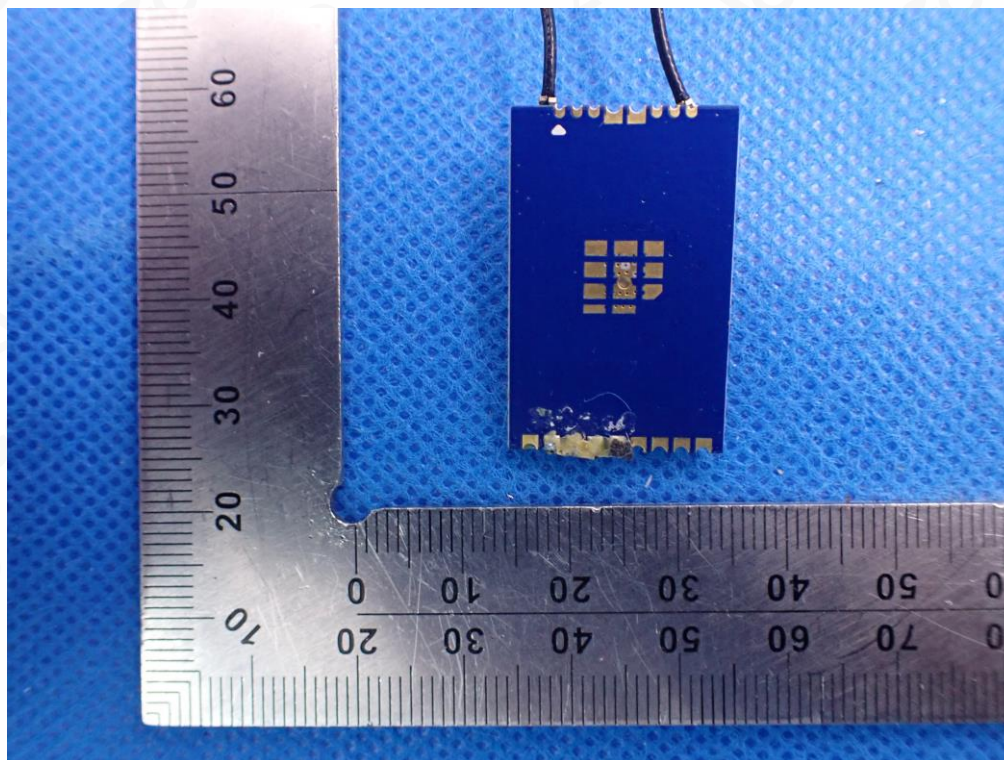

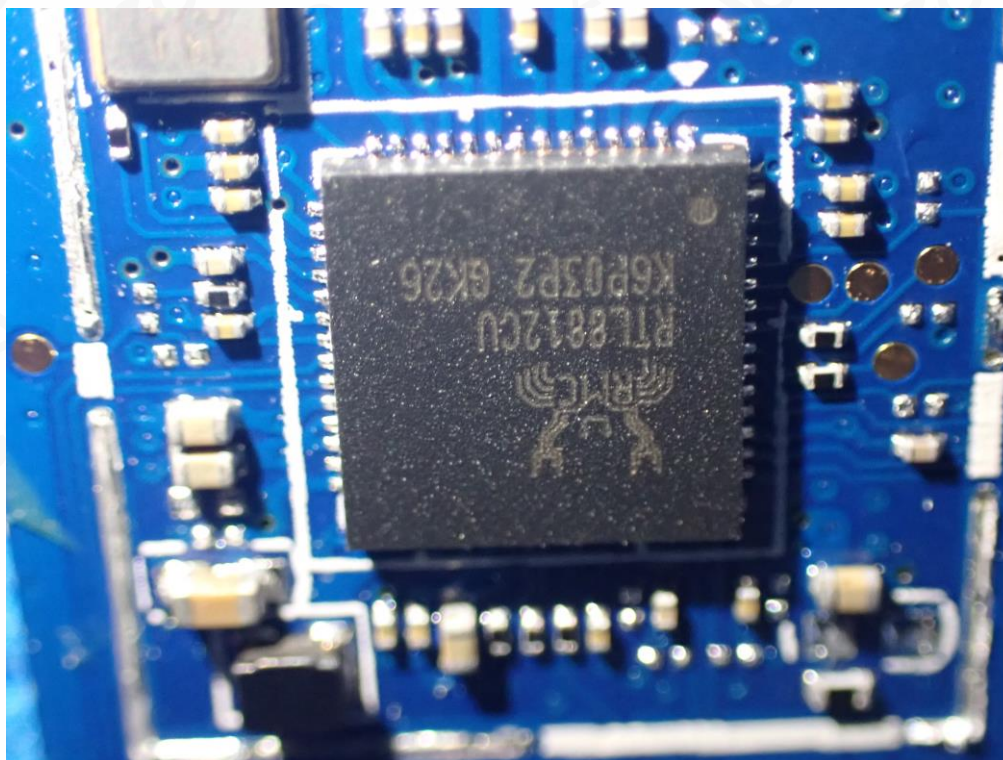

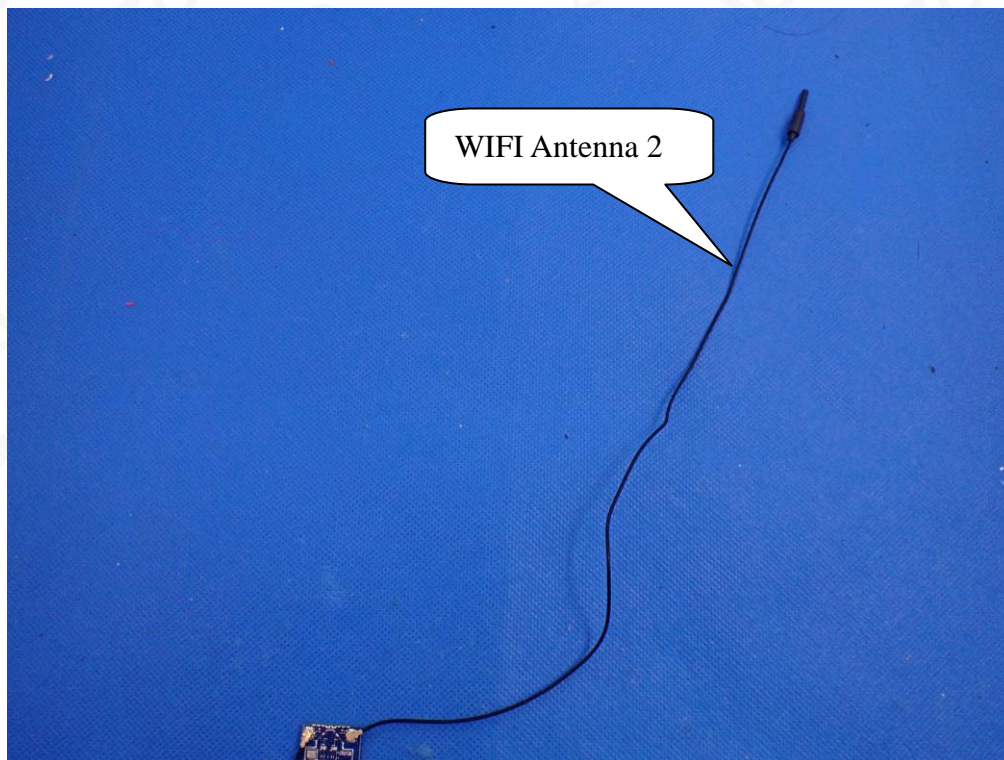
