



2.2 Assessment Results

Power density (S) is calculated according to the formula:

 $S = PG / (4\pi R^2)$

Where S = power density in mW/cm²

P = Power in mW

G = numeric gain of transmit antenna

R = distance (cm)

As we can see from the test report 240600229SHA-001:

56.5dBuV/m@3m, @20cm=@3m+40log(3/0.2)=103.54dBuV/m=0.15V/m<60.77.

RFID and all modules can transmit simultaneously, so the maximum rate of MPE is, 0.15/60.77+0.025/1+0.158/0.442=0.385 < 1.0.
