#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Hyundai Corporation* 's product, model number: D245 (FCC ID: RQQHLT-D24FSL) or the "EUT" in this report was a *Mobile Phone*, which was measured approximately:  $11.2 \text{ cm } (L) \times 4.7 \text{ cm } (W) \times 1.2 \text{ cm}$  (H), rated with input voltage: DC 3.7 V rechargeable Li-ion battery or DC 5.0 V from adapter. The highest operating frequency is 260MHz.

Note: This series products model: D245S and D245 are identical schematics, the difference among them is just the D245 has double SIM card, D245S has single SIM card and model number due to marketing purpose, and model D245 was selected for fully testing, the detailed information can be referred to the attached declaration letter that stated and guaranteed by the applicant.

#### **Objective**

This test report is prepared on behalf of *Hyundai Corporation* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

#### **Related Submittal(s)/Grant(s)**

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.







#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
