Catapult Sports Tag S7601 has 2 transmitters;

- 1) BLE transmitter operating in 2400 2483.5 MHz band.
- 2) UWB low power transmitter operating at 6489.6 MHz in the 4750 10600 MHz Band.

These calculations use the transmitter power measured during the test programs and are worst case as they do not take into account the time average duty cycle correction factor used on the Tag device during normal operation.

The highest power level measured during testing is used in the following calculations;-
