How to Use




 $oxed{1}$ Press to enter the softphone dialing screen, answer or enter a softphone's call.

 $\widehat{\mathcal{D}}$ Press to enter the phone dialing screen, answer or end a phone's call.

(Teams Edition) Press to invoke the Teams client; Hold 2 seconds to activate Cortana. (UC Edition) Hold 2 seconds to activate voice assistant.

Before using the Teams button functions, you should install the Microsoft Teams client on your PC, smartphone or tablet.



4 Press to mute or unmute microphone.

(5) (7) Hold 2 seconds to activate Cortana; Press to turn up/down volume.

(6) Press to answer, reject, or end a call.

Troubleshooting
