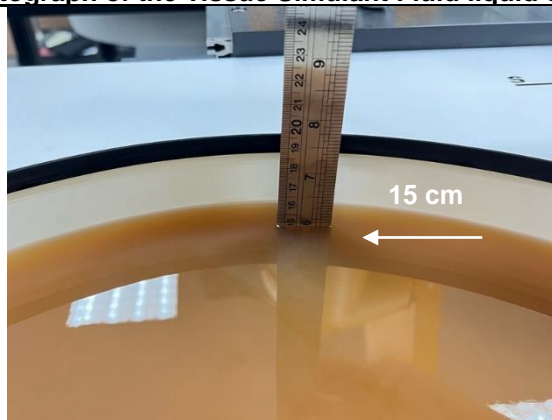

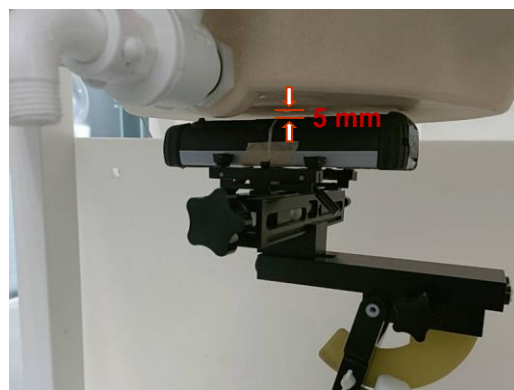

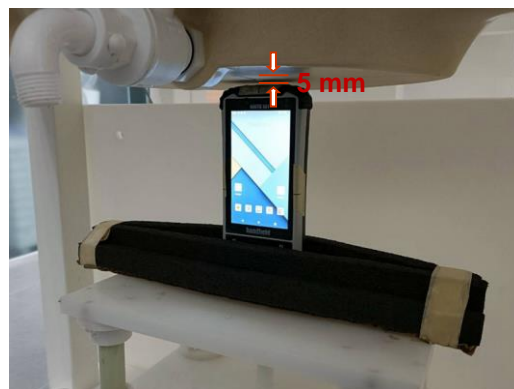
Photograph 3. Body, Back Surface, 5mm

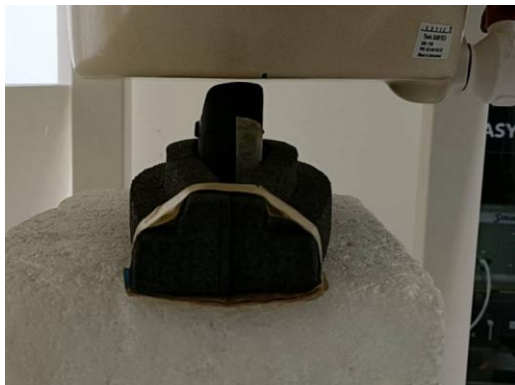

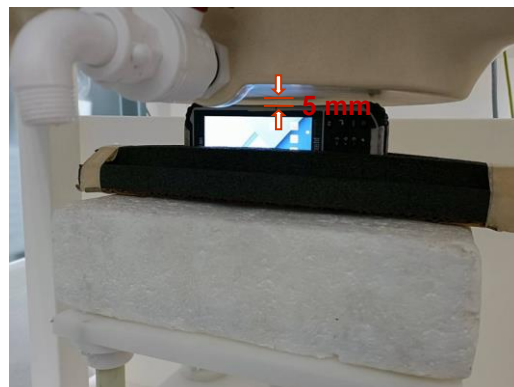

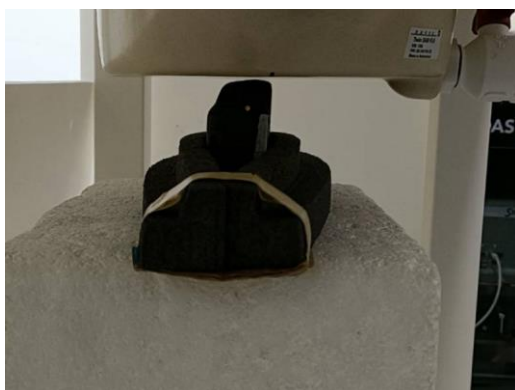

Photograph 7. Body, Right Edge, 5mm



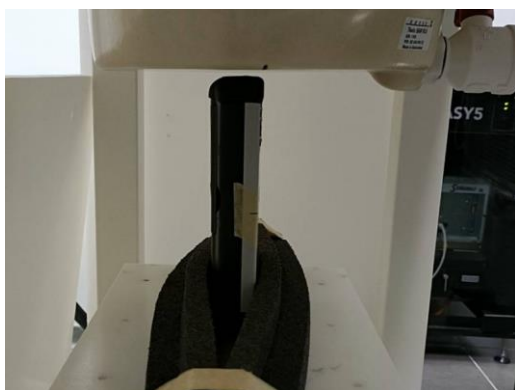
Photograph 8. Body, Right Edge, 5mm



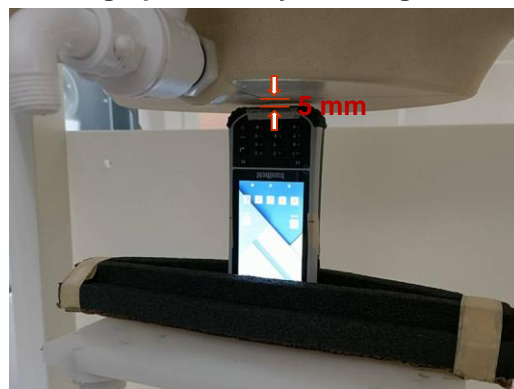
Photograph 9. Body, Left Edge, 5mm
