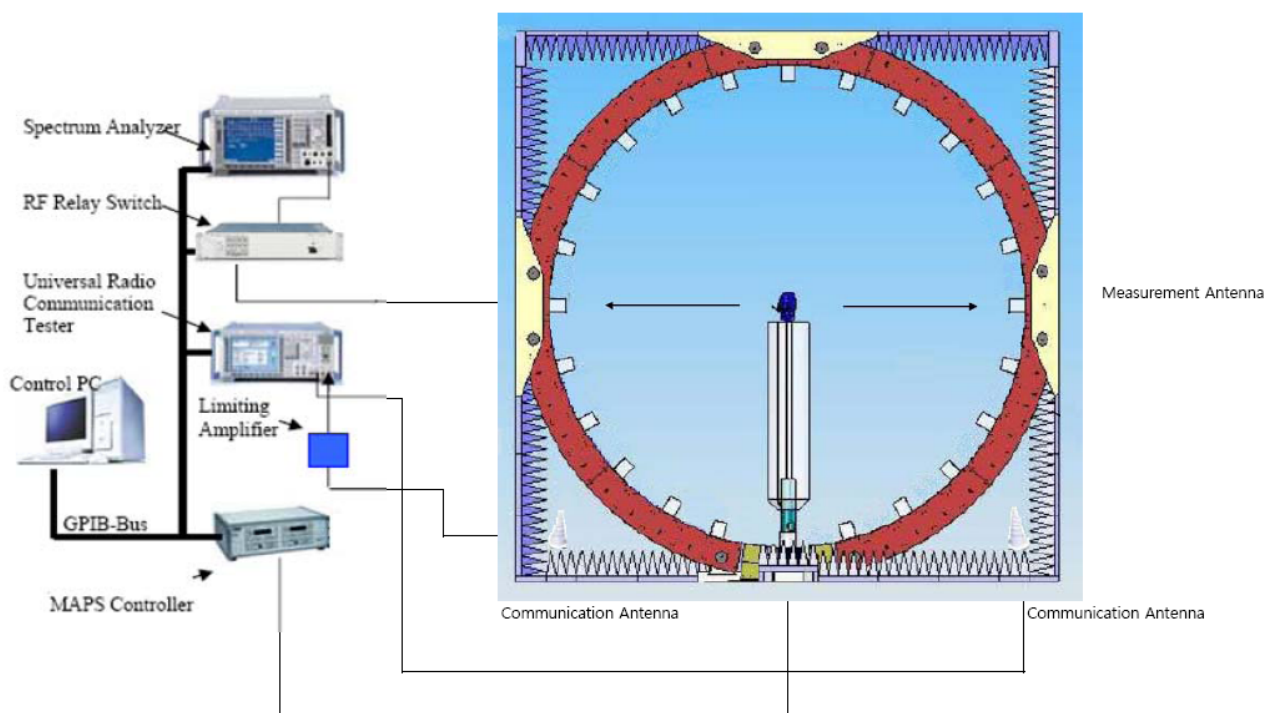

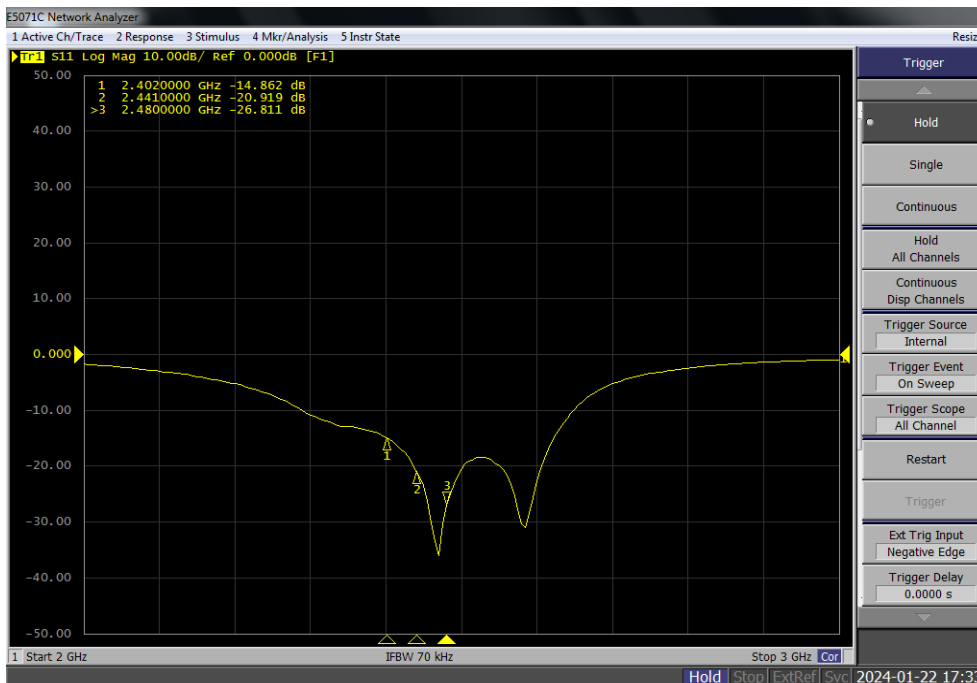

Free Space Right #1



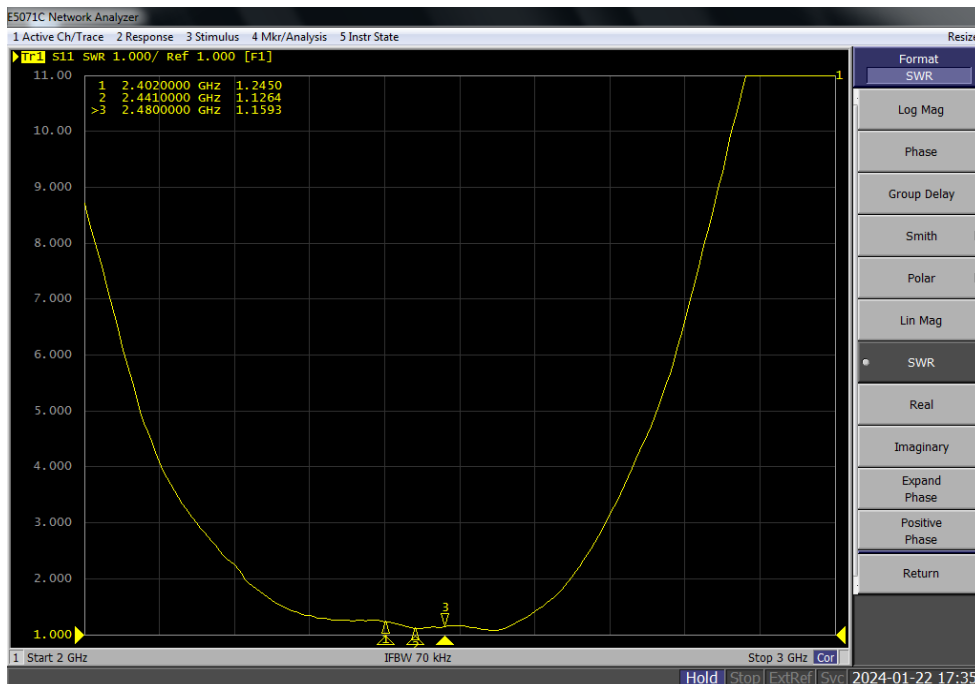

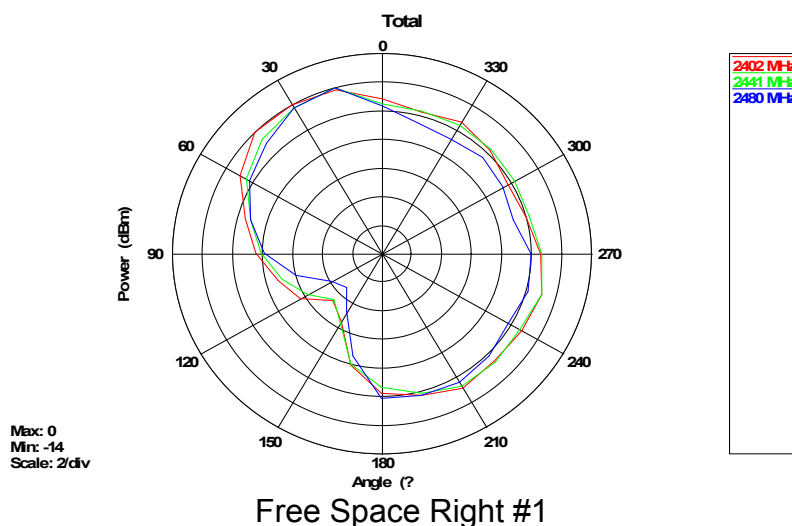
