

RC Monster Truck User Manual

Battery installation

For Monster Truck


Remove the screw and open the batteries cover.
Insert 3*AA Size batteries (1.5V) and close the batteries cover.
Put the screw back and lock the batteries cover.

For Remote Controller

Remove the screw and open the batteries cover.
Insert 2* AA Size batteries (1.5V) and close the batteries cover.
Put the screw back and lock the batteries cover.

Operation procedure

Put the Monster Truck on the floor and make sure the frequency docking successfully when the car and the controller are turned on.
Use the remote controller to control the Monster Truck and see below for the control method.



Notes:

Age recommendation: 10+ years and adult supervision required.
If you do not play the car, you must remove the batteries from both of the remote controller and the car.
