### 4. Test Results and Measurement Data

According to §1.1307(b), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

Remark: 1) **For BLE:** The maximum output power for antenna is 5.24dBm (3.34mW) at 2480MHz, 1.65dBi antenna gain(with 1.46 numeric antenna gain.)

**For WIFI:** The maximum output power for antenna is 12.62dBm(18.28mW) at 2437MHz, 1.65dBi antenna gain(with 1.46 numeric antenna gain.)


For SRD: The maximum output power for antenna is -27.54dBm (0.0018mW) at 433.92MHz, -1.74dBi antenna gain(with 0.67 numeric antenna gain.)

Note: E[dBµV/m]=72.39 computational formula

 $EIRP[dBm] = E[dB\mu V/m] + 20 log (d[m]) - 104.77;$ 

Conducted Power = EIRP-4.7;

Where E is the electric field strength in V/m; d is the measurement distance in meters (m)



#### Calculation

Given

$$E = \sqrt{\frac{30 \times P \times G}{d}} \quad \& \quad S = \frac{E^2}{3770}$$

Where E = Field Strength in Volts / meter

P = Power in Watts G=Numeric antenna gain

d=Distance in meters

S=Power Density in milliwatts / square centimeter

Substituting the MPE safe distance using d=20cm into above equation.
