Band41-20MHz-QPSK-39750-1RB#0-Range2:1000~27000MHz

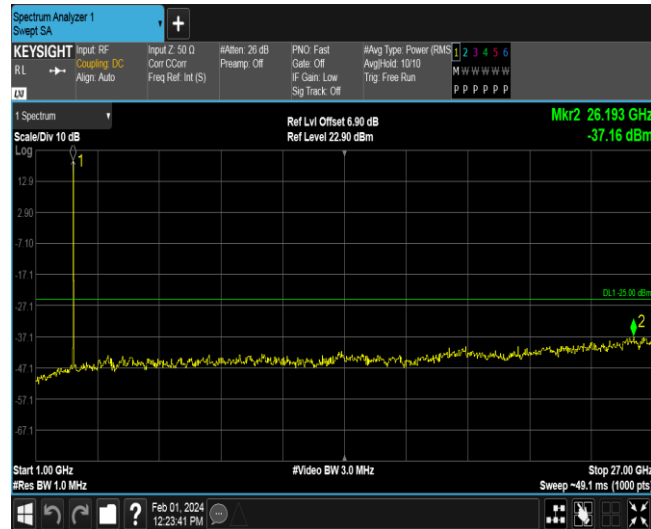

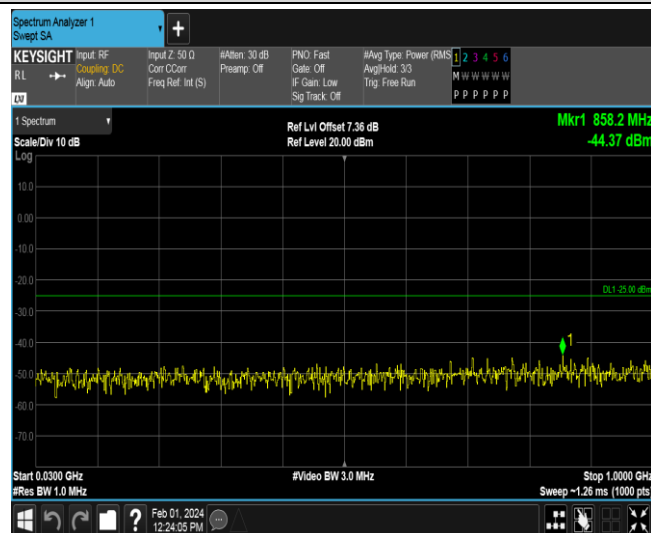
