Friis transmission formula: $P_d = (P_{out} * G) / (4 * \pi * R^2)$

Where

P_d = Power density in mW/cm^2

P_{out} =output power to antenna in mW

G = gain of antenna in linear scale

$\pi=3.1416$

R = distance between observation point and center of the radiator in cm

P_d the limit of MPE, 1mW/cm^2 . If we know the maximum gain of the antenna and total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.
