

**Note:** Music playback is paused during call functions and resumes when the calls ended.

## How to use:

### A. Charge:

- Connect the Type-C charging cable to the headphone and a USB source;
- 2. LED lights red when charging and turns off when fully charged.

### **B.** Pairing:

- 1. With the headphones turn on, enter pairing model, LED rapidly flashes blue and red.
- 2. On your device, turn on the Bluetooth function, and set it to search for Bluetooth devices.
- 3. Select (GM05 ANC) from the list of found devices.
- 4. When paired, the LED flashes blue slowly.

#### Note:

 During pairing, if the headphones are not connected to a device within 5 minutes, they automatically turn off. NOTE: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules.
