
Reason for request:

This information is a trade secret. VCom Inc. developed the BTR5857 product in response to commercial marketplace requirements. Its design and functional features are exclusive to VCom.

The BTR5857 product is offered in the highly competitive Multi-Point Distribution Service market. Technology in the field of wireless communications is evolving rapidly, and confidentiality of proprietary design information is essential to maintain competitiveness in this market. Disclosure of this information may allow competitors to benefit from VCom's intellectual property.

All employees of VCom Inc. are required to sign an Intellectual Property Agreement form upon becoming employed with VCom. This will identify the responsibility and rights of both VCom and the employee in regard to any interest or rights involved in the discoveries, inventions, improvements, etc. normally referred to as "Inventions" which are made by the employee during the course of his/her work.

All OEM Manufacturing partners, as well as any visitors to the plant, are required to sign non-disclosure agreements prior to being granted access to production and research/development areas. Electronic originals of proprietary documents are password protected and hard copies are controlled.

This information is not available to the public and there have been no disclosures to parties who are not employees of VCom with the exception of Nemko Canada Inc., who is acting on our behalf as an agent to FCC, and Industry Canada.

The period of time for required for nondisclosure for the BTR5857 product is for the life of the product (typically 20 years) and beyond, since features of the current design may be incorporated in future VCom products. This period should therefore be 20 years.

The BTR5857 product cannot be readily reverse-engineered without the schematics and parts lists. The BTR5857 incorporates proprietary software embedded in its circuits that is essential for its operation.

The BTR5857 is not sold directly to the general public nor is it viewable to the general public in normal application; it is sold only to known, approved customers after credit check. No units are sold to known or potential competitors where there may be a possibility of reverse engineering. The BTR5857 requires professional installation.
