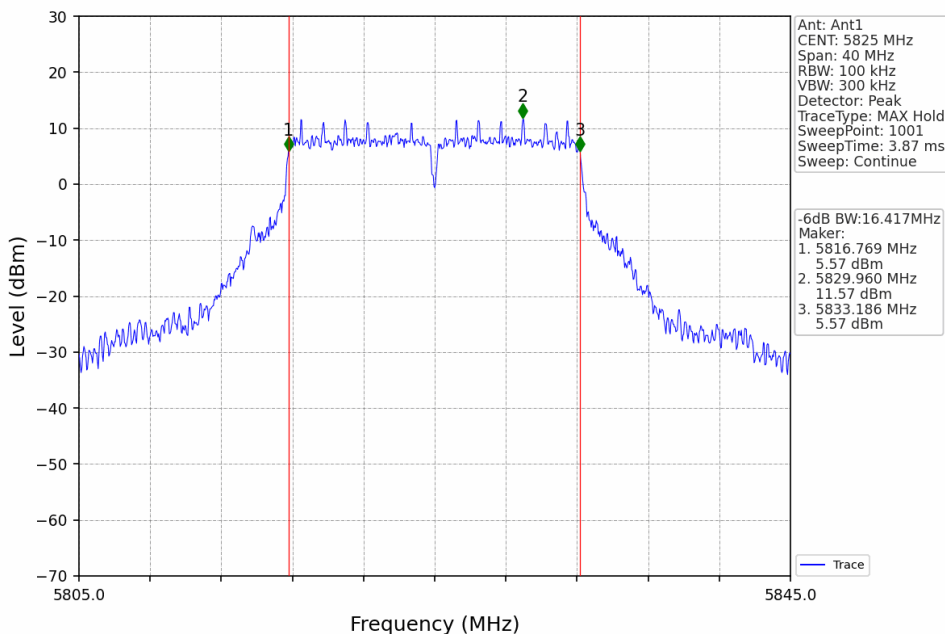
### 2.2.2 Test Graph



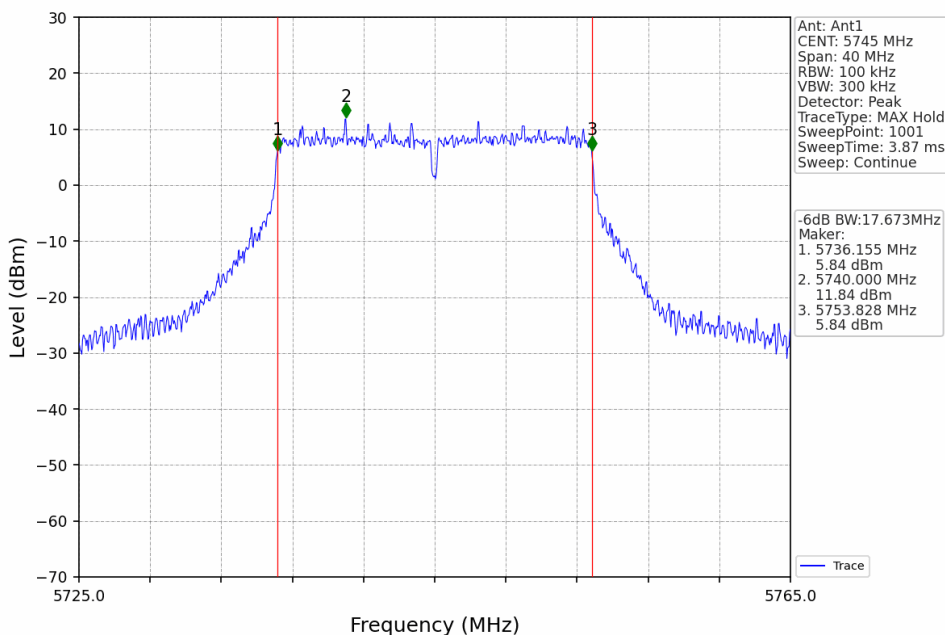
