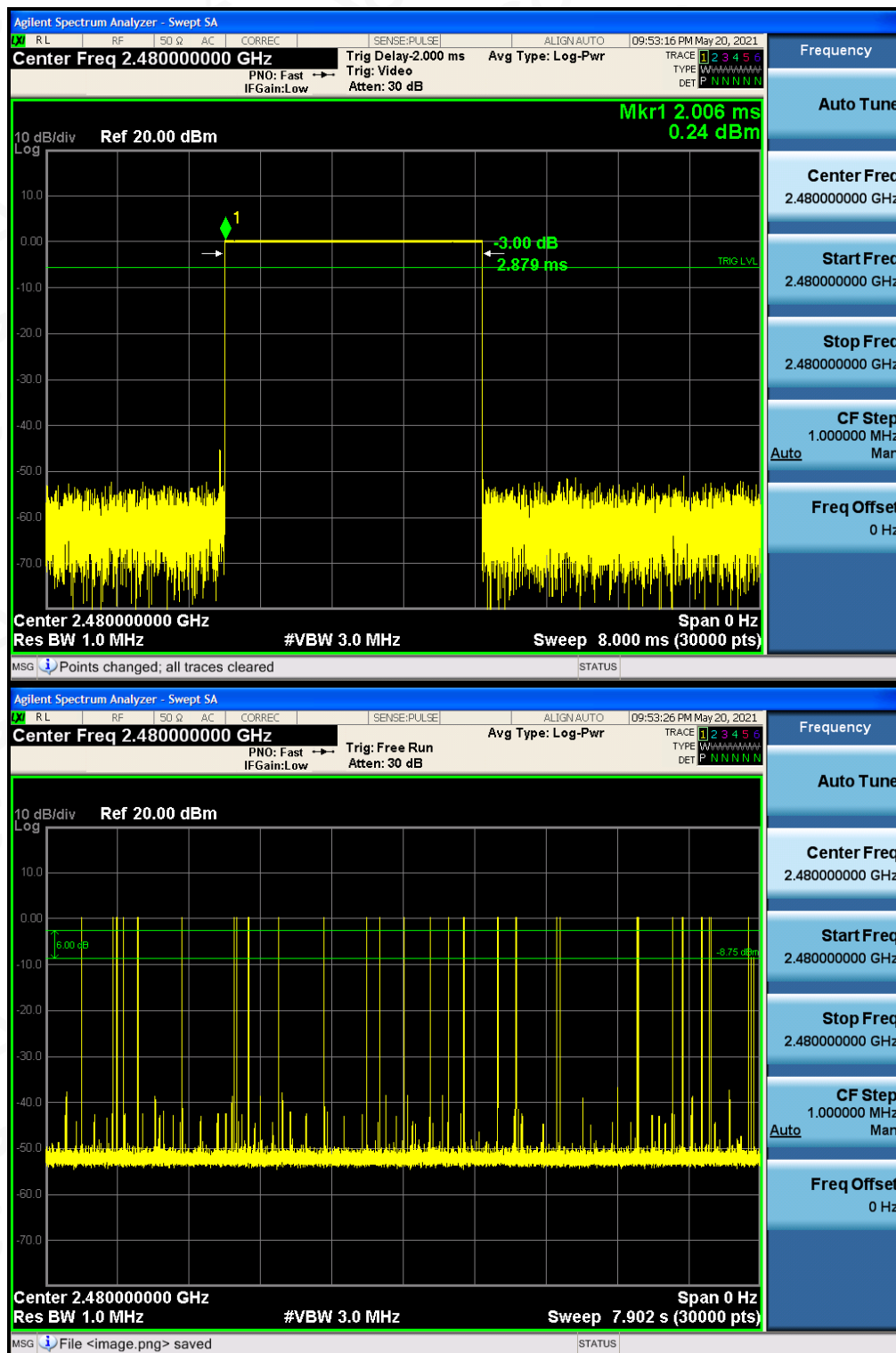

### 13. FREQUENCY SEPARATION

#### 13.1. MEASUREMENT PROCEDURE

The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:

1. Span: Wide enough to capture the peaks of two adjacent channels.
2. RBW: Start with the RBW set to approximately 30% of the channel spacing; adjust as necessary to best identify the center of each individual channel.
3. Video (or average) bandwidth (VBW)  $\geq$  RBW.
4. Sweep: Auto. e) Detector function: Peak. f) Trace: Max hold. g) Allow the trace to stabilize.

Use the marker-delta function to determine the separation between the peaks of the adjacent channels.

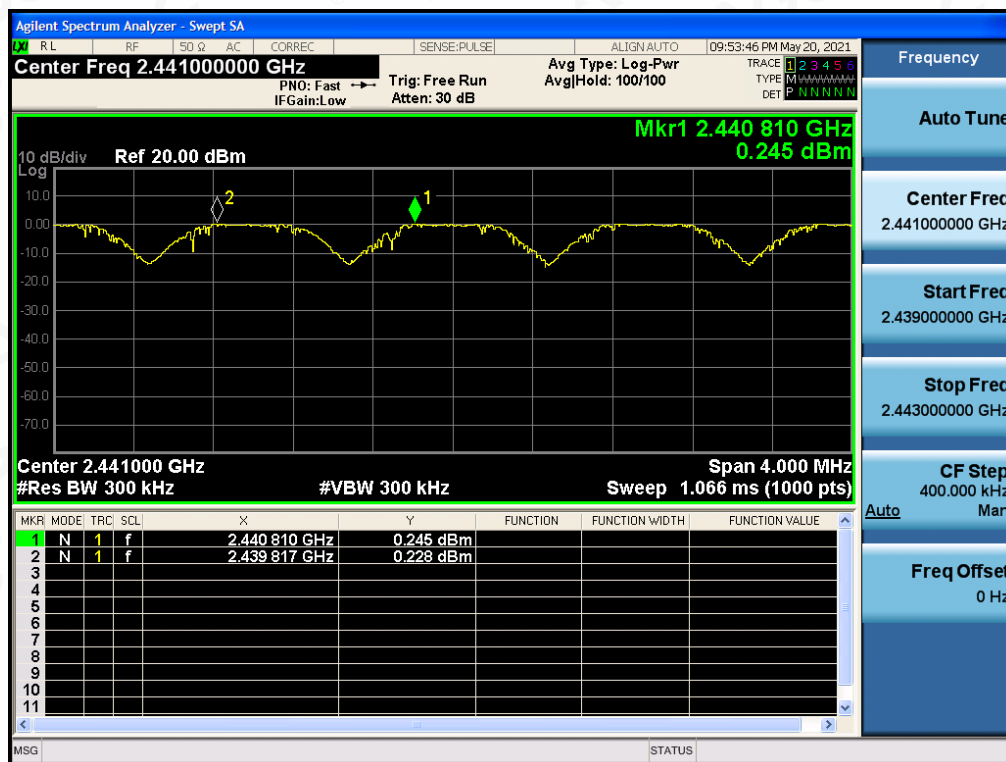

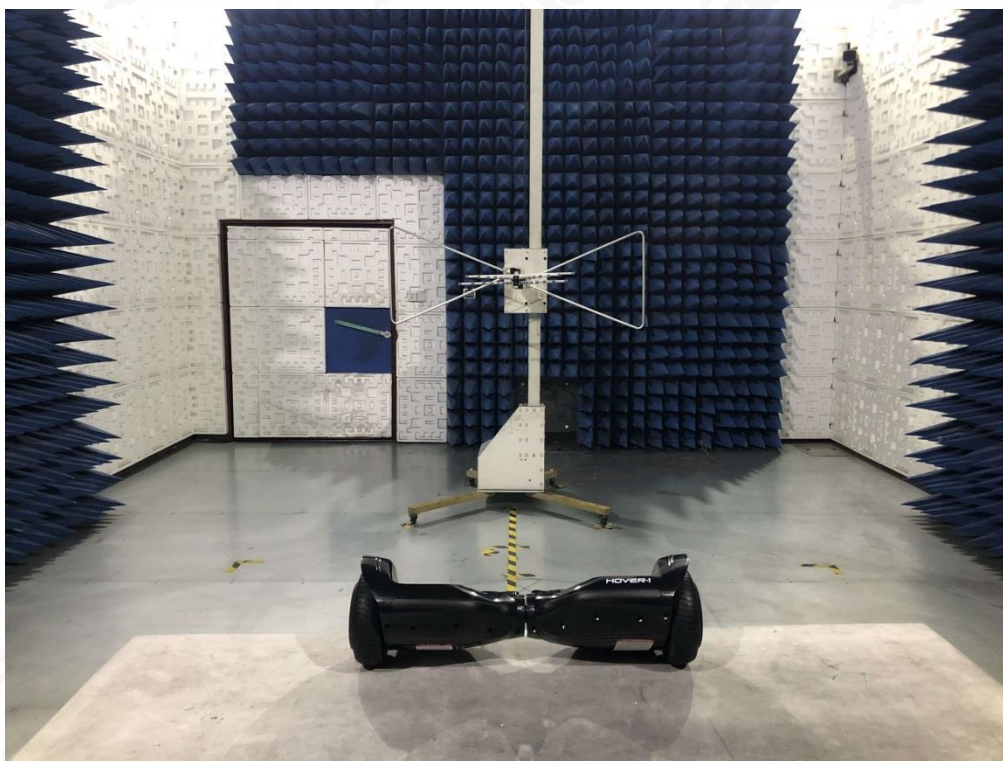

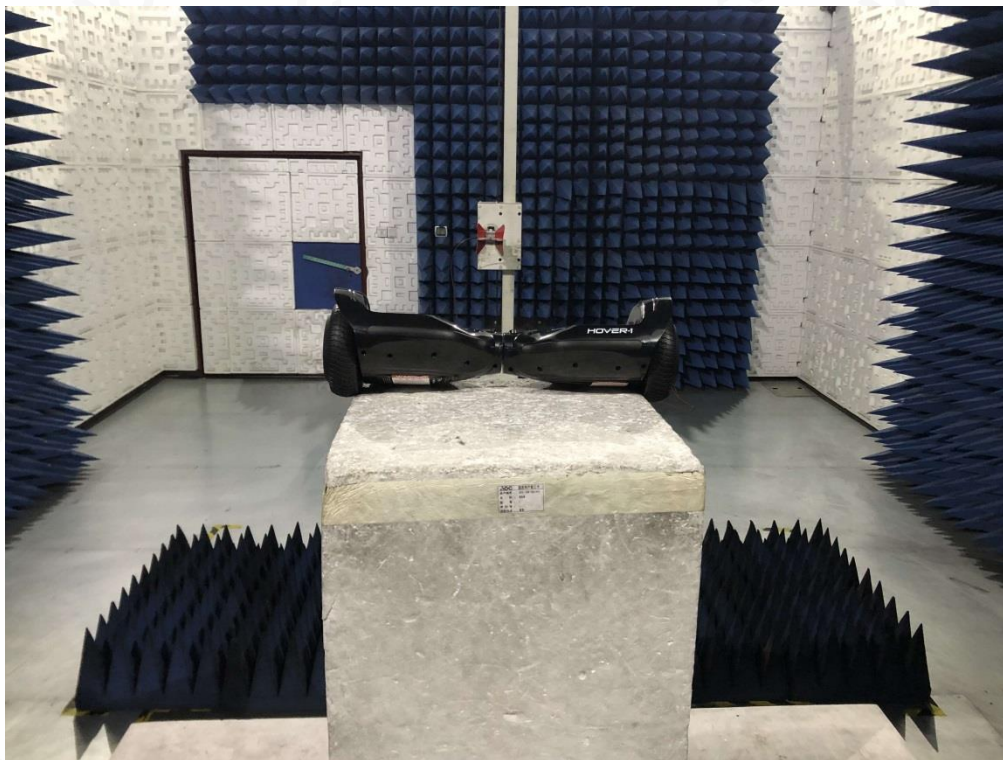

### RADIATED EMISSION TEST SETUP ABOVE 1GHz

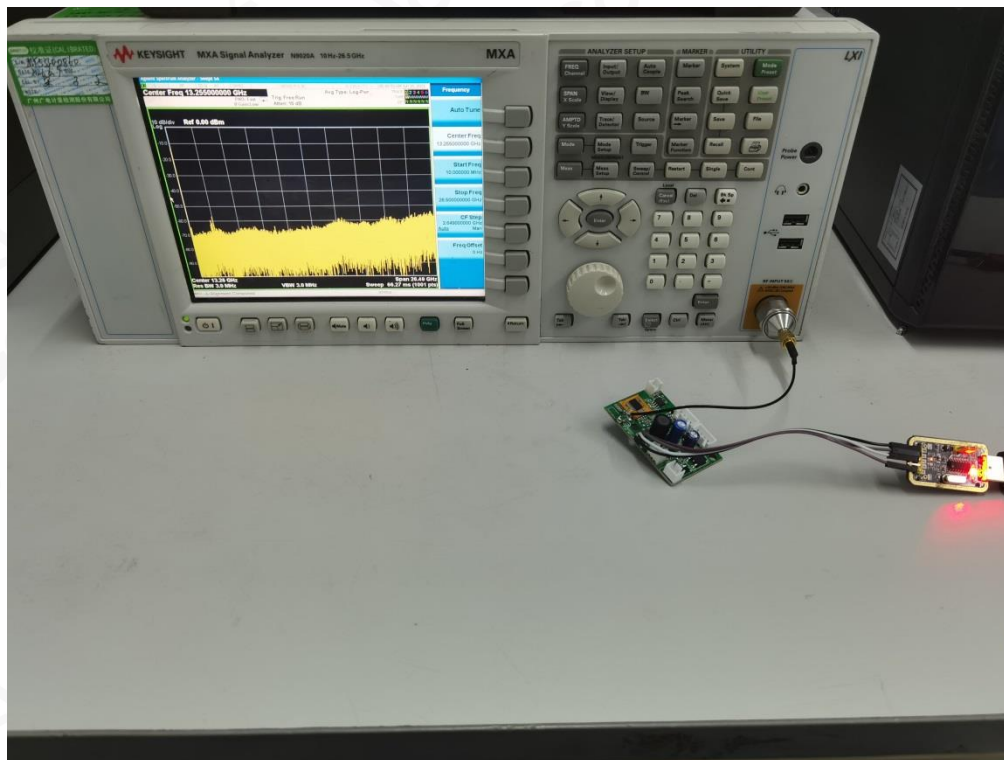

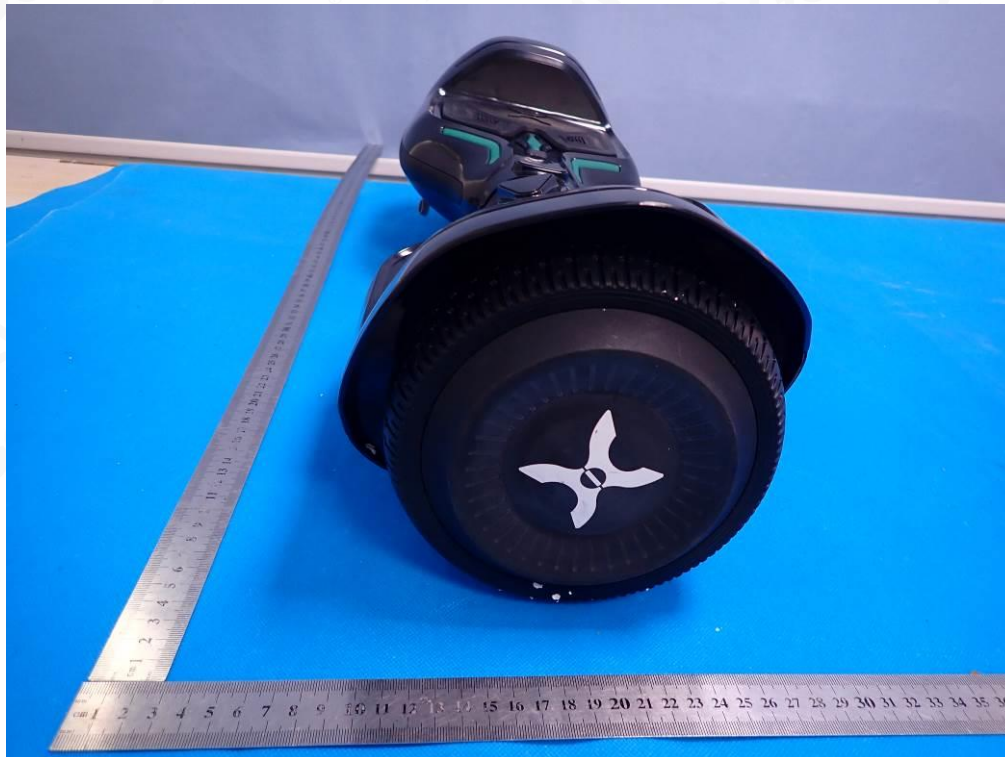

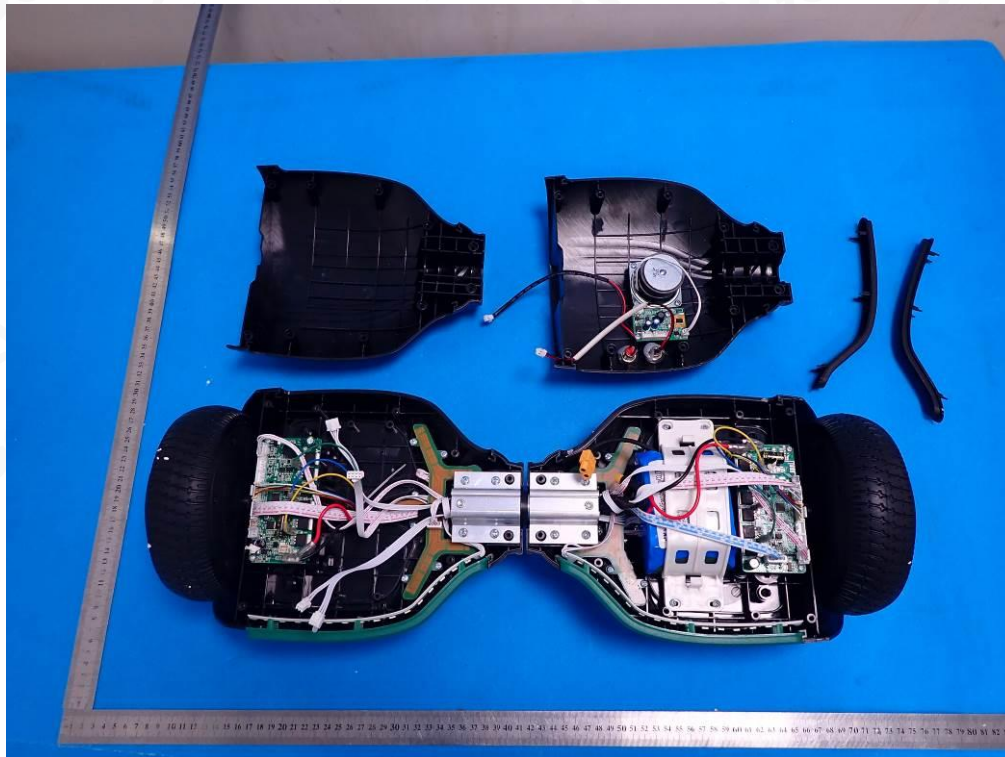




VIEW OF EUT(PORT)

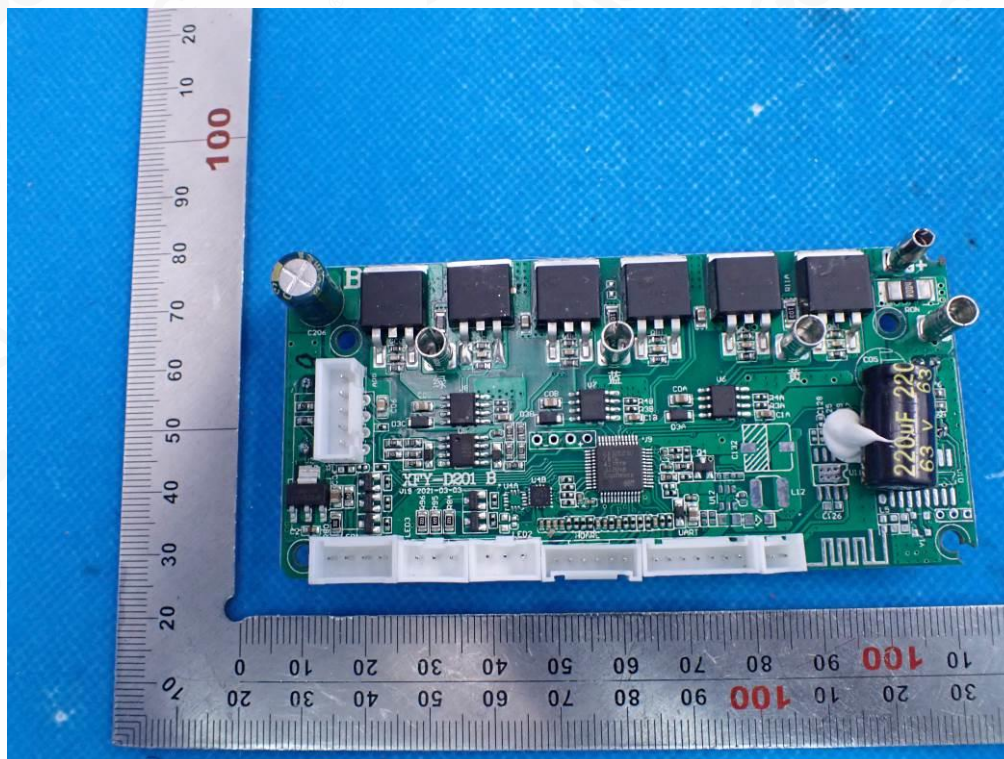

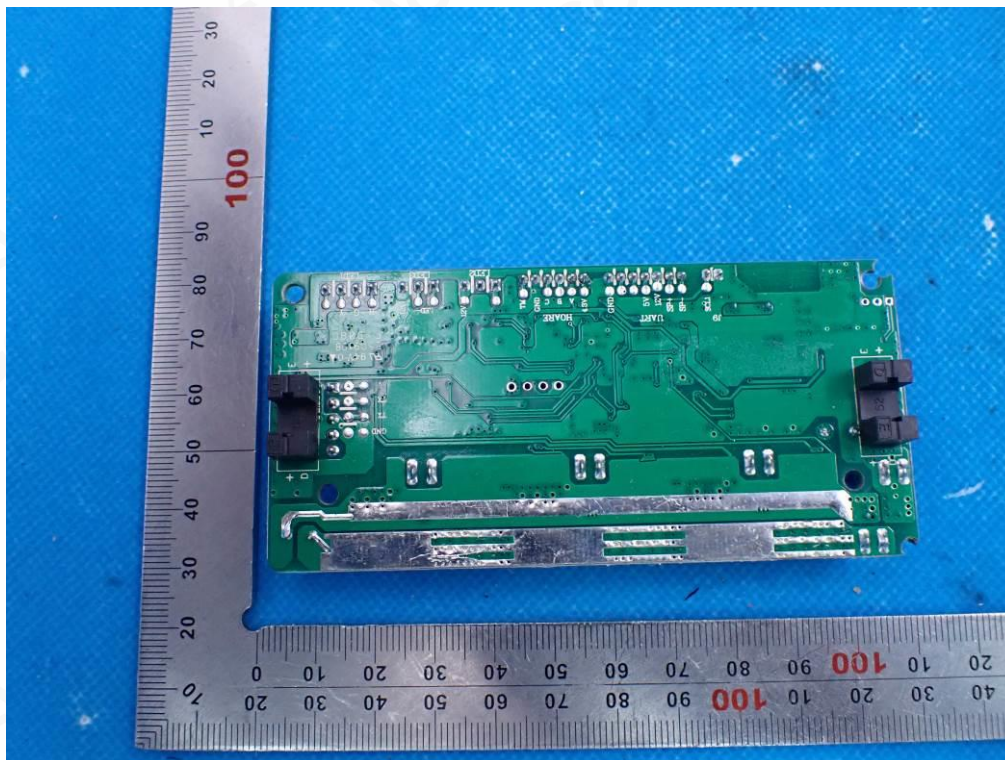

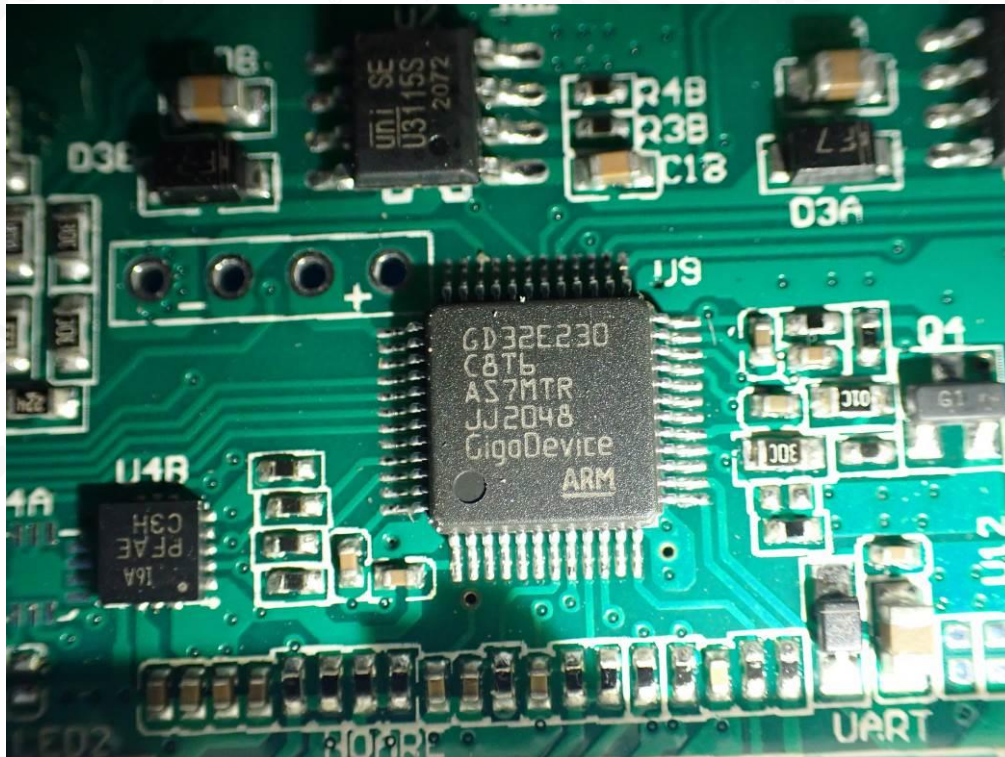




INTERNAL VIEW OF EUT-2

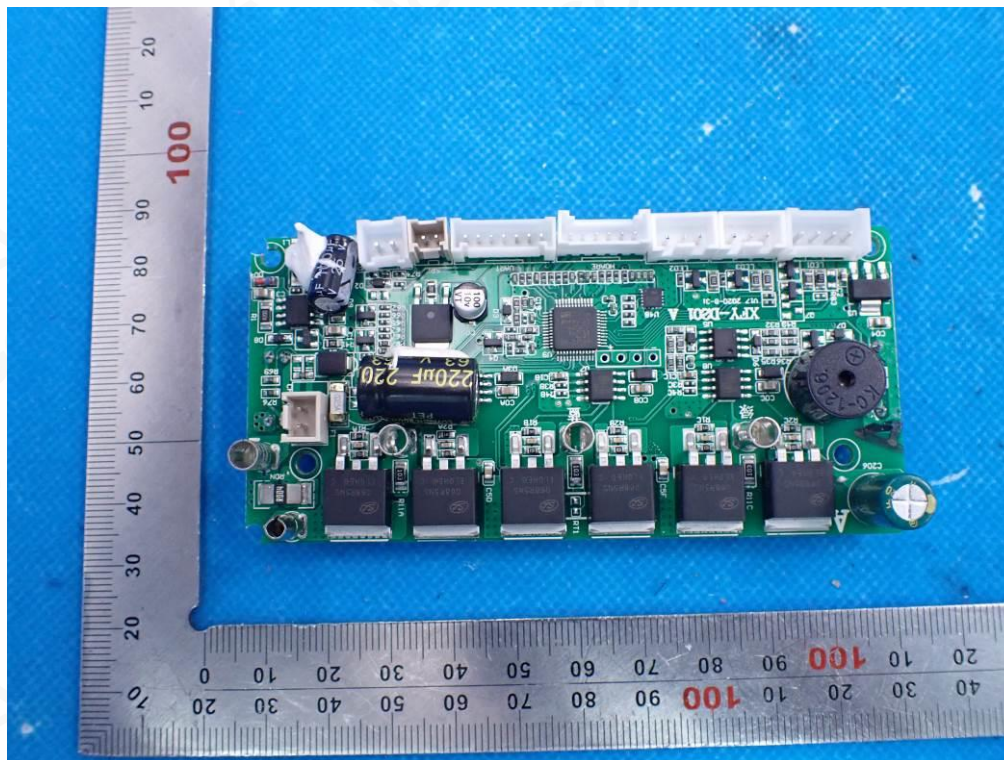

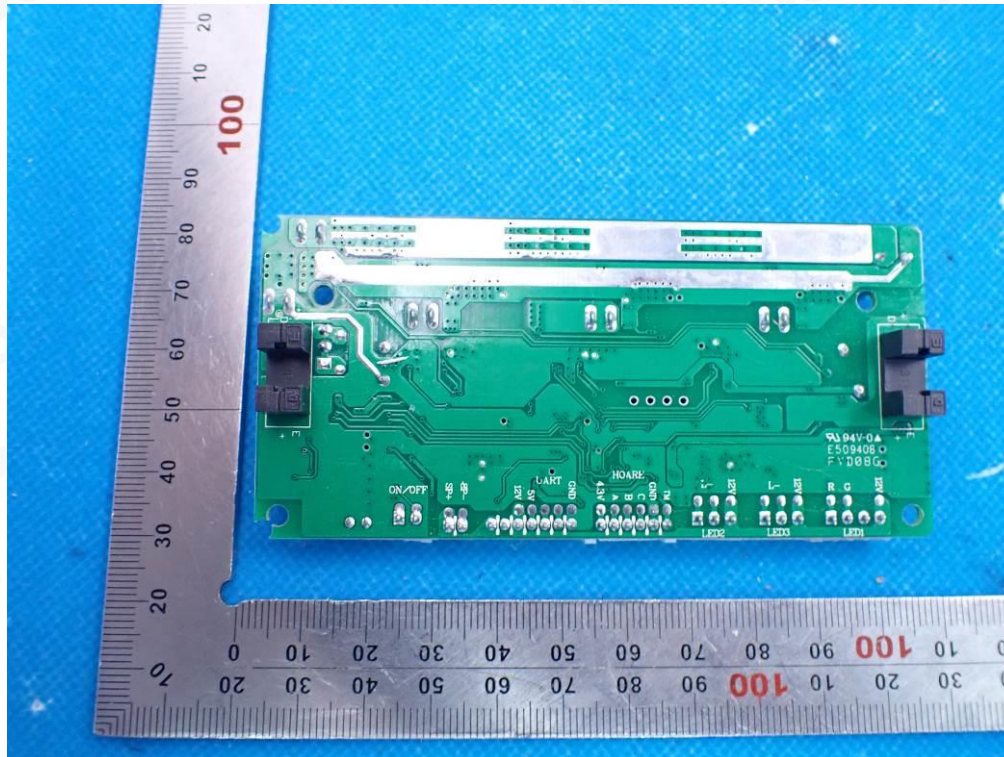




INTERNAL VIEW OF EUT-4

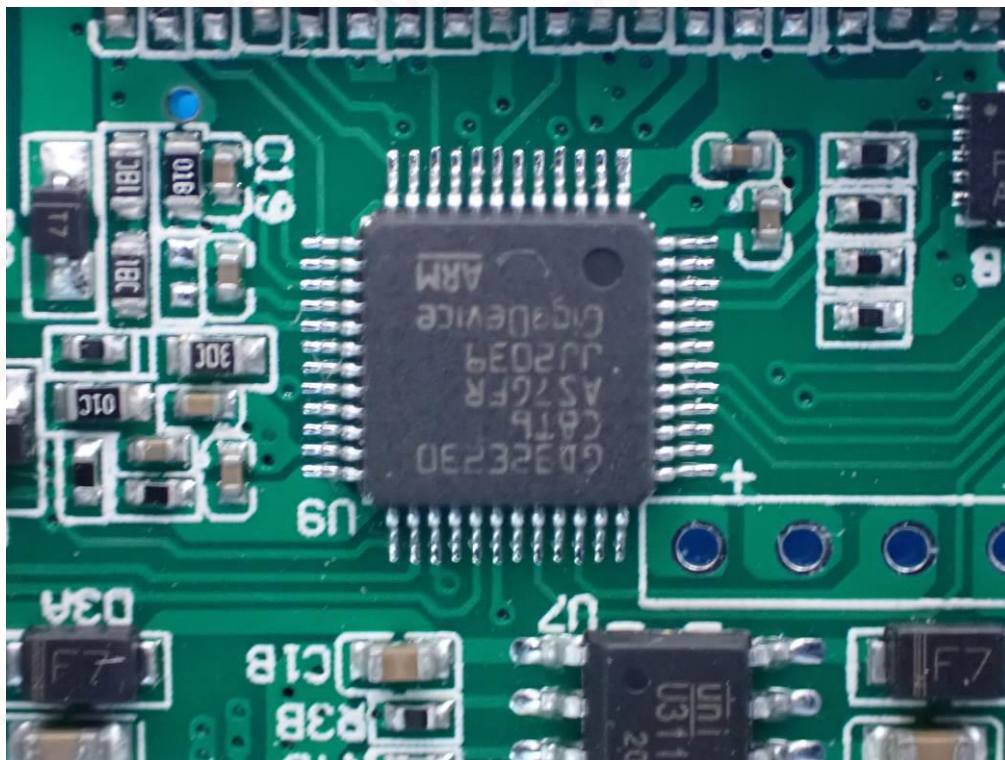

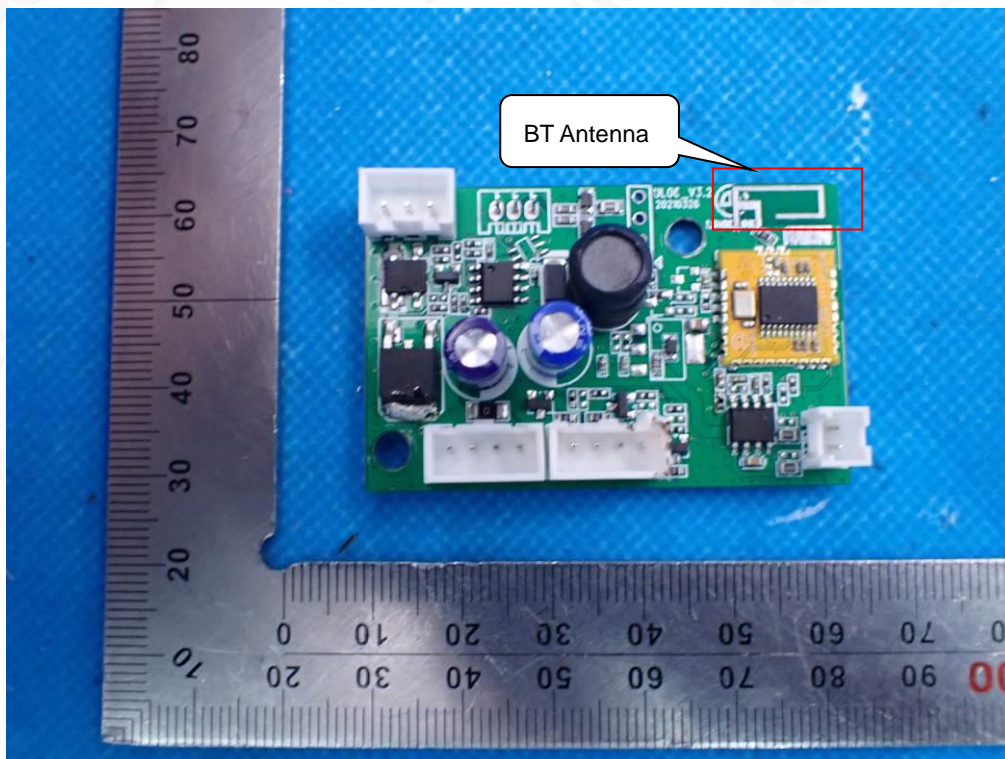




INTERNAL VIEW OF EUT-6



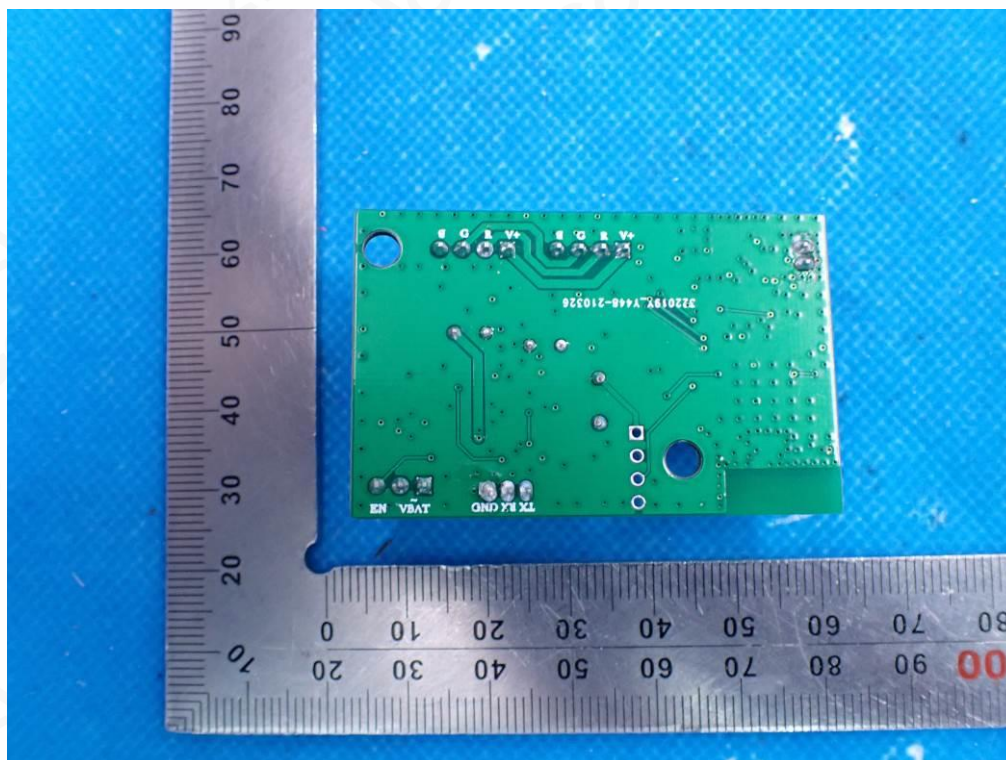

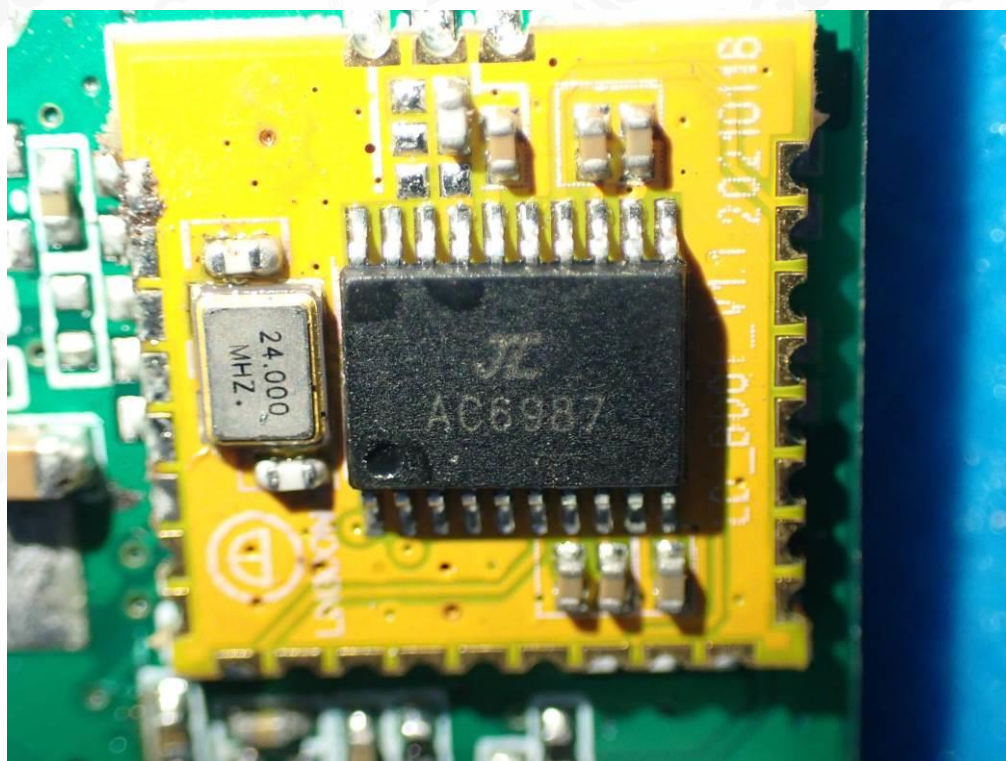

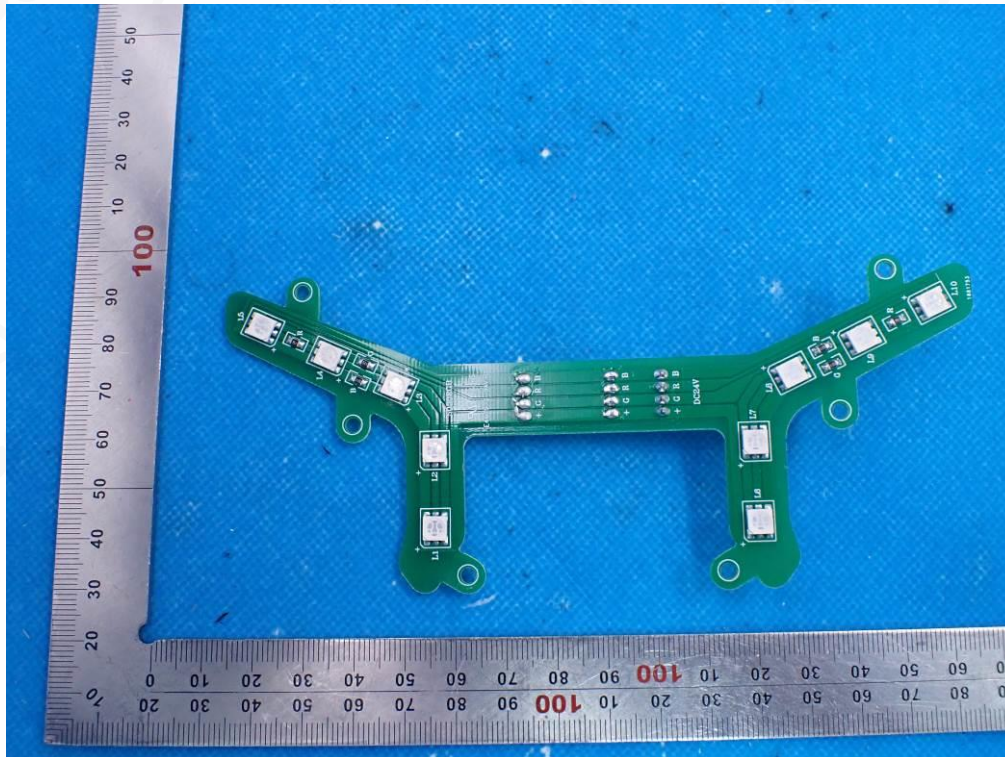




INTERNAL VIEW OF EUT-10

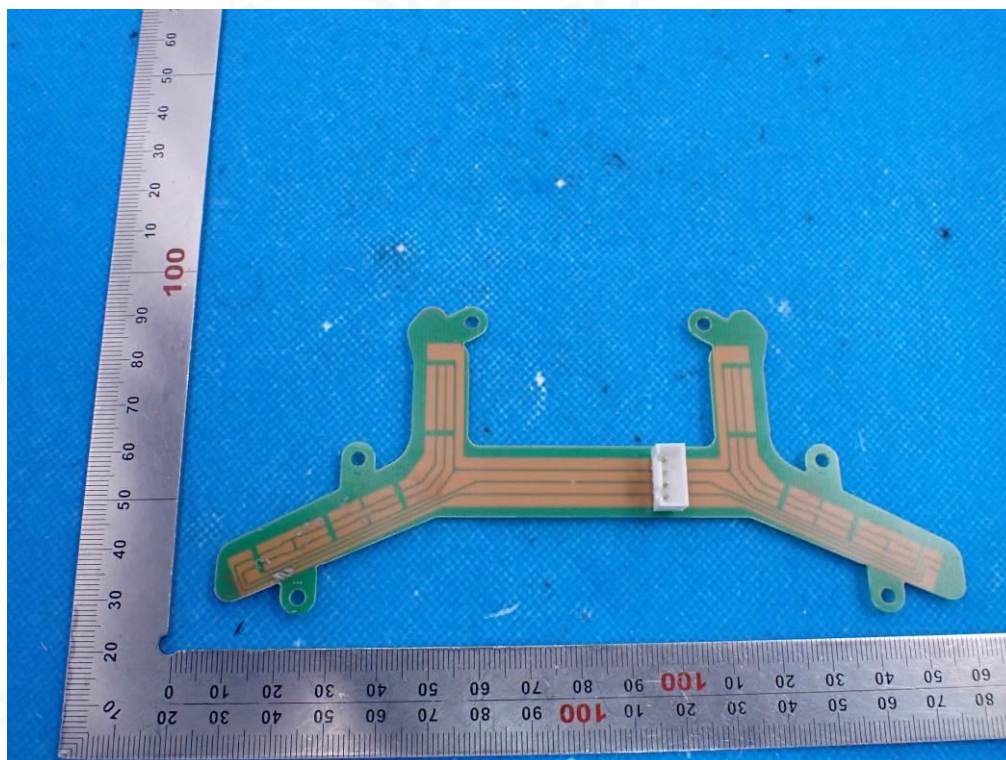

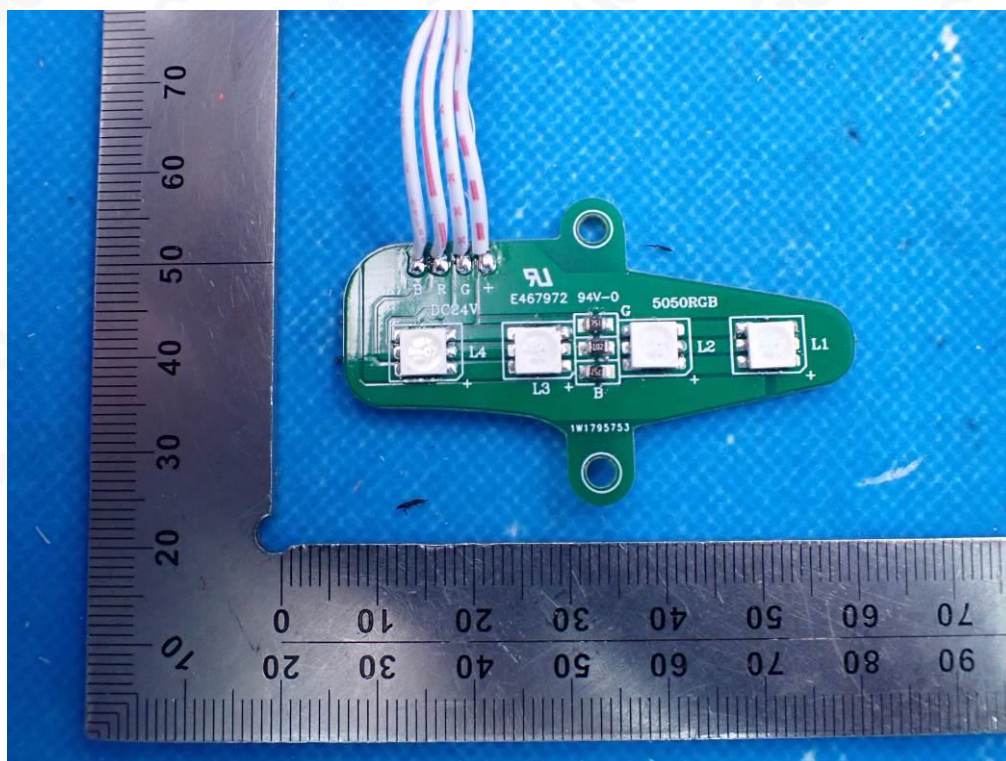




INTERNAL VIEW OF EUT-12

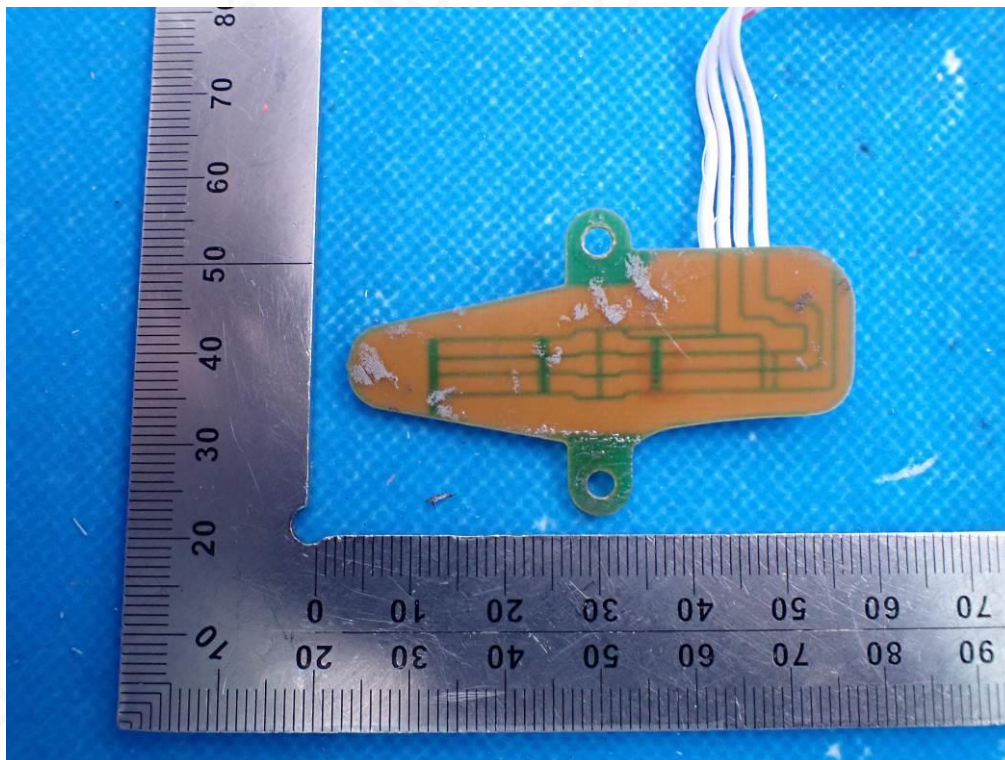

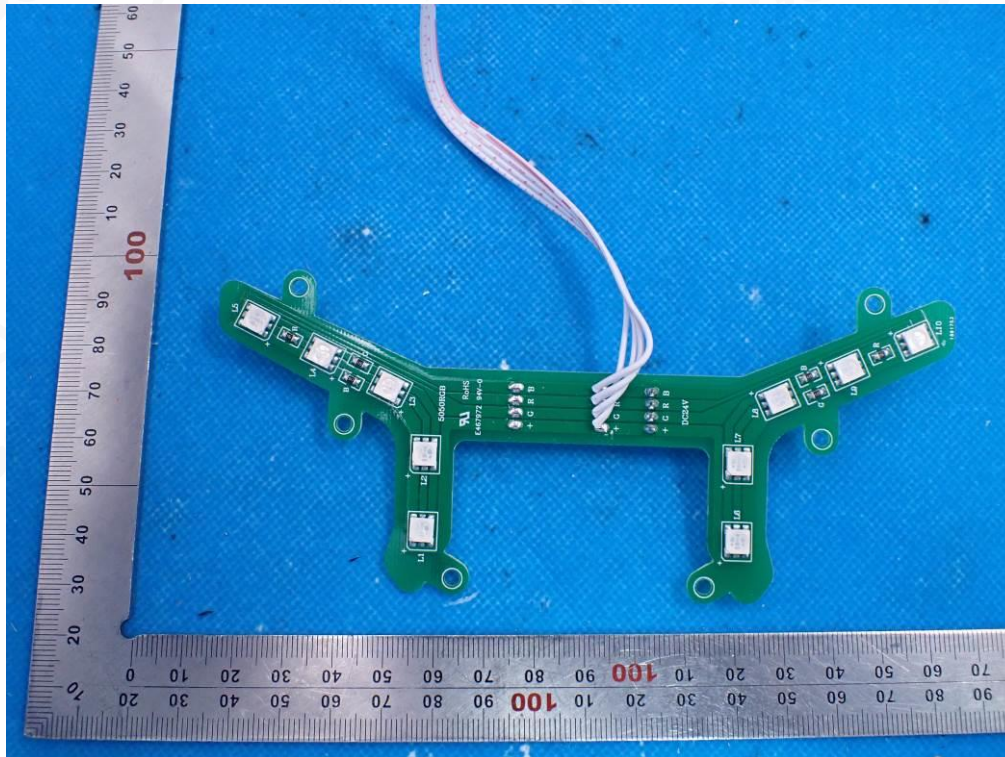
