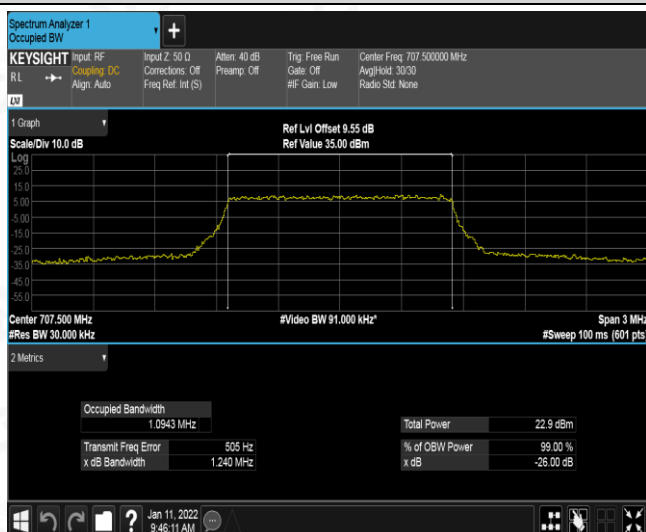

Band12-1.4MHz-QPSK-23095-6RB#0

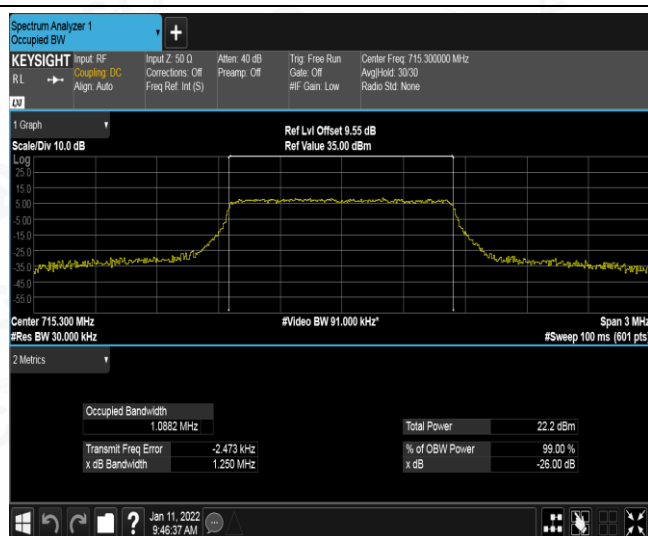

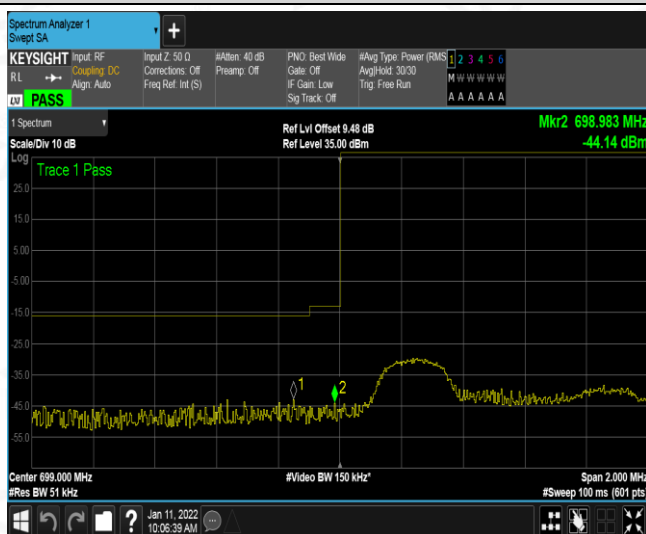




Band12-3MHz-QPSK-23025-1RB#0

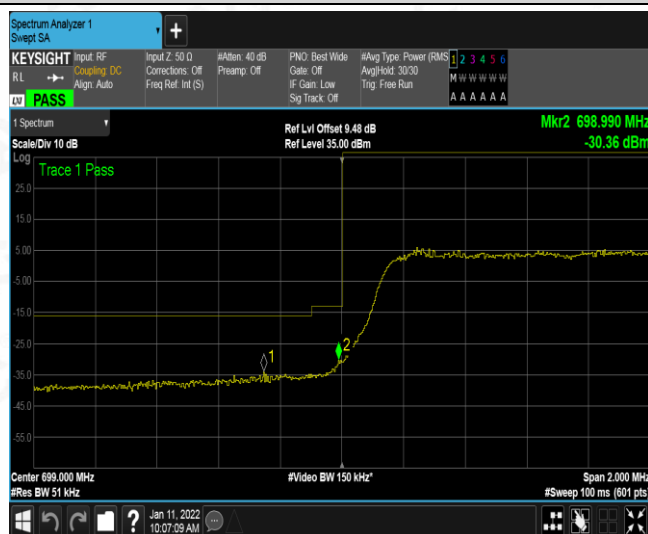
