



4 TEST CONDITIONS AND RESULTS

4.1 AC Power Conducted Emission

TEST CONFIGURATION



TEST PROCEDURE

1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2013.

2 Support equipment, if needed, was placed as per ANSI C63.10-2013

3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2013

4 The EUT received power from adapter, the adapter received AC120V/60Hz and AC 240V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.

5 All support equipments received AC power from a second LISN, if any.

6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT.The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.

7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.

8 During the above scans, the emissions were maximized by cable manipulation.




Remark:

1. All 802.11a/ 802.11ac(VHT20) /802.11ac(VHT40) / 802.11n (HT20) / 802.11n (HT40) modes have been tested at low, middle, and high channel, only the worst case 802.11n (HT20) low channel of U-NII 1 band was recorded.

2. Both 120 VAC, 50/60 Hz and 240 VAC, 50/60 Hz power supply have been tested, only the worst result of 120 VAC, 60 Hz was reported as below:

4.2 Radiated Emissions

<u>Limit</u>

The maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

(1) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

(2) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of −27 dBm/MHz.

(3) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of −27 dBm/MHz.

(4) For transmitters operating in the 5.725-5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge.






(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

Test Procedure

- 1. Below 1GHz measurement the EUT is placed on a turntable which is 0.8m above ground plane, and above 1GHz measurement EUT was placed on a low permittivity and low loss tangent turn table which is 1.5m above ground plane.
- Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0° to 360° to acquire the highest emissions from EUT
- 3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.
- 5. Radiated emission test frequency band from 9KHz to 40GHz.



All 802.11a/ 802.11ac(VHT20) /802.11ac(VHT40)/ 802.11n (HT20) / 802.11n (HT40) modes have been tested for below 1GHz test, only the worst case 802.11n (HT20) low channel of U-NII 1 band was recorded. 2.All 802.11a/ 802.11ac(VHT20) /802.11ac(VHT40) / 802.11n (HT20) / 802.11n (HT40) modes have been tested for above 1GHz test, only the worst case 802.11n (HT20) was recorded.



4.3 Maximum Conducted Average Output Power

<u>Limit</u>

For the band 5.15-5.25 GHz.

(i) For an outdoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi.

(ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi.

(iii) For fixed point-to-point access points operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W.

(iv) For client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi.


For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or 11 dBm + 10 log B, where B is the 26 dB emission bandwidth in megahertz.

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W

Test Procedure

Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the power sensor.

4.4 Power Spectral Density

<u>Limit</u>

(1) For the band 5.15 - 5.25 GHz.

(i) For an outdoor access point operating in the band 5.15 - 5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 MHz band.^{note1}

(ii) For an indoor access point operating in the band 5.15 - 5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 MHz band.^{note1}

(iii) For fixed point-to-point access points operating in the band 5.15 - 5.25 GHz, transmitters that employ a directional antenna gain greater than 23 dBi, a 1 dB reduction in maximum power spectral density is required for each 1 dB of antenna gain in excess of 23 dBi.

(iv) For mobile and portable client devices in the 5.15 - 5.25 GHz band, the maximum power spectral density shall not exceed 11 dBm in any 1 MHz band. ^{note1}

(2) For the 5.25 - 5.35 GHz and 5.47 - 5.725 GHz bands, the peak power spectral density shall not exceed 11 dBm in any 1 MHz band. ^{note1}

(3) For the band 5.725 - 5.85 GHz, the maximum power spectral density shall not exceed 30 dBm in any 500 kHz band. ^{note1, note2}

Note1: If transmitting antennas of directional gain greater than 6 dBi are used, the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. Note2: Fixed point - to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information.

Test Procedure

- 1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
- 2. Set the RBW = 1MHz for U-NII 1, U-NII 2A, U-NII C band and 300KHz for U-NII 3 band.
- 3. Set the VBW \geq 3× RBW.
- 4. Set the span to encompass the entire EBW.
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum power level.
