




1. INTRODUCTION

1.1. Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada and Certification and Engineering Bureau.

1.2. MRT Test Location

Array Gain = 10 log (N_{ANT}/N_{SS}) dB;

• For power measurements on IEEE 802.11 devices,

Array Gain = 0 dB for $N_{ANT} \le 4$;

- 2. The EUT also supports Beam Forming mode, and the Beam Forming support 802.11ac/ax, not include 802.11a/b/g/n. BF Directional gain = G_{ANT} + 10 log (N_{ANT}).

Calculation Formula: $Pd = (Pout*G)/(4*pi*r^2)$

Where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

r = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.



CONCLUSION:

WLAN 2.4GHz Band and WLAN 5GHz can transmit simultaneously.

The max Power Density at R $(23.0 \text{ cm}) = 0.4049 \text{mW/cm}^2 + 0.5133 \text{mW/cm}^2 = 0.9181 \text{mW/cm}^2 < 1 \text{mW/cm}^2$.


