Pairing:

- 1. Remove the battery box cover on the back of the mouse.
- 2. Insert two (2) 1.5V AAA Alkaline batteries (not Included) into the battery box pointed in the correct direction. The correct poles are indicated there. Put the battery cover back in place so that is securely closed.
- Switch your computer on and connect the USB receiver to a free port on your PC.
- 4. Make sure that the mouse comes close to the USB receiver and integrates it into ths setting.
- 5. The LED starts to blink in order to show that the receiver is ready to synchronize the mouse automatically.
- 6. The status LED on the wheel of the mouse lights continuously after the synchronization process has been completed. The mouse is now ready for use.
