7.1 Antenna requirement

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.




7.3 Conducted Peak Output Power






7.4 Channel Bandwidth & 99% Occupy Bandwidth







Test Procedure:

- 1. The EUT was placed on the top of a rotating table (0.8m for below 1G and 1.5m for above 1G) above the ground at a 3 meter camber. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.








Lowest Polarziation: Vertical




Test channel: Middle Polarziation: Horizontal






Test channel: Middle Polarziation: Vertical








Test channel: Middle Polarziation: Horizontal








Test channel: Lowest Polarziation: Vertical






Test channel: Highest Polarziation: Horizontal







