2.6 TRANSMIT POWER CONTROL (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an EIRP of less than 500 mW.

Maximum EIRP of this device is 329.721mW which less than 500mW, therefore it's not require TPC function.

2.7 STATEMENT OF MANUFACTURER

This device (Client) is without radar detection, then the manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. **And the device doesn't have Ad Hoc mode on DFS frequency band.**

3. U-NII DFS RULE REQUIREMENTS

3.1 WORKING MODES AND REQUIRED TEST ITEMS

The manufacturer shall state whether the UUT is capable of operating as a Master and/or a Client. If the UUT is capable of operating in more than one operating mode then each operating mode shall be tested separately. See tables 6 and 7 for the applicability of DFS requirements for each of the operational modes.

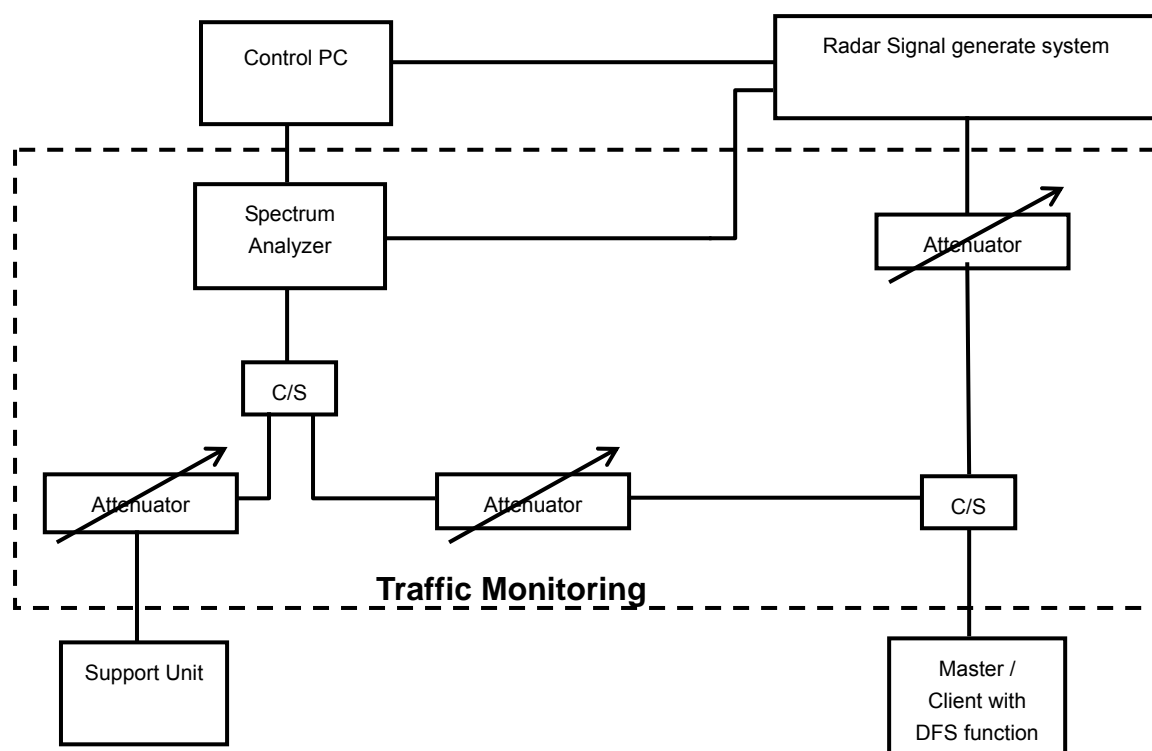

5. TEST PROCEDURE

5.1 DFS MEASUREMENT SYSTEM:

A complete DFS Measurement System consists of Radar signal generate system to generating the radar waveforms in Table 10, 11 and 12. The traffic monitoring system is specified to the type of unit under test (UUT).

Channel Loading

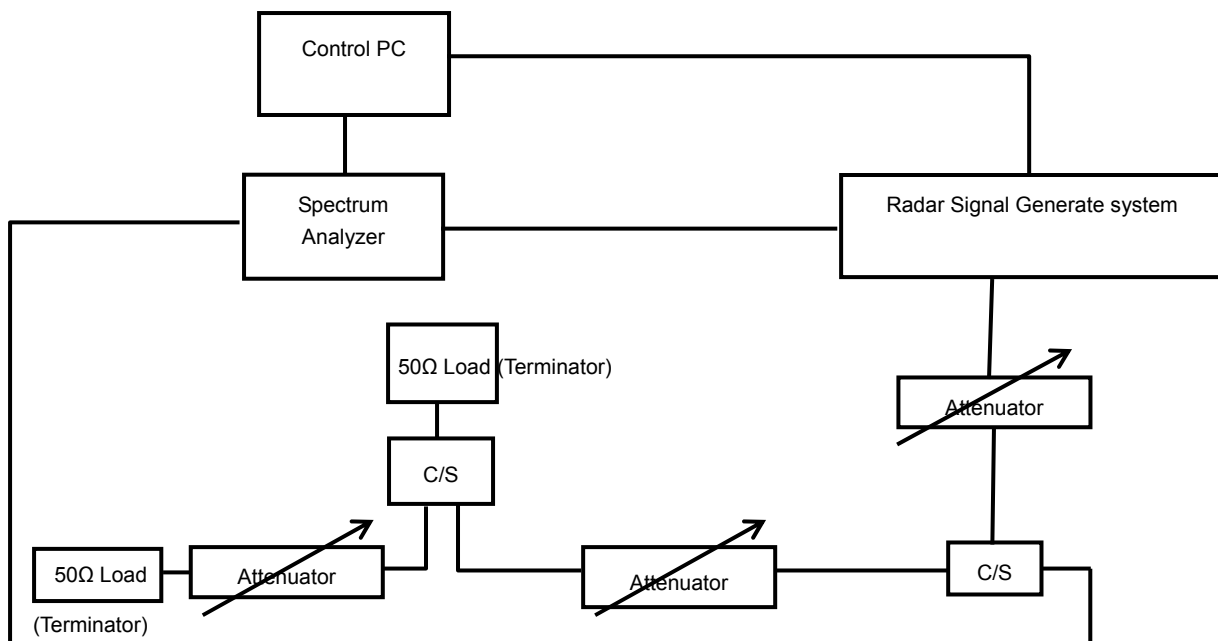
System testing will be performed with channel-loading using means appropriate to the data types that are used by the unlicensed device. The following requirements apply:

a)	The data file must be of a type that is typical for the device (i.e., MPEG-2, MPEG-4, WAV, MP3, MP4, AVI, etc.) and must generally be transmitting in a streaming mode.	
b)	Software to ping the client is permitted to simulate data transfer but must have random ping intervals.	
c)	Timing plots are required with calculations demonstrating a minimum channel loading of approximately 17% or greater.	✓
d)	Unicast or Multicast protocols are preferable but other protocols may be used. The appropriate protocol used must be described in the test procedures.	

5.2 CALIBRATION OF DFS DETECTION THRESHOLD LEVEL:

The measured channel is 5500 MHz in 20MHz Bandwidth, 5510MHz in 40MHz Bandwidth. The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The Master antenna gain is 3.428dBi and required detection threshold is -59.572dBm ($= -64 + 1 + 3.428$). The calibrated conducted detection threshold level is set to -59.572 dBm.

CONDUCTED SETUP CONFIGURATION OF CALIBRATION OF DFS DETECTION THRESHOLD LEVEL

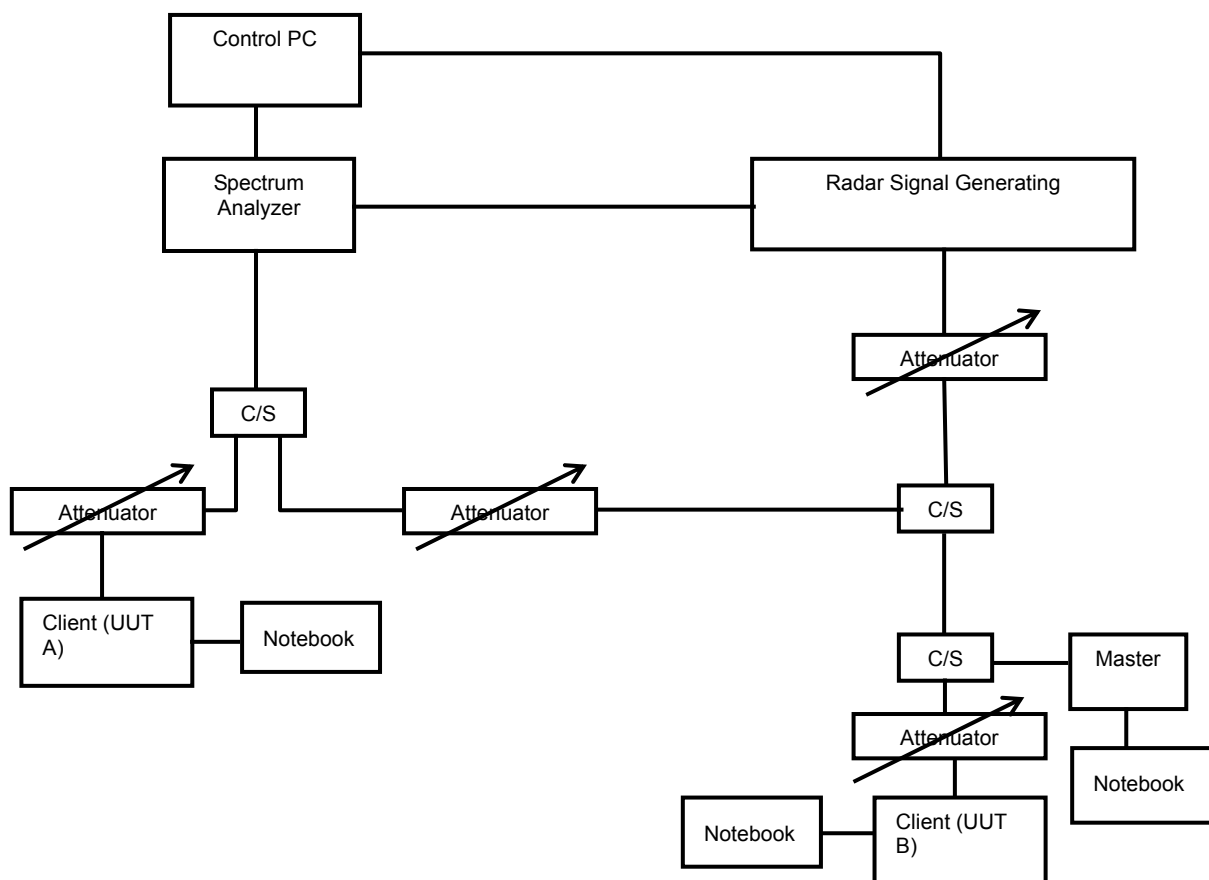

5.4 CONDUCTED TEST SETUP CONFIGURATION

5.4.1 CLIENT WITHOUT RADAR DETECTION MODE (TDLS MODE)



The UUT is a U-NII Device operating in Client mode without radar detection. The radar test signals are injected into the Master Device.

UUT operation mode in DFS testing:

1. AP sends control signal to UUT A&B to enable UUT A&B under transmission condition continuously at same channel.
2. Send command to UUT A in TDLS mode. Set UUT A&B under transmission condition continuously in TDLS mode.
3. UUT A sends message (MPEG files) to UUT B.
4. The radar test signals are injected into AP, so the AP disconnects transmission condition after the test. And then UUT A&B both disconnect transmission condition at the same time.

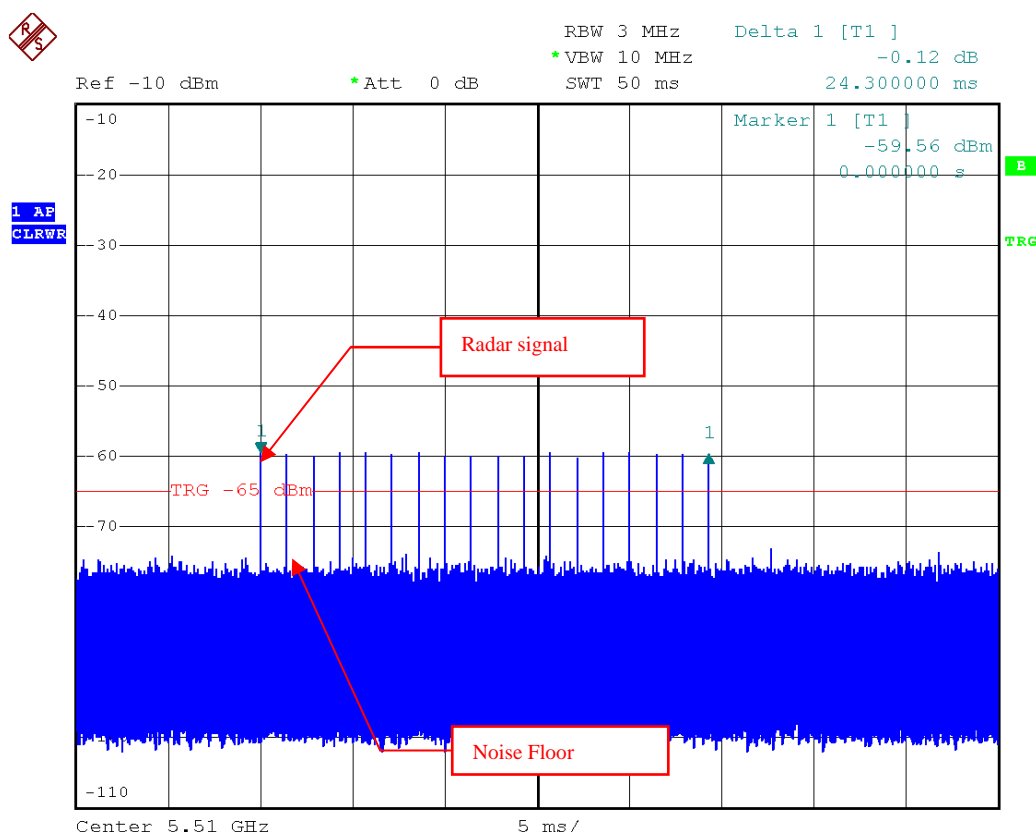
The radar test signals are injected into the Master Device.

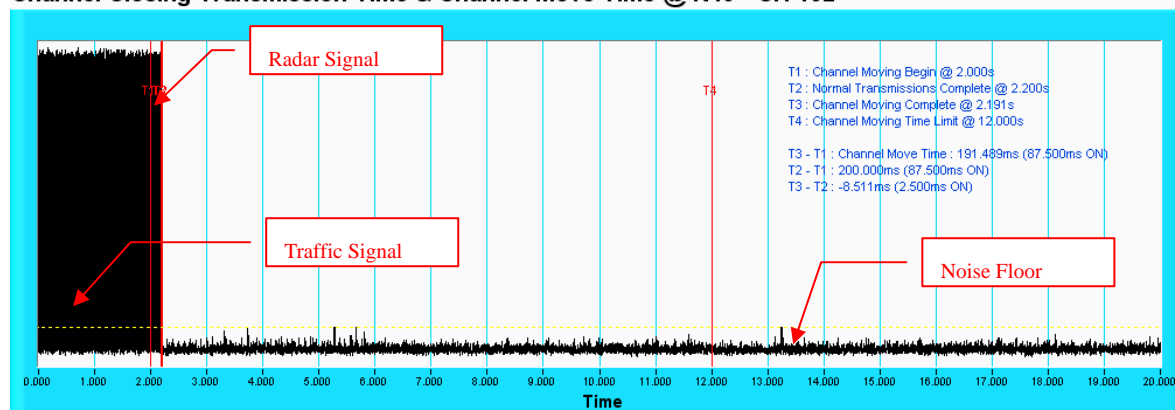
The required detection threshold is -59.572dBm ($= -64 + 3.428 + 1$). The conducted radar burst level is lower than -59.572dBm .



Radar Signal 0

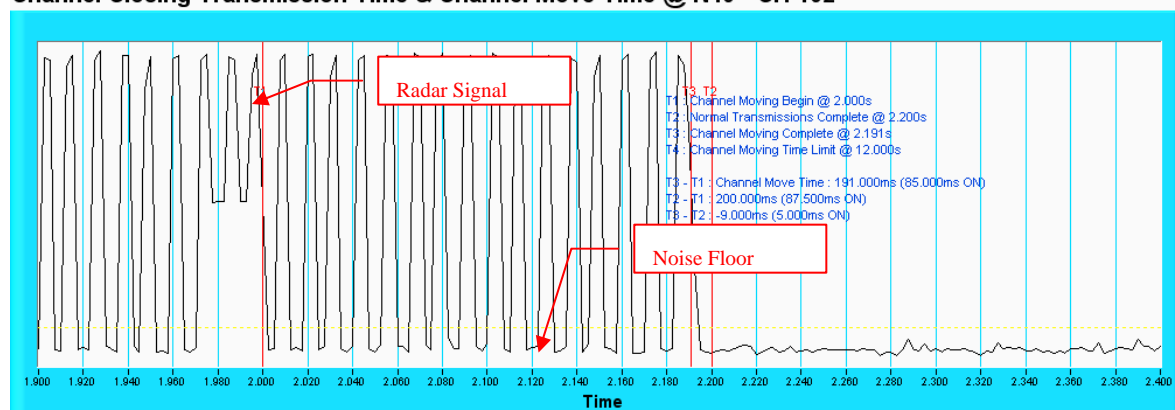

Channel Closing Transmission Time & Channel Move Time @ N40 - CH 102

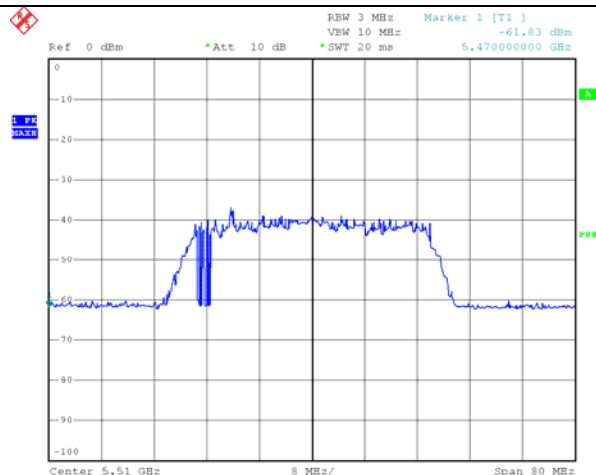

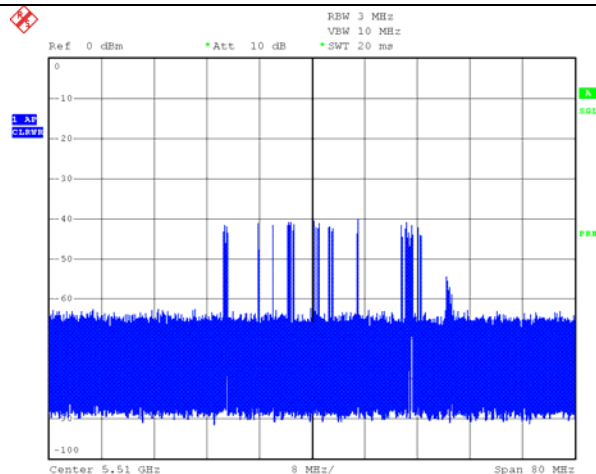

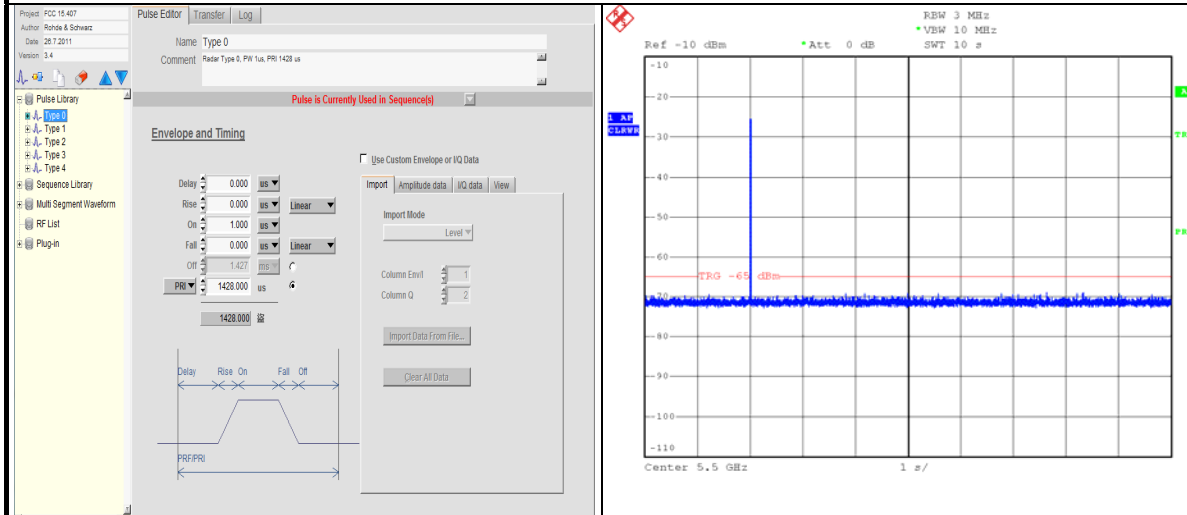

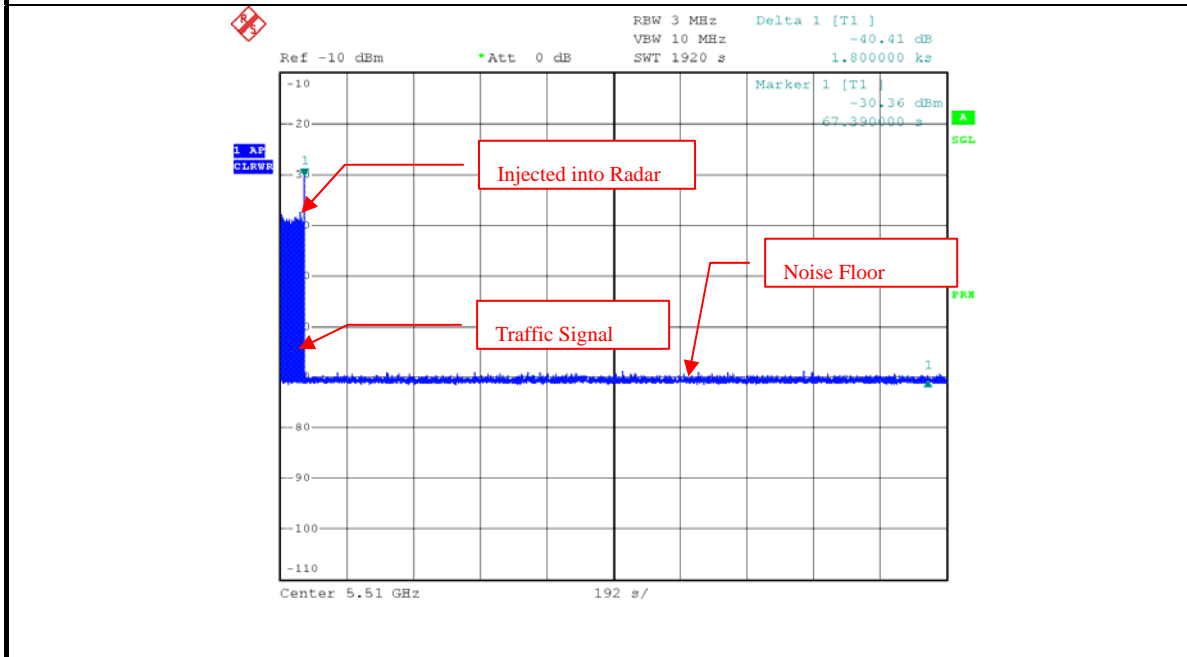

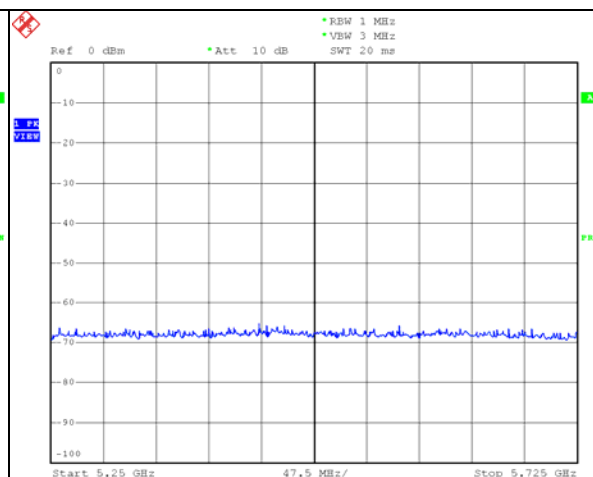
