Please note that the Users manual already contains the following information which meets the requirements:

BlueGiga Technologies Inc. WRAP THOR 2022-1-B2B module is FCC Approved as module to be installed in other devices. This device is to be used only for fixed and mobile applications. If the final product after integration is intended for portable use, a new application and FCC is required.

To meet the FCC's RF exposure rules and regulations:

- The antenna(s) used for this transmitter must be installed to provide a separation distance of at least 20 cm from all the persons and must not be co-located or operating in conjunction with any other antenna or transmitter.
- Users and installers must be provided with antenna installation instructions and transmitter operating conditions for satisfying RF exposure compliance.
- The product must be installed by an OEM or OEM authorized agent, a final consumer is not authorized to install this module in a product.
