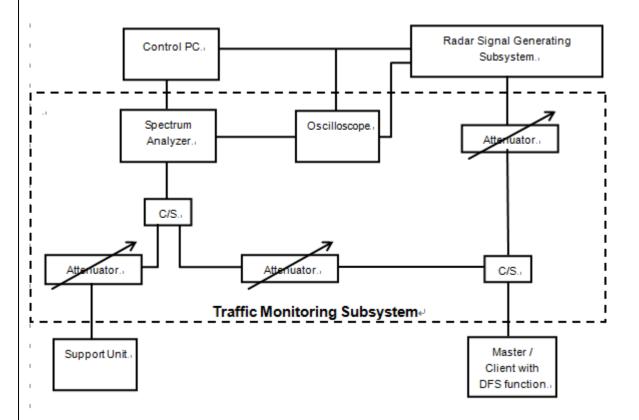


5 Test Procedure

5.1 DFS Measurement System

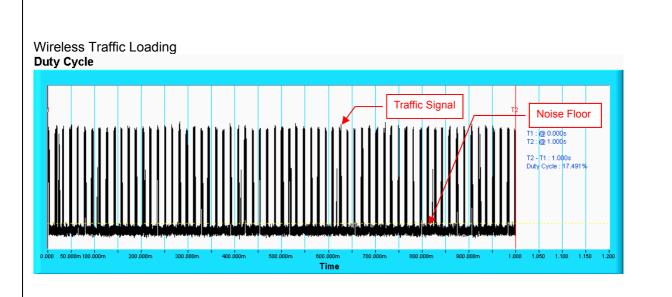
A complete DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 10, 11 and 12. The traffic monitoring subsystem is specified to the type of unit under test (UUT).

System testing will be performed with channel-loading using means appropriate to the data types that are used by the unlicensed device. The following requirements apply:

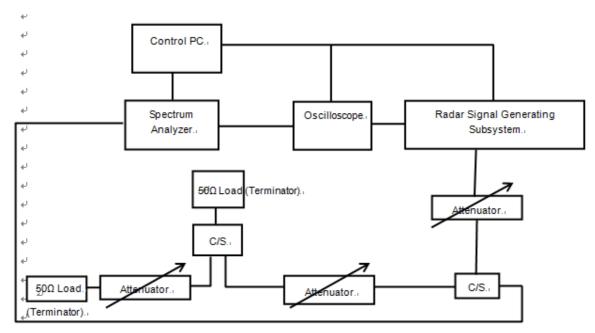

5.2 Calibration of DFS Detection Threshold Level

The measured channels are 5500MHz, 5510MHz, 5530MHz. The radar signal was the same as transmitted channels, and injected into the antenna of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The calibrated conducted detection threshold level is set to -64dBm. The tested level is lower than required level hence it provides margin to the limit.

Conducted setup configuration of Calibration of DFS Detection Threshold Level

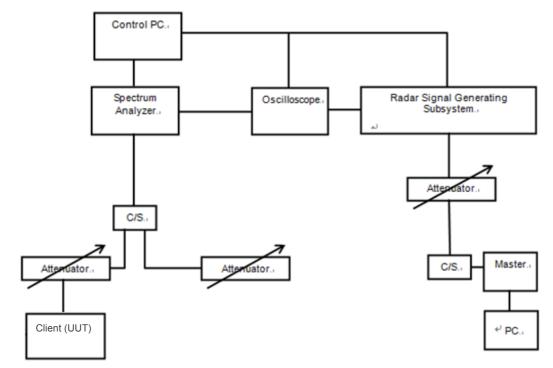

Channel Closing Transmission Time & Channel Move Time

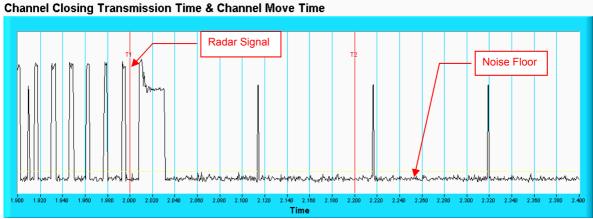

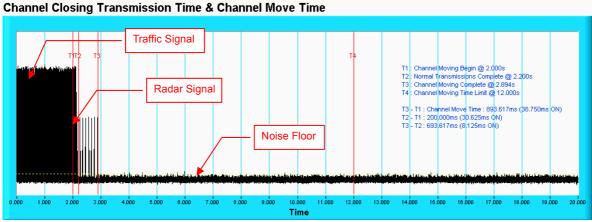

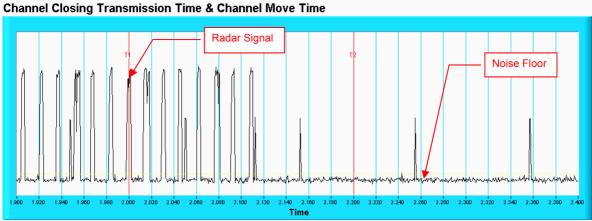

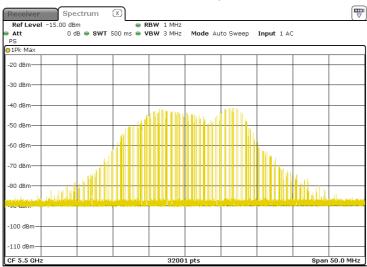
6.2.3 Non-Occupancy Period

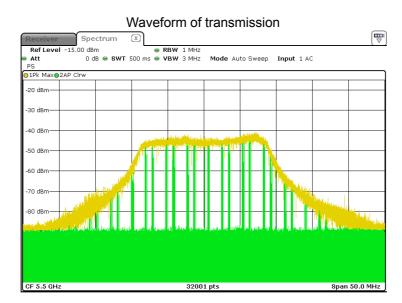
Waveform of EUT links up with Master

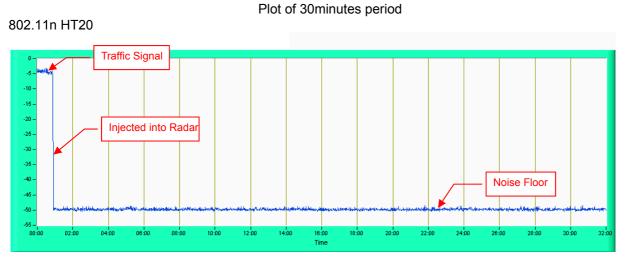
2) Client plays specified files via master.

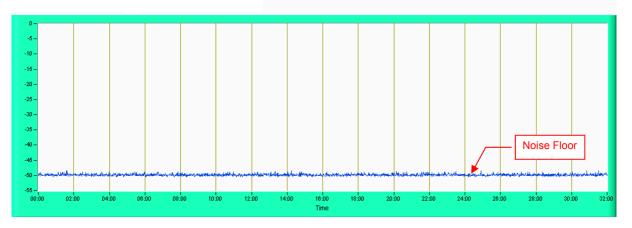
