1.Appearance



- 1. Screen Display
- 2. USB Type-A to charge other devices
- 3. USB Type-C for data communication and power charging of the JW-MRD-6001
- 4. Gigabit Ethernet
- 5. Status LED for WiFi connectivity
- 6. Micro-SIM slot

- 7. MicroSD slot (128GB in maximum)
- 8. Power/Function button. Power button: 3-sec long press to turn on/off the JW-MRD-6001; Function button: When the JW-MRD-6001 on, tap Function button twice quickly for menu selection
- 9. Reset button: 4-sec long press for factory reset

2.Install the SIM Card




- Install SIM card to Micro-SIM slot as shown
- MicroSD slot to expand the storage of MRD6001

3. Connecting to the Internet



- Ensure your SIM card is properly inserted
- Long-press power button for 3-sec to turn on the JW-MRD-6001
- Check WLAN name (SSID) and password on display screen
- The WLAN name (SSID) and password able to be changed through Web UI and remote application of the JW-MRD-6001





 Share 4G LTE connection through WiFi with multiple mobile devices or through USB Type-C (note: enable USB sharing through Web UI and remote application of the JW-MRD-6001)

4. WiFi Offloading



• Connect cat.5e Ethernet cable to the gigabit Ethernet connector of the JW-MRD-6001. Then, the JW-MRD-6001 will offload data traffic to LAN to minimize the usage of cellular network

5.Charge Other Portable Devices



Able to charge other devices through USB Type-A

8. RF Exposure Information (SAR)
