To Whom It May Concern:


On behalf of Applicant Matsushita Electric Industrial Co., Ltd. and their agent Matsushita Electronic Corporation of America, we hereby authorize PCTEST Engineering Laboratory, Inc., to act on our behalf in matters relating to FCC equipment authorization, including the signing of documents relating to these matters. Any and all acts carried out by PCTEST on our behalf shall have the same effect as acts of our own.

This filing represents Panasonic Mobile Personal Computer, Model CF-29-mk3 Family to be marketed under FCC ID: ACJ9TGCF-299A. This product will be marketed exclusively for mobile application with at least 20 cm spacing between antennas in LCD panel and person's body. This configuration represents: (1) CPU type Pentium-M-1.4 GHz; (2) Intel WLAN (a+b+g) Module Model WM3B2915ABG with Part 15C operation within 2412~2462 and 5745~5825 MHz at 233 and 103 mW peak conducted RF output and Part 15E operation within 5180~5240 and 5260~5320 MHz at 54 and 125 mW peak conducted RF output; (3) Sony EGPRS PCMCIA Card, Model GC83 with Part 22H operation within 824.2~848.8 MHz at 0.617 watts ERP and Part 24E operation within 1850.2~1909.8 MHz at 0.805 watts EIRP; and (4) Car Mounter Model CF-WEB291 with 2 external connectors for EDGE and WLAN external antennas. The optional external WLAN antenna is by Radiall/Larsen, type MS3E2400TNC. This WLAN antenna has 3dBi omni directional antenna gain and magnet roof mounted base.

The basic portable PC's User Manual contains all general RF exposure warning notices, which includes notice that PC was approved for portable operation and unless otherwise advised in separate supplemental instructions for individual wireless transmitter(s), requires minimum 1.5 cm spacing. The mobile PC's User Manual contains all general RF exposure warning notices, which includes notice that PC was approved for mobile operation and requires minimum 20 cm spacing. The optional Car Mounter has external mounted antennas are for mobile operation and must be professionally installed and cannot exceed recommended maximum antenna dBi gain. Refer to provided sample of User Manuals for exact wording.

In accordance with provisions of Section 0.457(d) of the Commission's Rules and Section 552(b)(4) of the Freedom of Information Act, we request confidentiality for transmitter's exhibits for Operation Description, Parts List & Tune-Up Procedure, Block Diagram(s) and Schematic Diagram(s). These exhibits contain proprietary, confidential and trade secrets material, which would not be routinely made available for public inspection.
