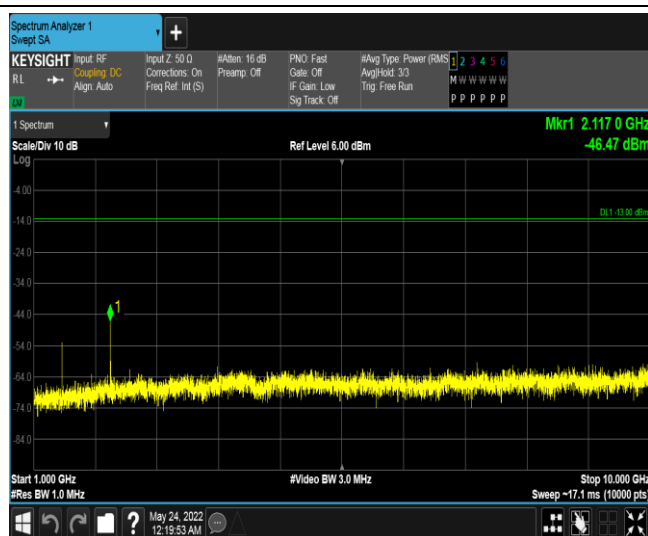


Band17-10MHz-16QAM-23790-1RB#0-Range2:30~1000MHz

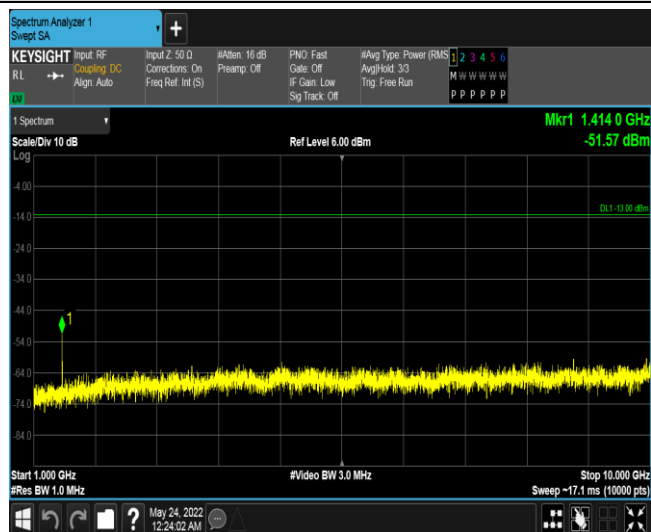
