P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

## 2.5 Standalone MPE Result

As declared by the Applicant, the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance,  $r = 20\text{cm}$ , as well as the gain of the used antenna is refer to section 4, the RF power density can be obtained.

$g_t$ =numeric gain of the transmitting antenna (unitless)

$E$ =electric field strength in V/m

$d$ =measurement distance in meters (m)

According to the formula described above:

$$P_t = (E \times d)^2 / (30 \times g_t) = (0.0663 \times 3)^2 / (30 \times 1.321) = 0.0010 \text{ W} = 1.00 \text{ mW} = 0.02 \text{ dBm}$$

2472MHz

$$E_{\text{max}} = 96.02 \text{ dBuV/m} = 0.0632 \text{ V/m}, d=3\text{m}, g_t=1.321$$

$$P_t = (E \times d)^2 / (30 \times g_t) = (0.0632 \times 3)^2 / (30 \times 1.321) = 0.00091 \text{ W} = 0.91 \text{ mW} = -0.41 \text{ dBm}$$
