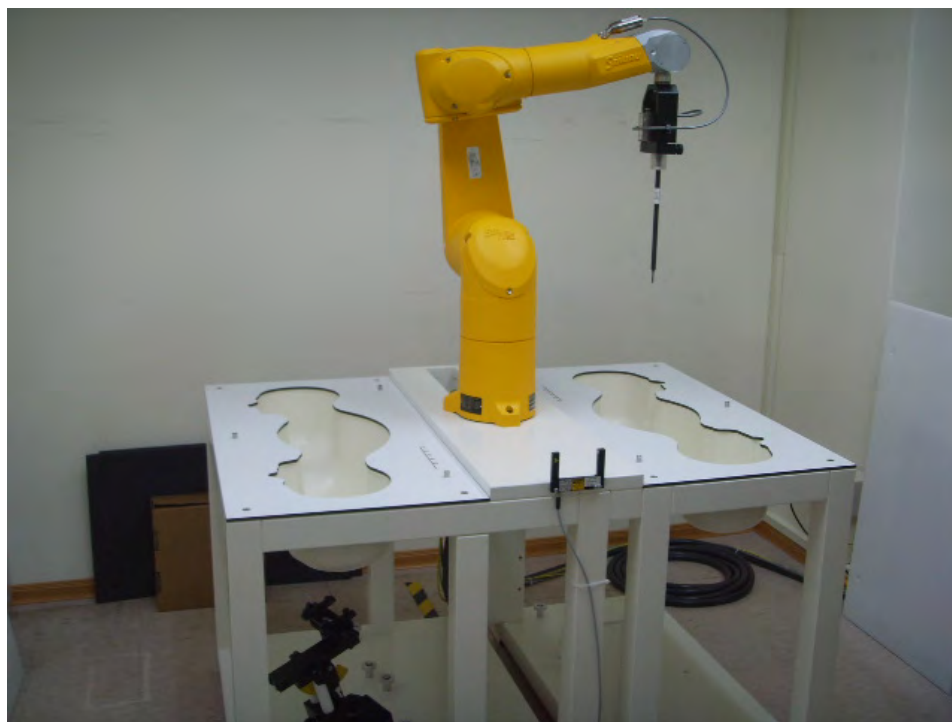


Fig.1 Photograph of the SAR measurement system

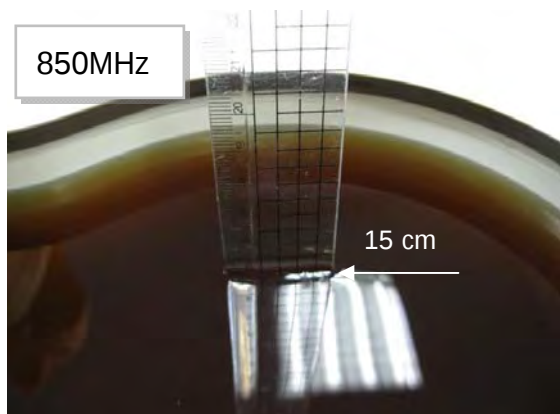

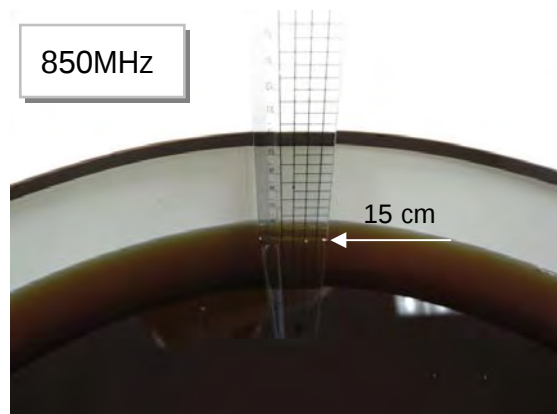

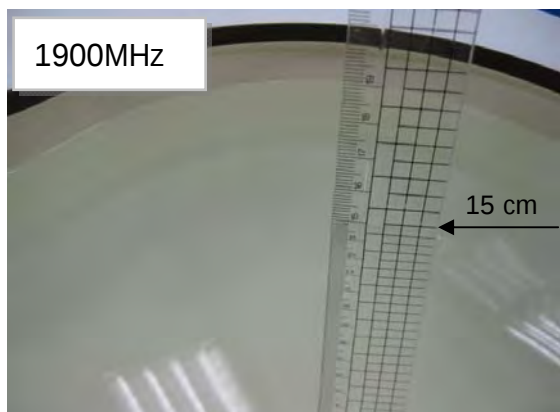

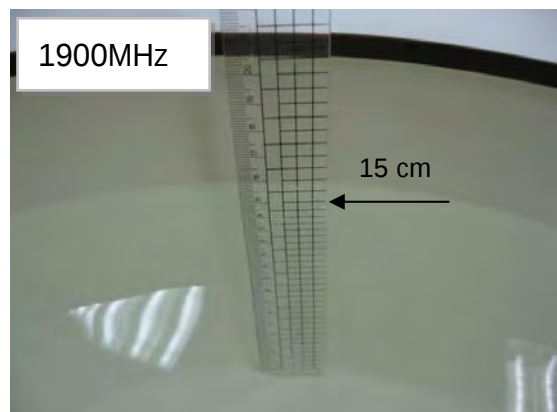

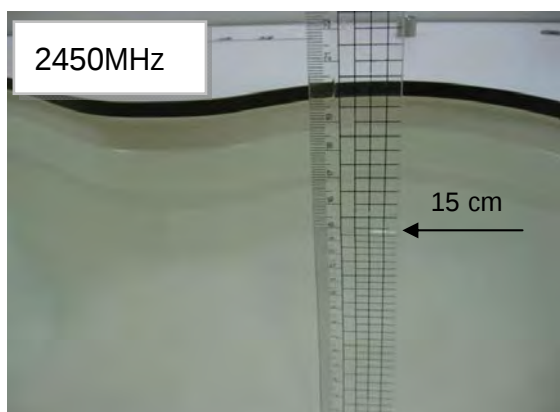

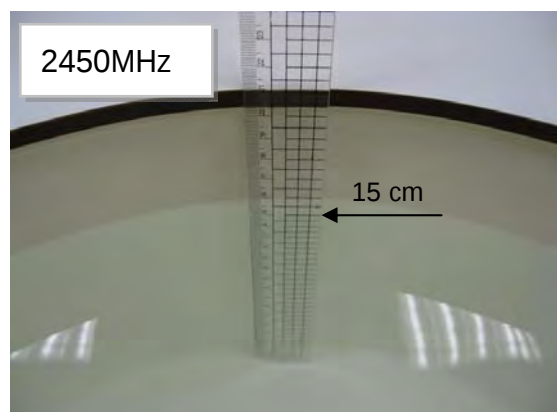

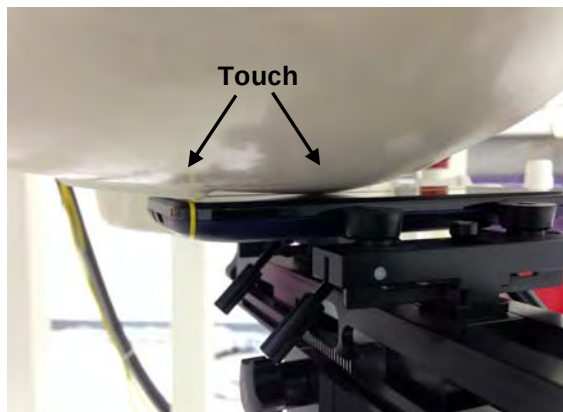


Fig.3 Right Head Section / Cheek-Touch Position

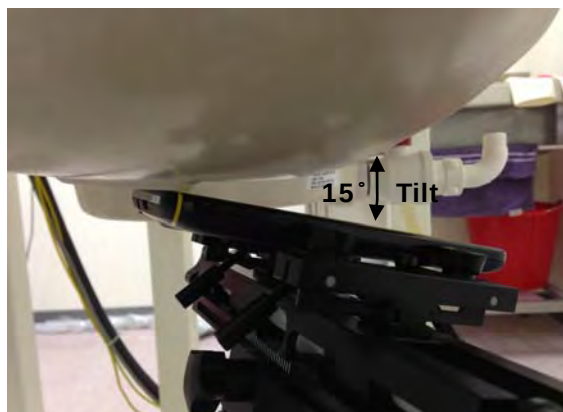
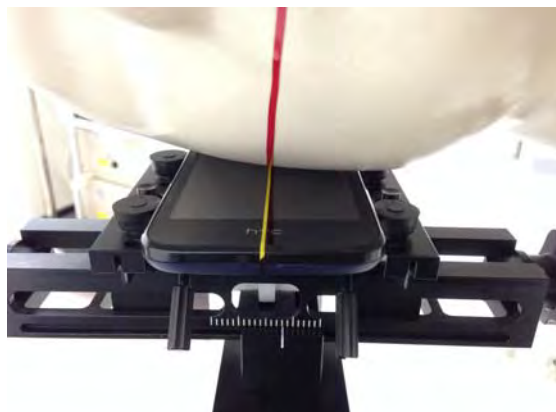


Fig.4 Right Head Section / Ear-Tilt Position(15°)

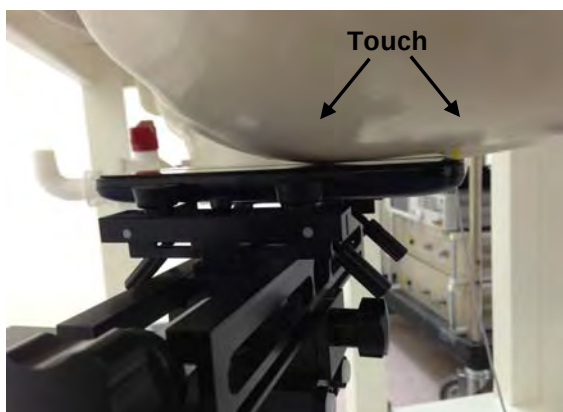


Fig.5 Left Head Section / Cheek-Touch Position

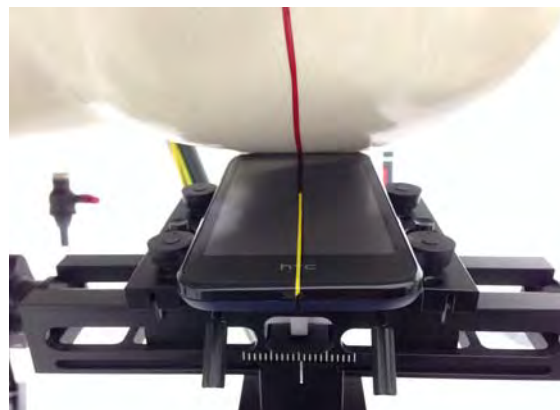
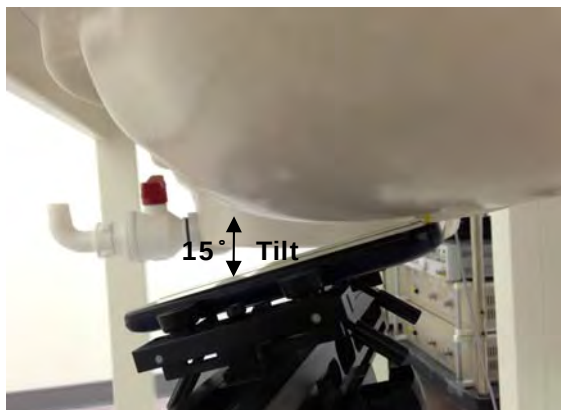


Fig.6 Left Head Section / Ear-Tilt Position(15°)

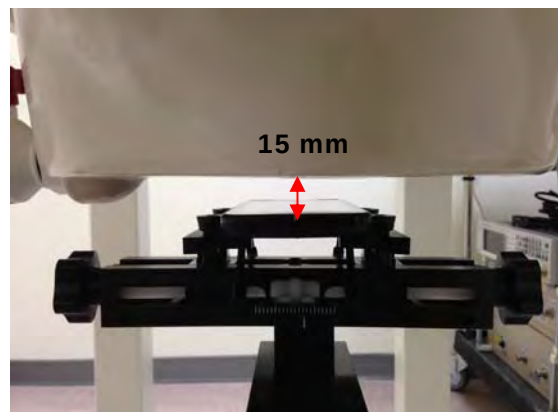


Fig.7 EUT front to flat phantom

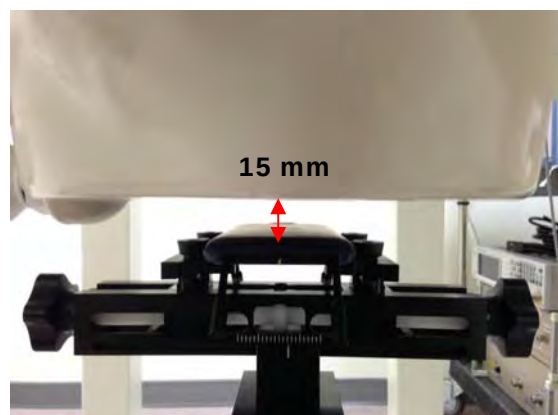


Fig.8 EUT back to flat phantom

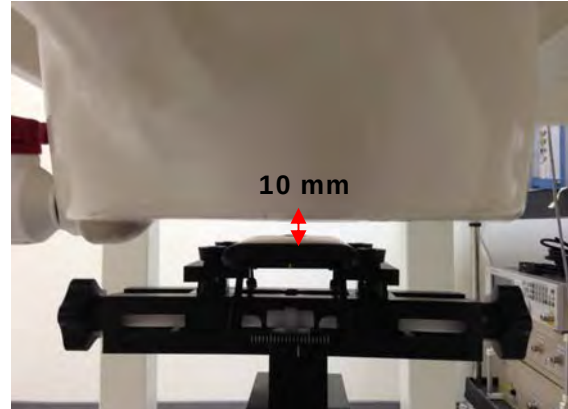


Fig.9 EUT back to flat phantom

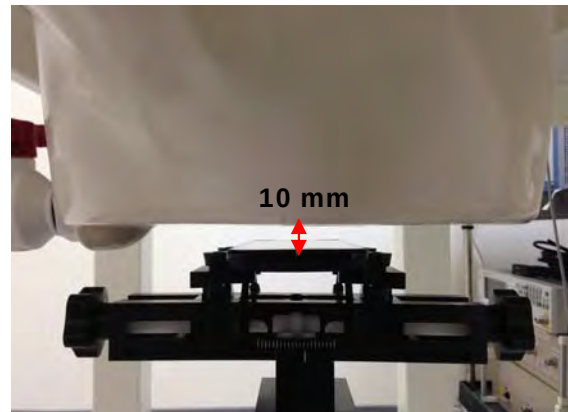


Fig.10 EUT front to flat phantom

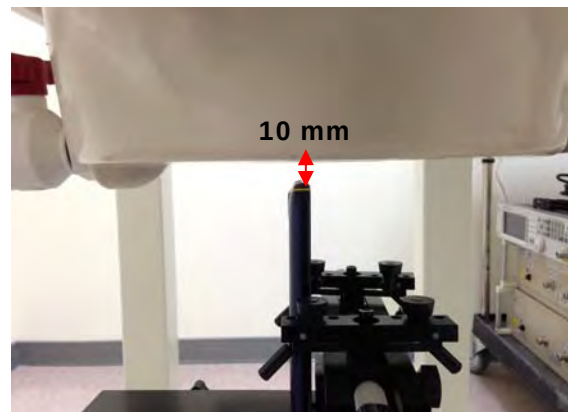


Fig.11 EUT top to flat phantom

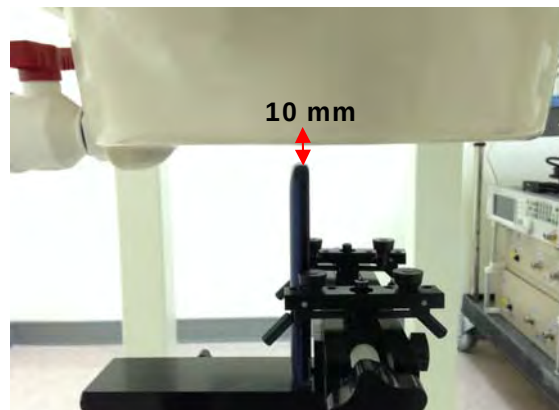


Fig.12 EUT bottom to flat phantom

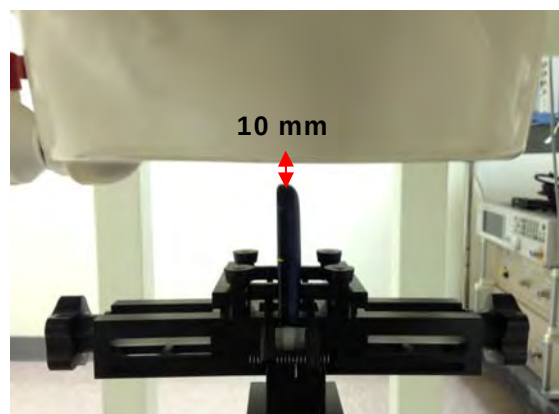


Fig.13 EUT right to flat phantom

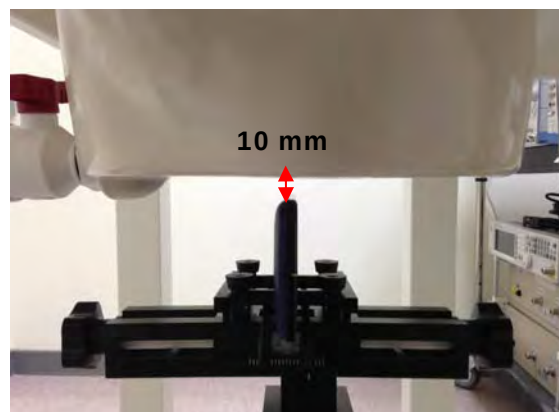


Fig.14 EUT left to flat phantom

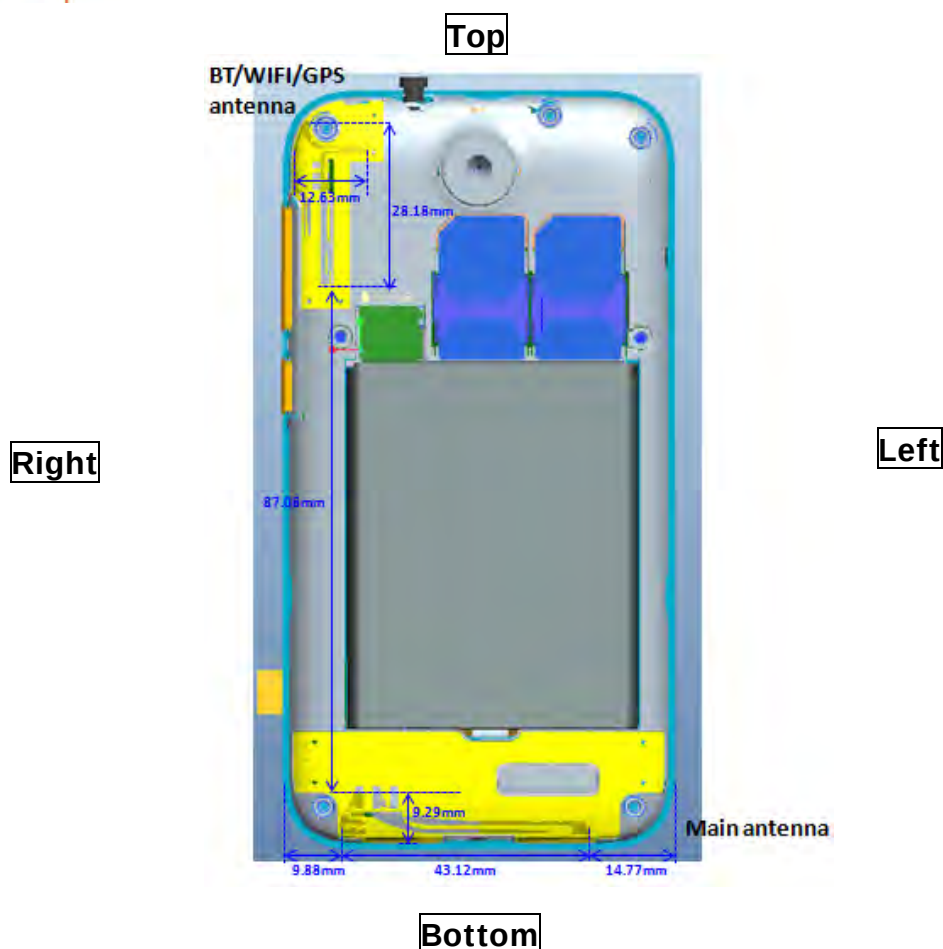


Fig.21 Antenna position of EUT (Back view)
