SAFETY AND GENERAL INFORMATION IMPORTANT INFORMATION ON SAFE AND EFFICIENT OPERATION READ THIS INFORMATION BEFORE USING YOUR RADIO

The information provided in this document supersedes the general safety information contained in user guides published prior to July 2000. For information regarding radio use in a hazardous atmosphere please refer to the Factory Mutual (FM) Approval Manual Supplement or Instruction Card, which is included with radio models that offer this capability.

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

Transmit and Receive Procedure

Your two-way radio contains a transmitter and a receiver. To transmit (talk), you must push the Push-to-Talk button; to receive (listen), release the Push-to-Talk button.

Exposure To Radio Frequency Energy

Your Motorola radio is designed to comply with the following national and international standards and guidelines regarding exposure of human beings to radio frequency electromagnetic energy:

To assure optimal radio performance and make sure human exposure to radio frequency electromagnetic energy is within the guidelines set forth in the above standards, always adhere to the following procedures:

PORTABLE RADIO OPERATION AND EME EXPOSURE

Antenna Care

Use only the supplied or an approved replacement antenna. Unauthorized antennas, modifications, or attachments could damage the radio and may violate FCC regulations.

DO NOT hold the antenna when the radio is "IN USE." Holding the antenna affects call quality and may cause the radio to operate at a higher power level than needed.

Two-way Radio Operation

When using your radio as a traditional two-way radio, hold the radio in a vertical position with the microphone one to two inches (2.5 to 5 cm) away from the lips.

Body-worn Operation

To maintain compliance with FCC/Health Canada RF exposure guidelines, if you wear a radio on your body when transmitting, always place the radio in a Motorola supplied or approved clip, holder, holster, case, or body harness for this product. Use of non-Motorola-approved accessories may exceed FCC/Health Canada RF exposure guidelines. If you do not use one of the Motorola-supplied or approved body-worn accessories, and are not using the radio held in the normal use position, ensure the radio and its antenna are at least one to two inches (2.5 to 5 cm) away from your body when transmitting.

Data Operation

When using any data feature of the radio, with or without an accessory cable, position the radio and its antenna at least one to two inches (2.5 to 5 cm) away from the body.

ELECTROMAGNETIC INTERFERENCE/COMPATIBILITY

Note: Nearly every electronic device is susceptible to electromagnetic interference (EMI) if inadequately shielded, designed or otherwise configured for electromagnetic compatibility.

FACILITIES

To avoid electromagnetic interference and/or compatibility conflicts, turn off your radio in any facility where posted notices instruct you to do so. Hospitals or health care facilities may be using equipment that is sensitive to external RF energy.

AIRCRAFT

When instructed to do so, turn off your radio when on board an aircraft. Any use of a radio must be in accordance with applicable regulations per airline crew instructions.

MEDICAL DEVICES

Pacemakers

The Advanced Medical Technology Association recommends that a minimum separation of 6 inches (15 centimeters) be maintained between a handheld wireless radio and a pacemaker. These recommendations are consistent with the independent research by, and recommendations of, the United States Food and Drug Administration.

Persons with pacemakers should:

- ALWAYS keep the radio more than six inches (15 centimeters) from their pacemaker when the radio is turned ON.
- not carry the radio in the breast pocket.
- use the ear opposite the pacemaker to minimize the potential for interference.
- turn the radio OFF immediately if you have any reason to suspect that interference is taking place.

Hearing Aids

Some digital wireless radio may interfere with some hearing aids. In the event of such interference, you may want to consult your hearing aid manufacturer to discuss alternatives.

Other Medical Devices

If you use any other personal medical device, consult the manufacturer of your device to determine if it is adequately shielded from RF energy. Your physician may be able to assist you in obtaining this information.

Safety and General Use While Driving

Check the laws and regulations on the use of radio in the area where you drive. Always obey them.

When using your radio while driving, please:

- Give full attention to driving and to the road.
- Use hands-free operation, if available.

 Pull off the road and park before making or answering a call if driving conditions so require.

OPERATIONAL WARNINGS

FOR VEHICLES WITH AN AIR BAG

Do not place a portable radio in the area over an air bag or in the air bag deployment area. Air bags inflate with great force. If a portable radio is placed in the air bag deployment area and the air bag inflates, the radio may be propelled with great force and cause serious injury to occupants of the vehicle.

POTENTIALLY EXPLOSIVE ATMOSPHERES

Turn off your radio prior to entering any area with a potentially explosive atmosphere, unless it is a radio type especially qualified for use in such areas as "Intrinsically Safe." Do not remove, install, or charge batteries in such areas. Sparks in a potentially explosive atmosphere can cause an explosion or fire resulting in bodily injury or even death.

Note: The areas with potentially explosive atmospheres referred to above include fueling areas such as below decks on boats, fuel or chemical transfer or storage facilities, areas where the air contains chemicals or particles, such as grain, dust or metal powders, and any other area where you would normally be advised to turn off your vehicle engine. Areas with potentially explosive atmospheres are often but not always posted.

BLASTING CAPS AND AREAS

To avoid possible interference with blasting operations, turn off your radio when you are near electrical blasting caps, in a blasting area, or in areas posted: "Turn off two-way radio." Obey all signs and instructions.

OPERATIONAL CAUTIONS

ANTENNAS

Do not use any portable radio that has a damaged antenna. If a damaged antenna comes into contact with your skin, a minor burn can result.

BATTERIES

All batteries can cause property damage and/or bodily injury such as burns if a conductive material such as jewelry, keys, or beaded chains touch exposed terminals. The conductive material may complete an electrical circuit (short circuit) and become quite hot. Exercise care in handling any charged battery, particularly when placing it inside a pocket, purse, or other container with metal objects.



Radio Etiquette

Your radio has multiple channels shared on a "take turns" basis. This means other groups may be talking on the channels. For uninterrupted communications, do not talk over someone who is already using the channel - your message may not be completely heard. Try changing the channel to avoid channel congestion or press twice to check for channel activity. If you hear static after pressing \$\vec{\psi}\$, the channel is clear for use.

Batteries

T4300 radios operate with 4 AAA Alkaline batteries.

Installation

- 1. With back of radio facing you, lift Battery Cover Latch up to release.
- 2. Lift Battery Cover off.
- 3. Insert 4 AAA Alkaline batteries as shown.
- 4. Reposition Battery Cover.
- 5. Press Battery Cover Latch down to secure.

Low Battery Alert

When batteries are low, radio will beep:

- 3 to 4 seconds after turning radio On.
- Every 10 minutes in standby mode.
- After releasing or Call button.

Replace batteries immediately to avoid interrupted use.

Battery Life

The approximate battery life during Two-way Use* for AAA Alkaline is 20 Hours. *Two-way Use is defined as 90% standby time, 5 % talk time, and 5% receive time.

Battery Cover/Latch

Note: Remove batteries before storing your radio for extended periods. Batteries corrode over time and may cause permanent damage to your radio.

Talking and Listening

Read this manual carefully and make sure you know how to properly operate radio before use. Motorola Talkabout two-way radios have 14 channels. To communicate with others, all radios in your group must be set to the same Channel (I - I 4). Other FRS radios may have Interference Eliminator Codes, which must be turned Off or set to 0 for proper communication with T4300 radios.

- To maximize clarity, hold radio 2 to 3 inches from mouth.
- Press and hold and speak into the microphone. The outer segments around the display are visible when transmitting.

Talk Range

Your radio has been designed to maximize performance and improve transmission range. It is recommended that you do not use the radios closer than 5 feet apart.

Channel

- 1. With radio On, press , current Channel will begin to flash.
- 2. Use ♂ and ♀ to change Channel while flashing.
- 3. Press or to set new Channel.

Volume

Press \mathfrak{G} or \mathfrak{G} to adjust your volume to a comfortable listening level.

The speaker icon; will appear and a level set tone will be heard as you adjust the volume. So is the loudest and so is the quietest.



Monitor

Pressing twice allows you to monitor your Channel for activity. It is also used to hear the volume of your radio when you are not receiving so you can adjust your volume. To turn monitor off, press the button again, push or wait 5 seconds.

Time-out Timer

The Time-out Timer feature helps extend battery life by preventing accidental transmission. The radio will emit a continuous warning tone after is pressed for 60 continuous seconds and will stop transmitting.

Keypad Lock

You can be sure your menu and volume settings won't be changed accidentally. Just turn on Keypad Lock by pressing and holding for 3 seconds. Your radio will beep and a visible Ring surrounding the Channel on the display will flash. You can turn off Keypad Lock by pressing and holding for 3 seconds again. Your radio will beep and the visible Ring surrounding the Channel on the display will stop flashing.

Alerts

Call Tone

The Call Tone obtains others' attention before you start talking. Press J and users using the same Channel with Code 0, will hear your Call Tone.

Roger Beep/Talk Confirmation Tone

When you turn on this feature, your two-way radio transmits a unique tone when you finish transmitting. It's like saying "Roger" or "Over" and lets others know you're finished talking.

- To enable Roger Beep/Talk Confirmation Tone, press and hold ♀ as you turn your radio On. Now, when you release the button, a Tone lets your friends know you're finished talking.
- To disable the Talk Confirmation Tone feature, turn your radio Off and then back On while pressing and holding ፟�.

Display Indicators

- When your T4300 is waiting to receive a message, segments around the edge of the display will slowly rotate clockwise.
- When you are receiving a call or the channel is busy, a solid ring around the edge of the display will blink.
- When you are transmitting, a solid ring will appear continuously around the edge of the display.

Problem	Solution		
No Power	Reposition or replace batteries.		
Erratic Display	Reposition or replace batteries.		
Message Not Transmitted	Make sure button is completely pressed while you transmit. Reposition or replace batteries. Shared Channel may be in use, try another Channel.		
Message Not Received	Confirm radios have same Channel settings and/or other Talkabout radios' Interference Eliminator Code* is set to 0. (*helps minimize interference) Make sure is not inadvertently being pressed. Reposition or replace batteries. Obstructions, operating indoors or in vehicles may interfere with communication. Change your location. Check to make sure volume is turned up.		

Problem	Solution
Hearing Other Conversation or Noise on a Channel.	Shared Channel may be in use, try another.
Limited Talk Range	Steel/concrete structures, heavy foliage and use in buildings and in vehicles will decrease range. Check for clear line of sight to improve transmission. Wearing radio close to body such as in a pocket or on a belt will decrease range. Change location of radio.
Heavy Static or Interference	Radios too close. Radios must be at least 5 feet apart; increase your distance. Radios too far apart. Obstacles interfere with transmission.

I. What This Warranty Covers

Defects in materials and workmanship in the following new "Products" manufactured, sold or certified by Motorola, with which this limited warranty is included in/on the package: (a) wireless cellular telephones, pagers and two-way radios that operate via "Personal Radio Service" (such as Family Radio Service and General Mobile Radio Service), together with software imbedded in any of these products, and (b) subject to the following exceptions, accessories or software sold for use with these products.

- <u>Battery Exception.</u> This limited warranty extends only to batteries in which the fullycharged capacity falls below 80% of rated capacity and batteries that leak;
- Software Exceptions. This limited warranty extends only to physical defects in the
 media (such as CD-ROM) that tangibly embodies each copy of any software sold
 and/or certified by Motorola for use with Products. Software that is not tangibly
 embodied in media and that is purchased separately from Products (such as

II. What the Period of Coverage Is

Subject to the following exceptions, one year from the date the Products are purchased by the first end-user:

- Limited Lifetime Warranty Exception.
