4. The formula in section 9.5 of the report states  $P_{\text{mission}}(\text{dBm}) = P_{\text{substTX}}(\text{dBm}) - L_{\text{cable}}(\text{dB}) + G_{\text{antenna}}(\text{dBi})$ . However, the formula shown in the tables indicate that you added the cable. As you did not provide the factors themselves but only the results, it is not possible to determine if you added or subtracted that cable factor. Please correct as necessary.  
There was a misprint in the informal formula on the report's table header. It's been corrected now and new test report "831\_Exh6\_Tre\_FCC\_0452\_06\_revised.pdf" is uploaded.
5. Please note that the 731 states the device is also a BT Transmitter. Please note that no test report has been provided for the BT transmitter. Please provide the appropriate BT test report.

6. Please note that the EMC report for part 15B has been provided. If this is a composite application that is to include 15B, please provide the appropriate 731 form to include this information.

7. Please provide the test reports for the conducted and radiated emissions for Part 24.  
Device has no external antenna connector. That's why only radiated spurious emissions were measured. See report 831\_Exh6\_Tre\_FCC\_0452\_06.pdf.
8. Please note that the manual lists EU SAR limits. Please refer to US SAR limits for US products.
