1. Brief Description

The digital night vision scope can perform in all ambient light. It has an advanced HD sensor and a high resolution OLED display, which provides full-color clarity in daytime and classic black & white viewing at night. The traditional-style tube meets the needs of professional hunters who value traditions and seek technological superiority, ensuring an extreme detection range of up to 600 meters.

The device can capture snapshots, record videos, and set parameters by T-Vision App after being connected to your phone via hotspot.

Search the T-Vision on App Store (iOS System) or Google Play™ (Android System) to download it, or scan the QR code to download and install the App.

2. Appearance

Component & Interface (Page 1 – A)

The appearance descriptions of the two types are shown below. Please take the actual product for reference.

No.	Component	Function
1	Lens Cover	Protect the lens.
2	Focus Ring	Adjust the focal length.
3	Type-C Interface	Charge the device and transmit data.

4	Battery Compartment	Install the device battery in it.
5	Wheel	● Press: switch reticle ● Hold: enter/exit menu ● Rotate: switch digital zoom
6	Power Key	● Press: standby mode/wake up device ● Hold: power on/off
7	Laser Key	For models with laser rangefinder: ● Press: measure the distance with laser ● Hold: FFC
8	Capture Key	● Press: capture snapshots ● Hold: start/stop recording
9	Diopter Adjustment Ring	Adjust the dioptric correction.
10	Eyepiece	View the target.
11	Laser Rangefinder	Measure the distance to the target with laser.
12	Indicator	● Solid Green: Bluetooth pairing succeeded. ● Flashing Green: Bluetooth is in paring. ● Solide Red: Bluetooth unpaired or Bluetooth pairing failed.
13	Power Key	● Press: power on the laser rangefinder and start Bluetooth pairing. ● Hold: power off the laser rangefinder.
14	Battery Compartment	Install the battery of the laser rangefinder in it.

3. Install Battery

Install Battery in Device (Page 2 – B) Steps

1. Turn the battery cover anticlockwise to loosen it.
2. Insert the battery into the battery compartment with the positive mark inward.
3. Turn the battery cover clockwise to tighten it.

Install Battery in Laser Rangefinder (Page 2 – C)

Steps

1. Turn the battery cover anticlockwise to loosen it.
2. Insert the battery into the battery compartment with the positive mark inward.
3. Turn the battery cover clockwise to tighten it.

Note:

Take the battery away if you do not use the device for a long time.

4. Charging & Data Transmission (Page 3 – D)

Steps

1. Turn on the device and make sure the hotspot function is disabled.
2. Lift the cover of Type-C interface.
3. Connect the device and power adapter with a type-C cable to charge the device. Alternatively, connect the device and PC to export files.
