Maximum Power Spectral Density_TNVN_11N20_5745_Ant2

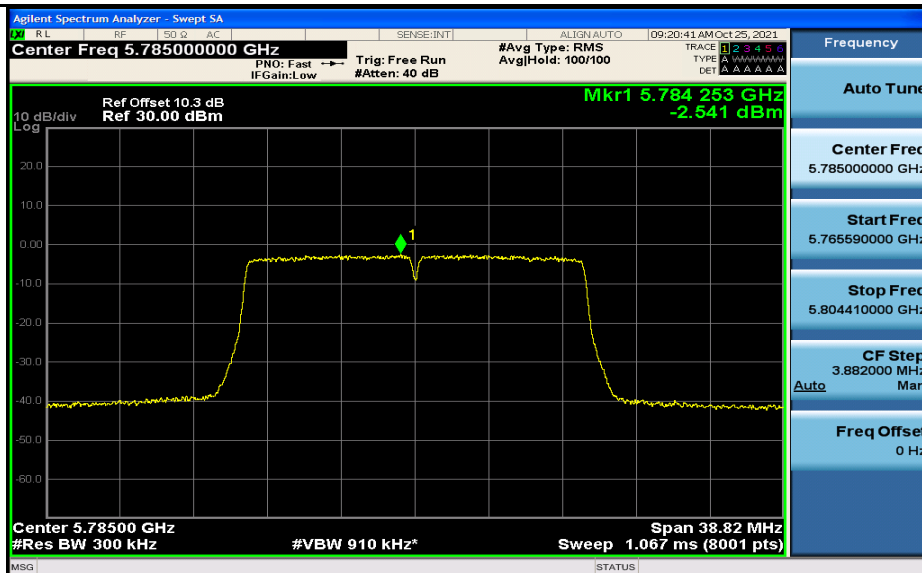

Maximum Power Spectral Density_TNVN_11N40_5795_Ant2

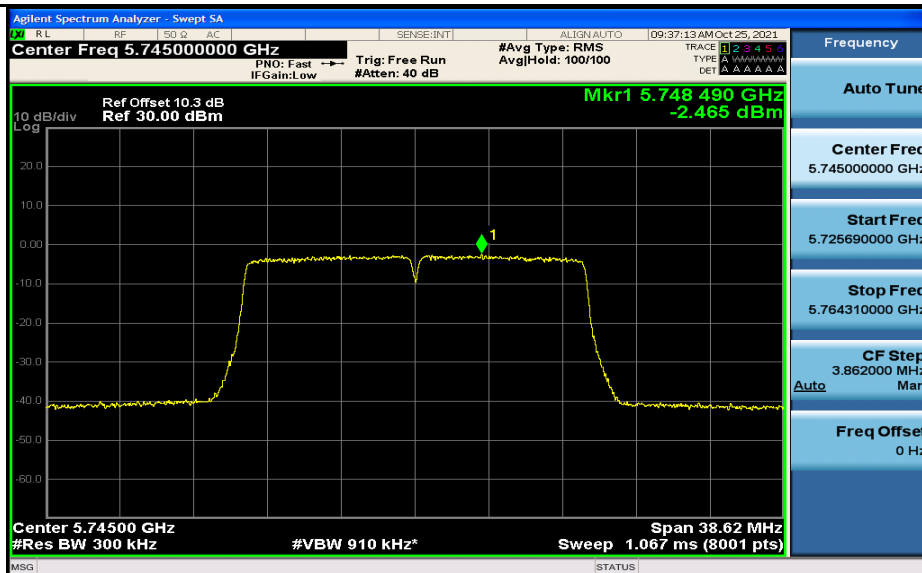

Maximum Power Spectral Density_TNVN_11AC40_5755_Ant2

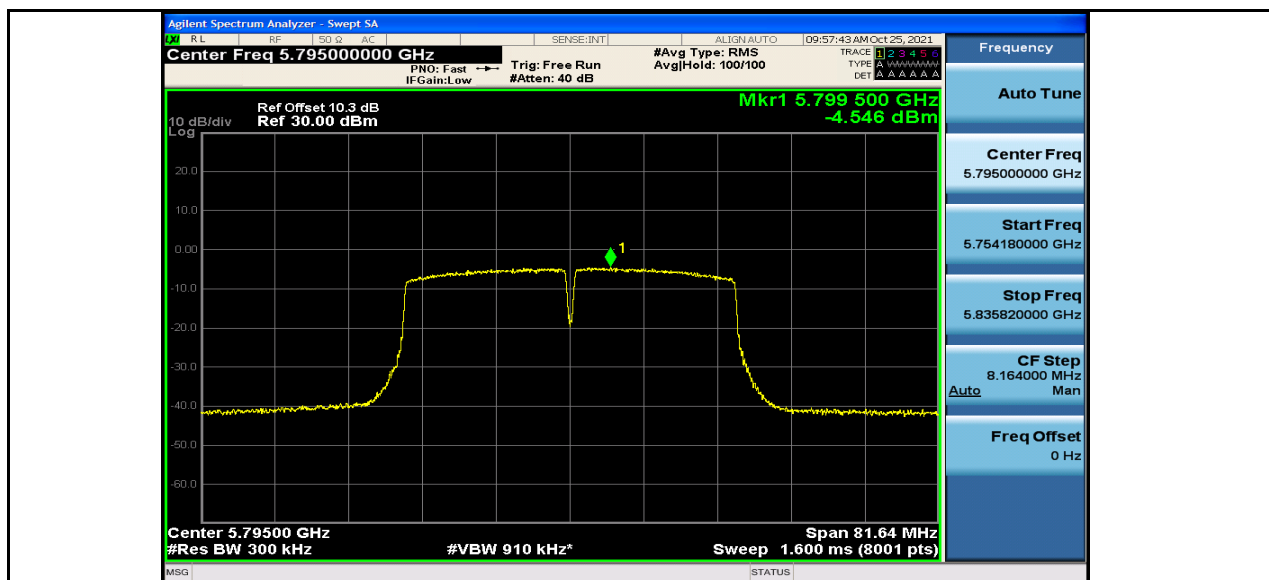
