The antenna is a FPC Antenna which permanently attached, and the best case gain of the antenna is 0.96dBi. It complies with the standard requirement.



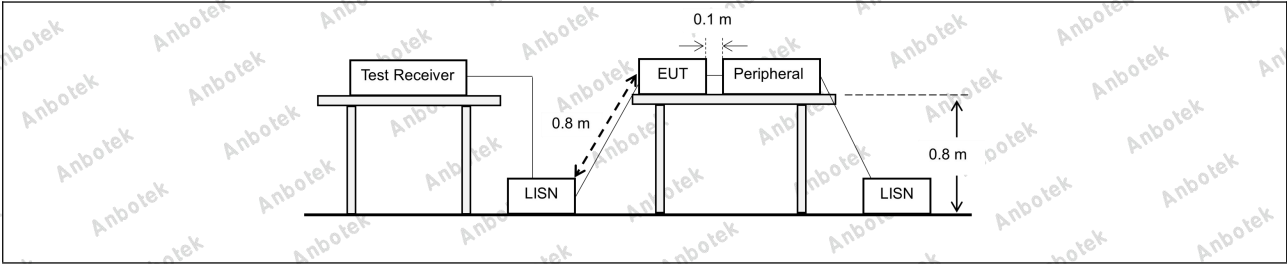

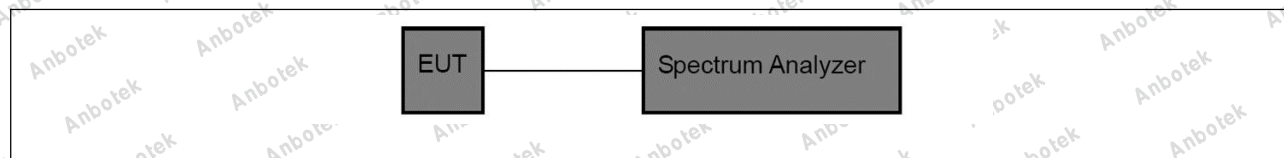
5. Maximum Conducted Output Power
