




4. Test Results and Measurement Data

According to §1.1307(b), systems operating under the provisions of this section shall be operated in a manner that ensure that the public is not exposed to radio frequency energy level in excess of the Commission's guideline.

Remark: 1) **For BLE:** The maximum output power for antenna is 3.72dBm(2.36mW) at 2440MHz, 2.99dBi antenna gain(with 1.99 numeric antenna gain.) **For WIFI:** The maximum output power for antenna is 12.96dBm(19.77mW) at 2412MHz, 2.99dBi antenna gain(with 1.99 numeric antenna gain.)



Calculation

Given

$$E = \frac{\sqrt{30 \times P \times G}}{d} \quad \& \quad S = \frac{E^2}{3770}$$

Where

E = Field Strength in Volts / meter

P = Power in Watts

G=Numeric antenna gain

d=Distance in meters

S=Power Density in milliwatts / square centimeter

Substituting the MPE safe distance using d=20cm into above equation.

Yields: S=0.000199*P*G
