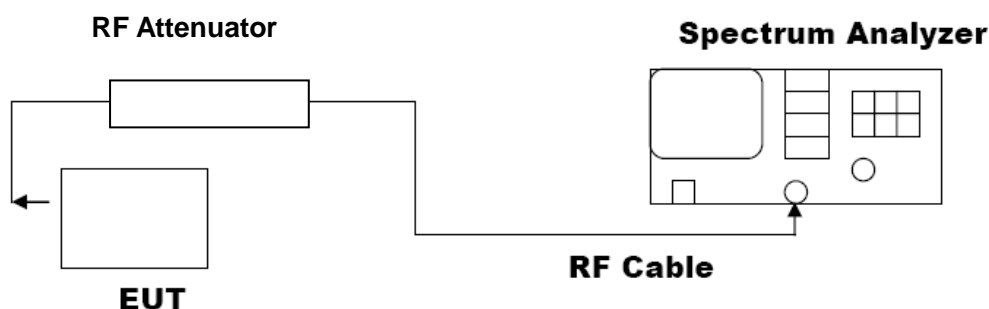

For peak power test:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. $RBW \geq DTS$ bandwidth
3. $VBW \geq 3 * RBW$.
4. $SPAN \geq VBW$.
5. Sweep: Auto.
6. Detector function: Peak.
7. Trace: Max hold.

Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.

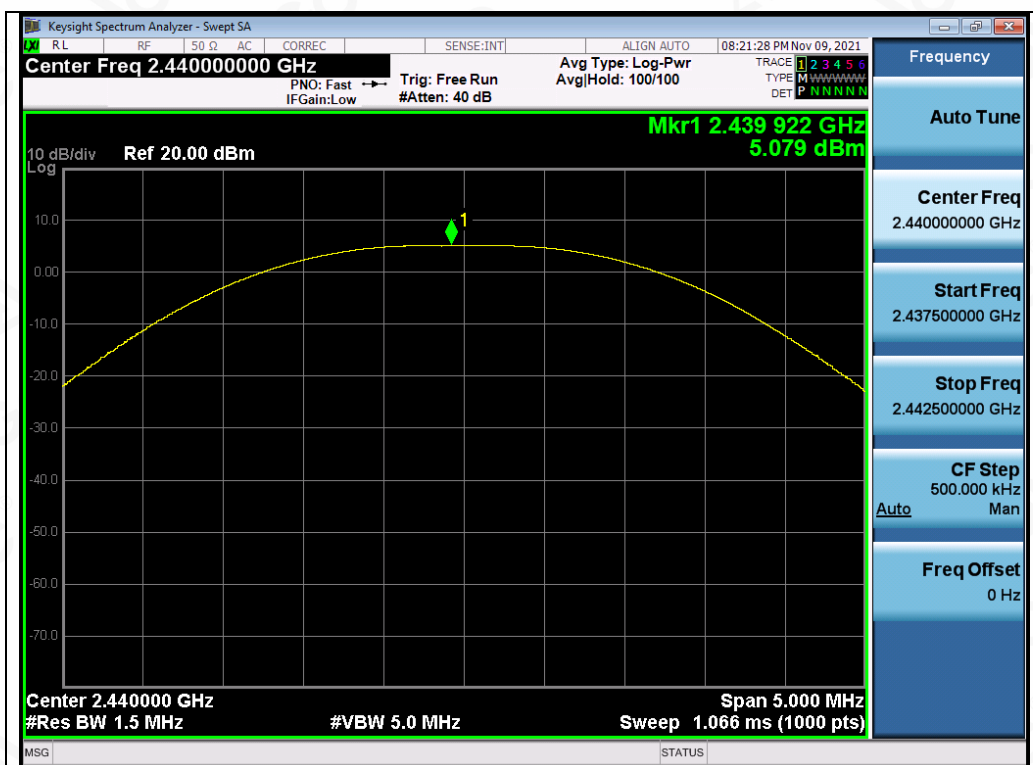
Test Graphs of Conducted Output Power



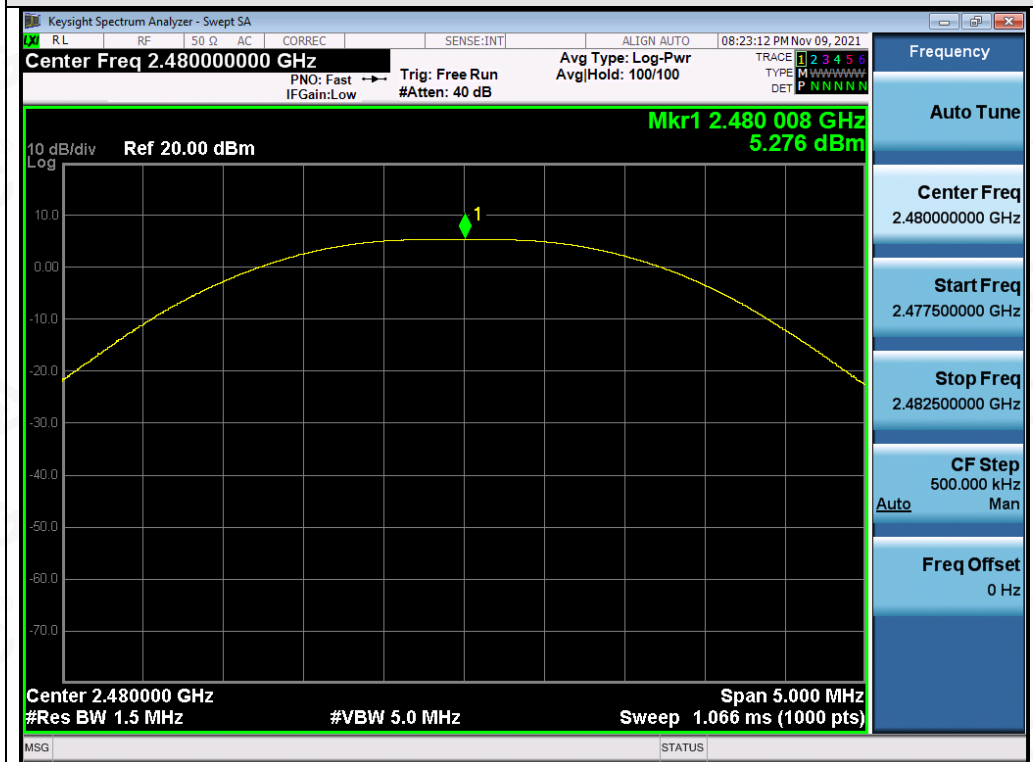

Test_Graph_LE1M_ANT1_2440_1Mbps_Peak Power



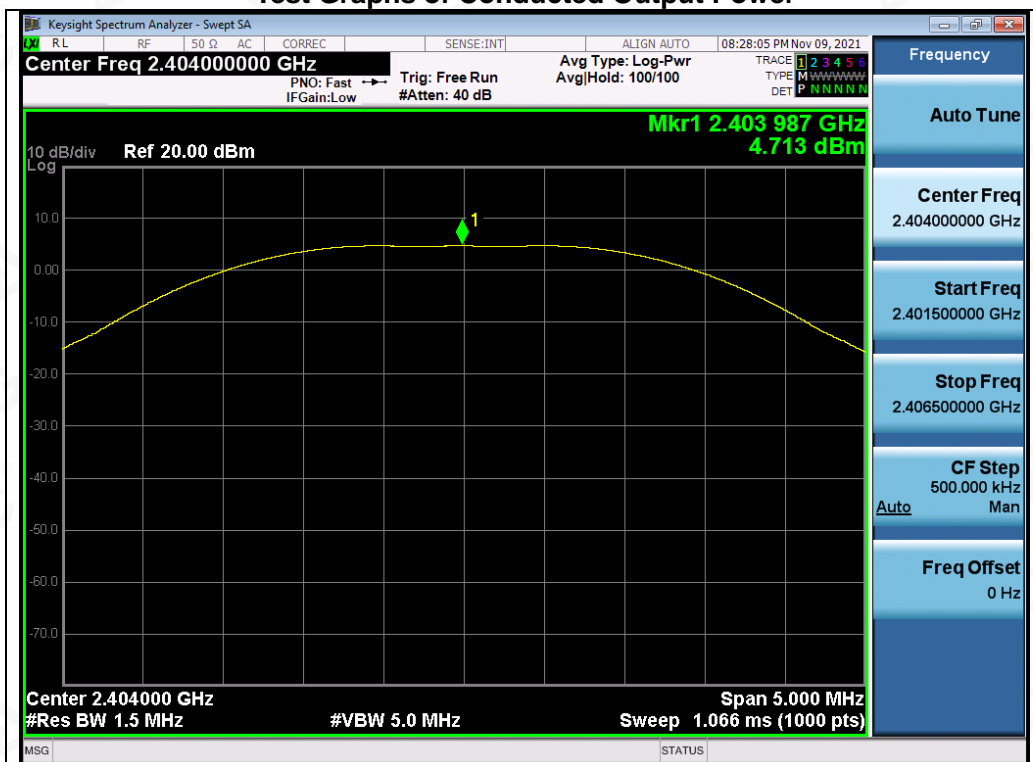

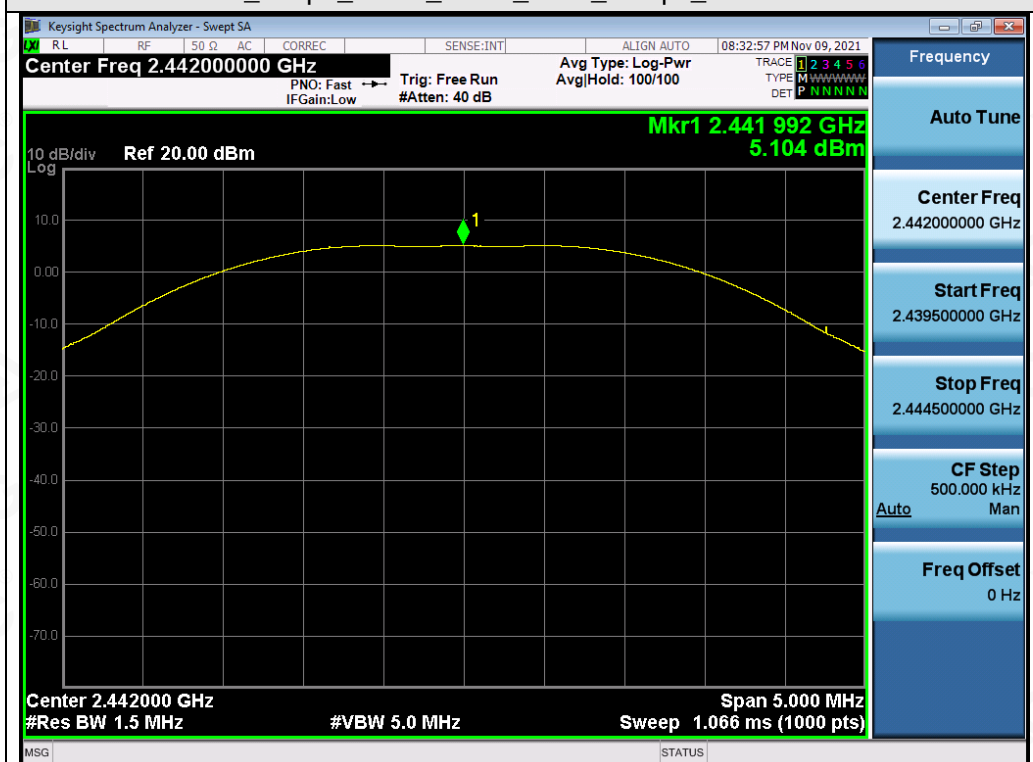

Test_Graph_LE2M_ANT1_2404_2Mbps_Peak Power

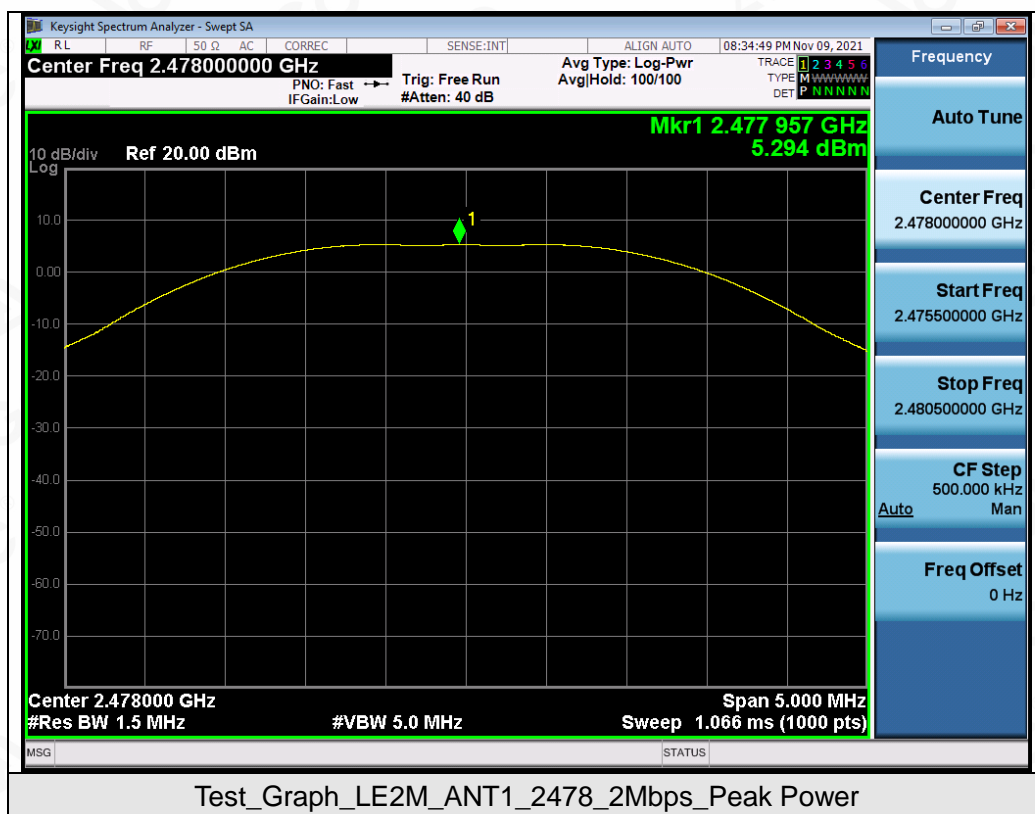


Test_Graph_LE2M_ANT1_2442_2Mbps_Peak Power

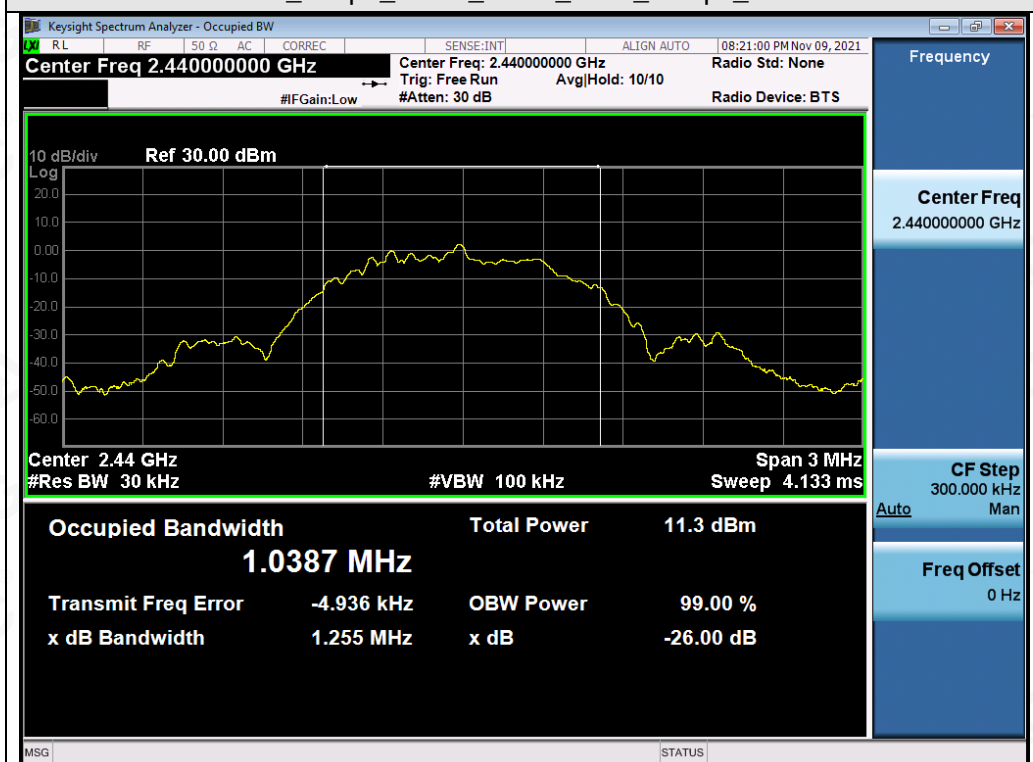

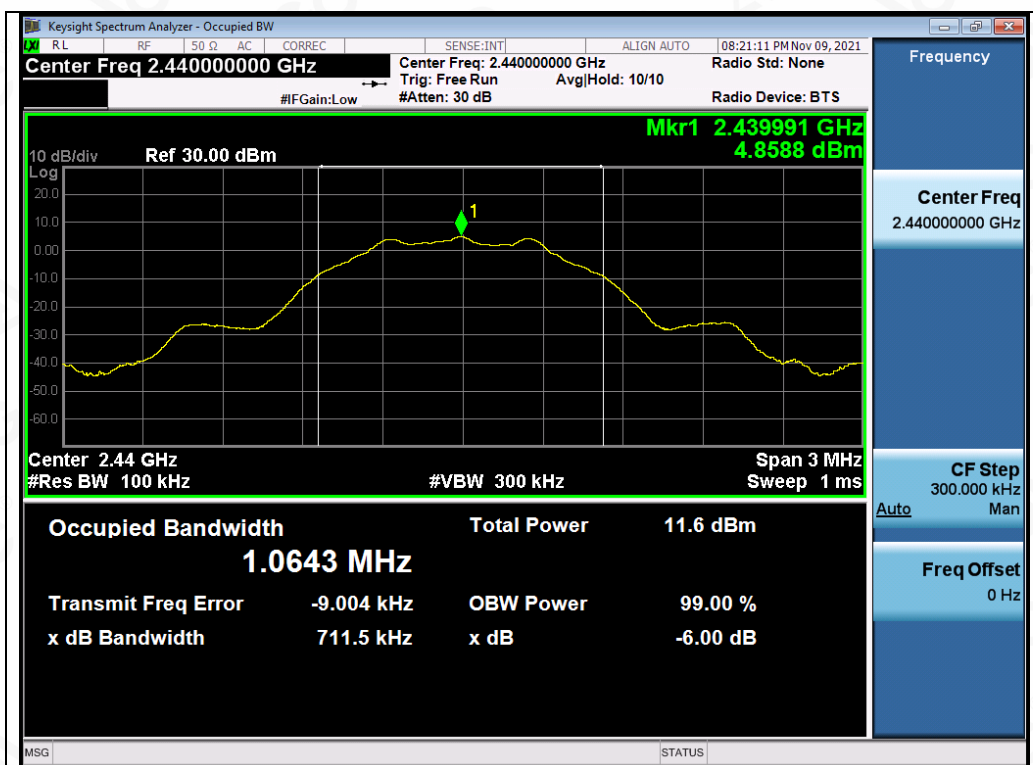
Test Graphs of DTS Bandwidth



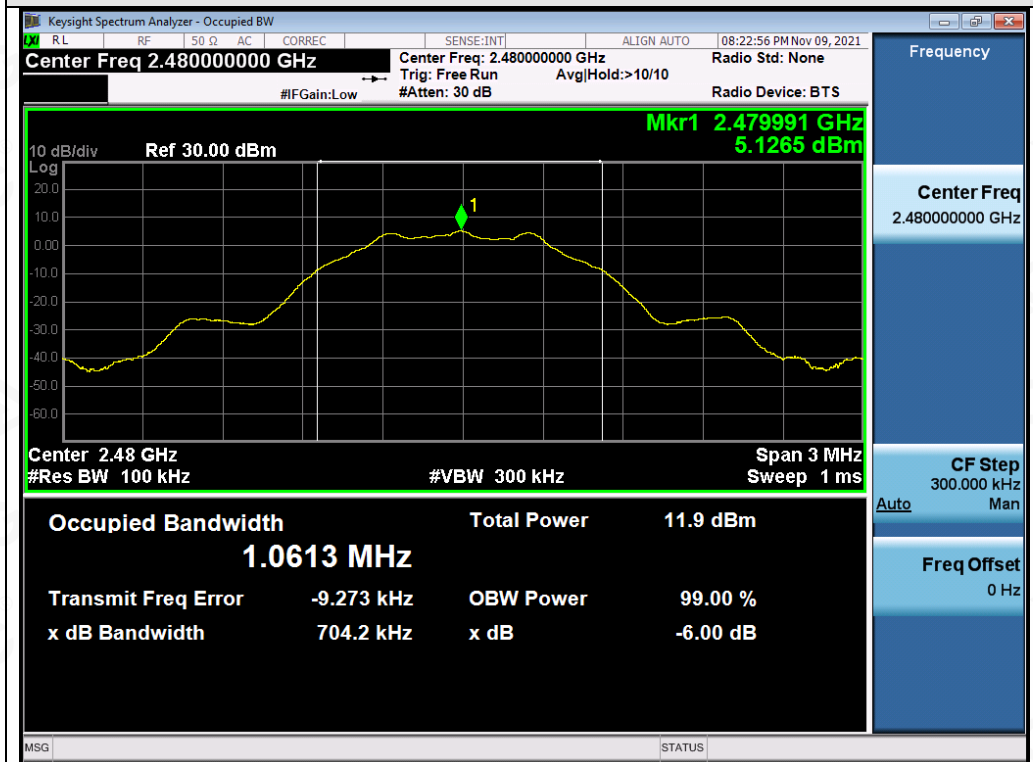

Test_Graph_LE1M_ANT1_2440_1Mbps_DTSBW



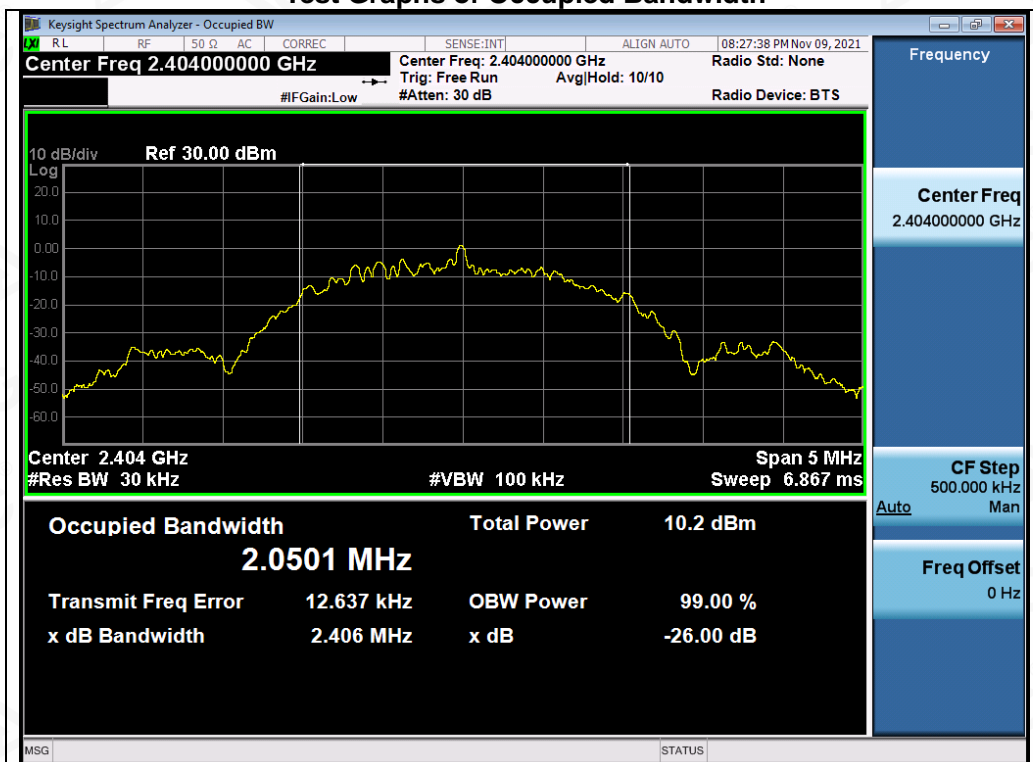

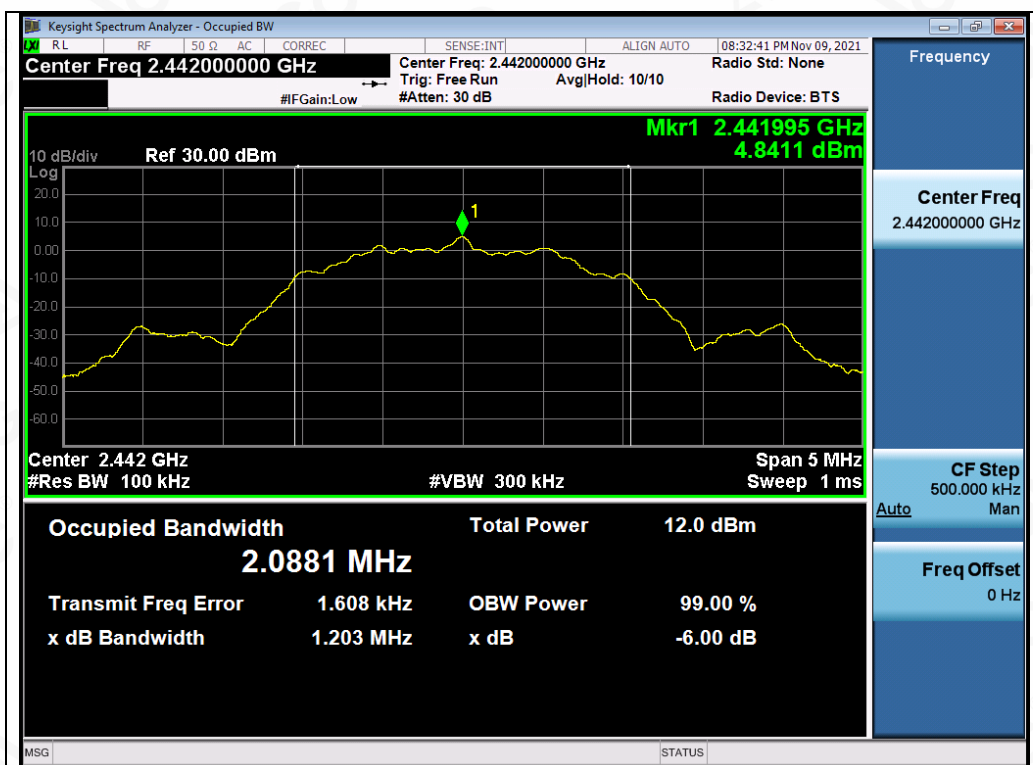
Test Graphs of DTS Bandwidth



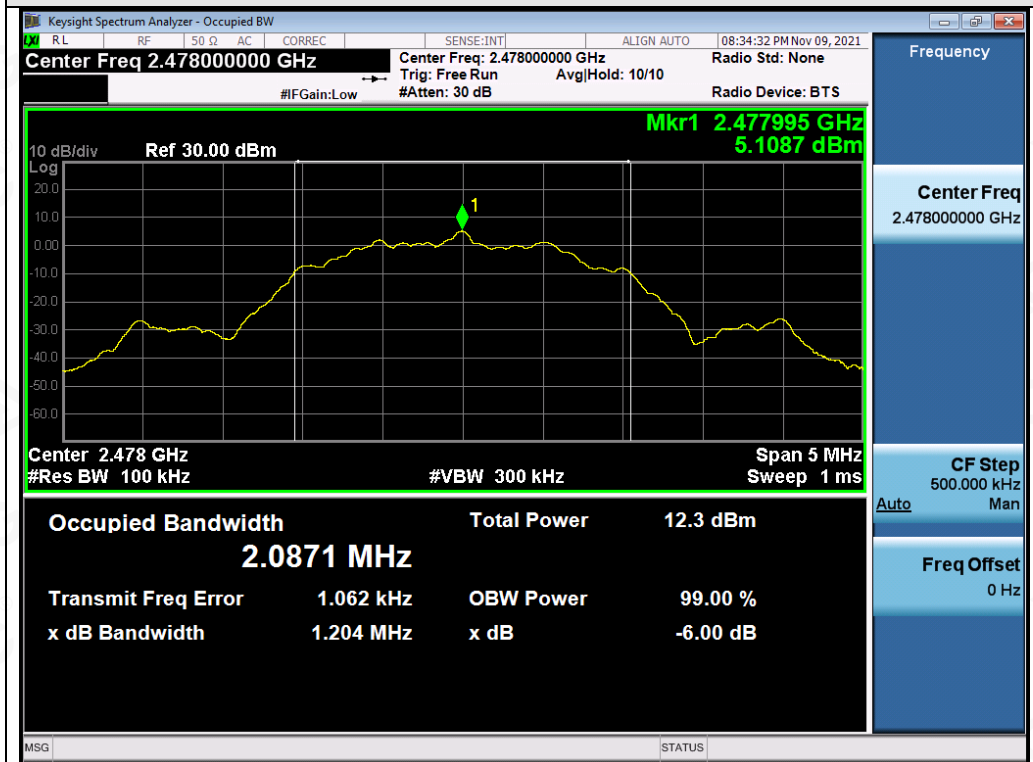

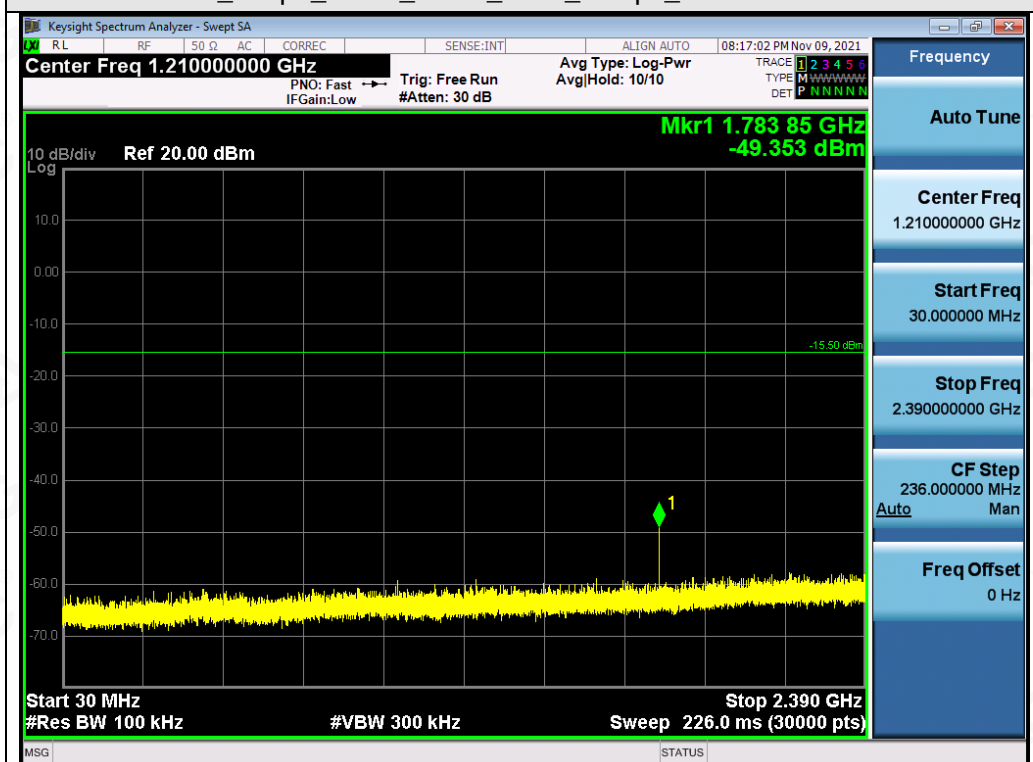

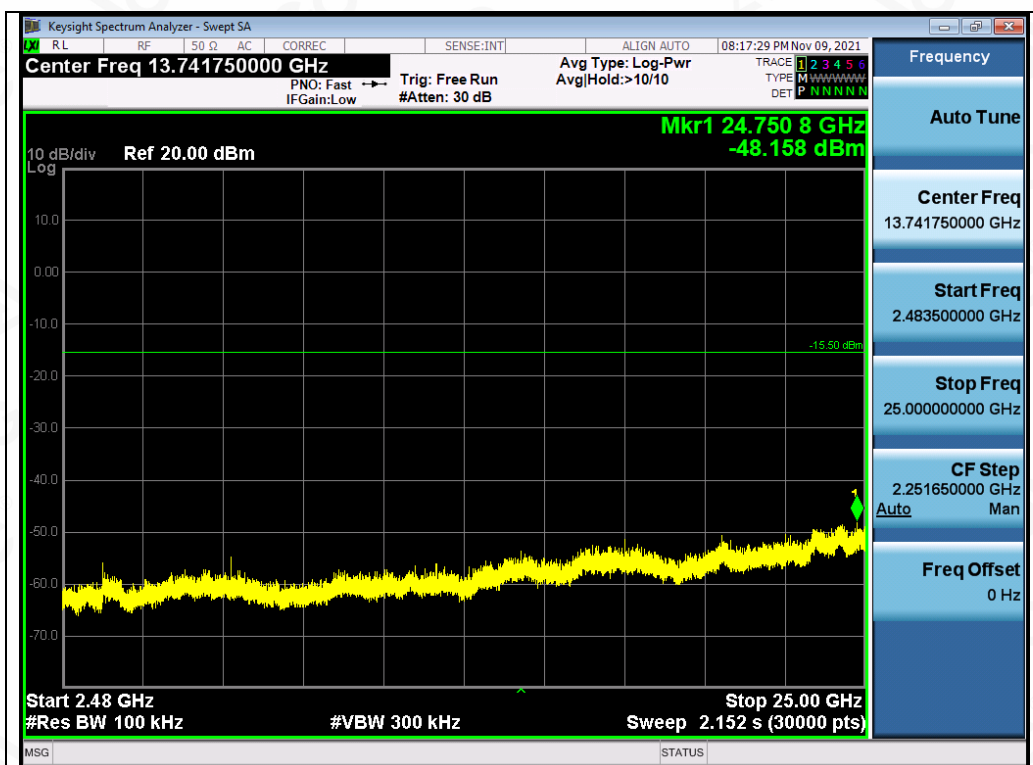

Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions

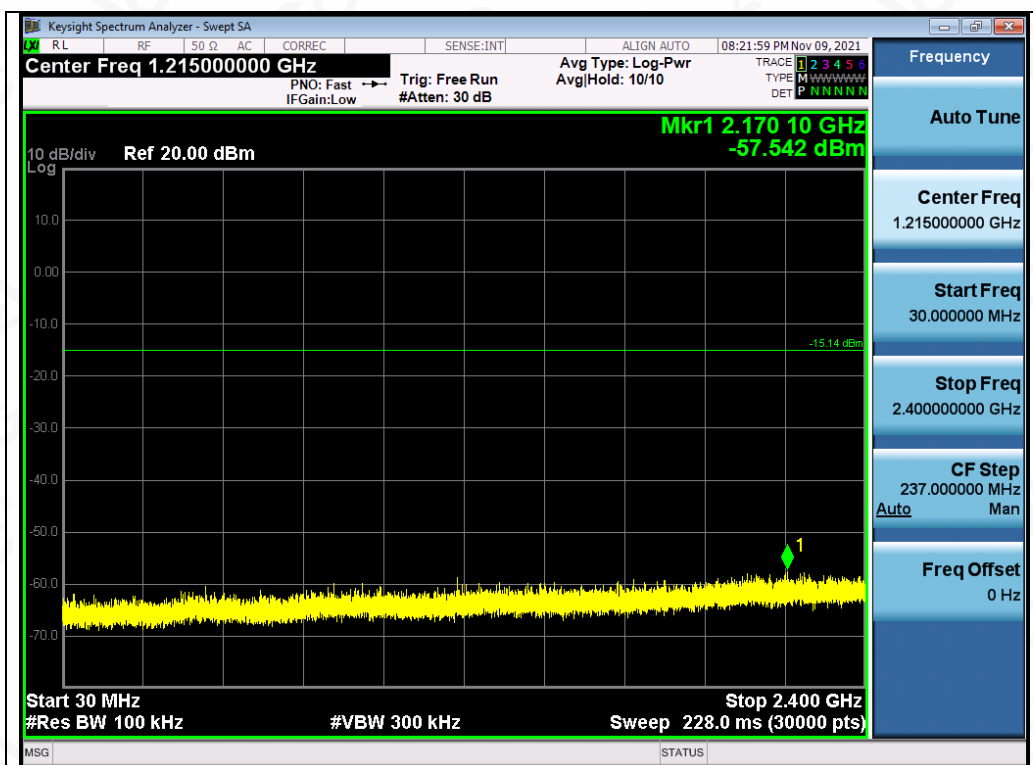

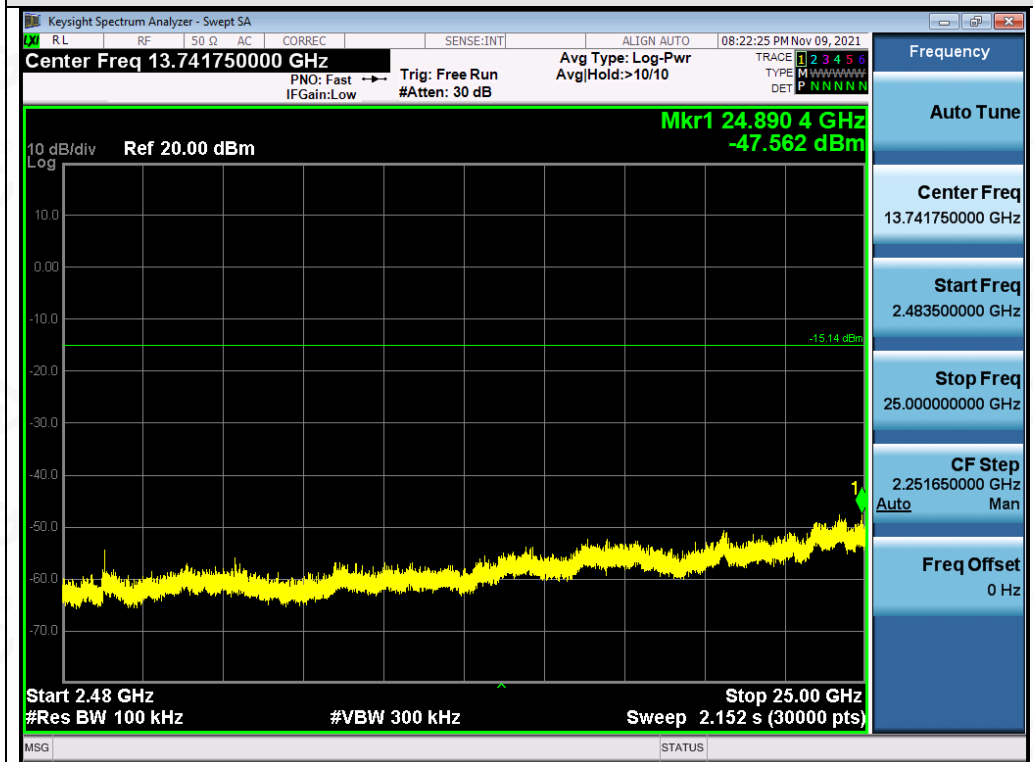

Test_Graph_LE1M_ANT1_2440_1Mbps_Lower Band Emissions

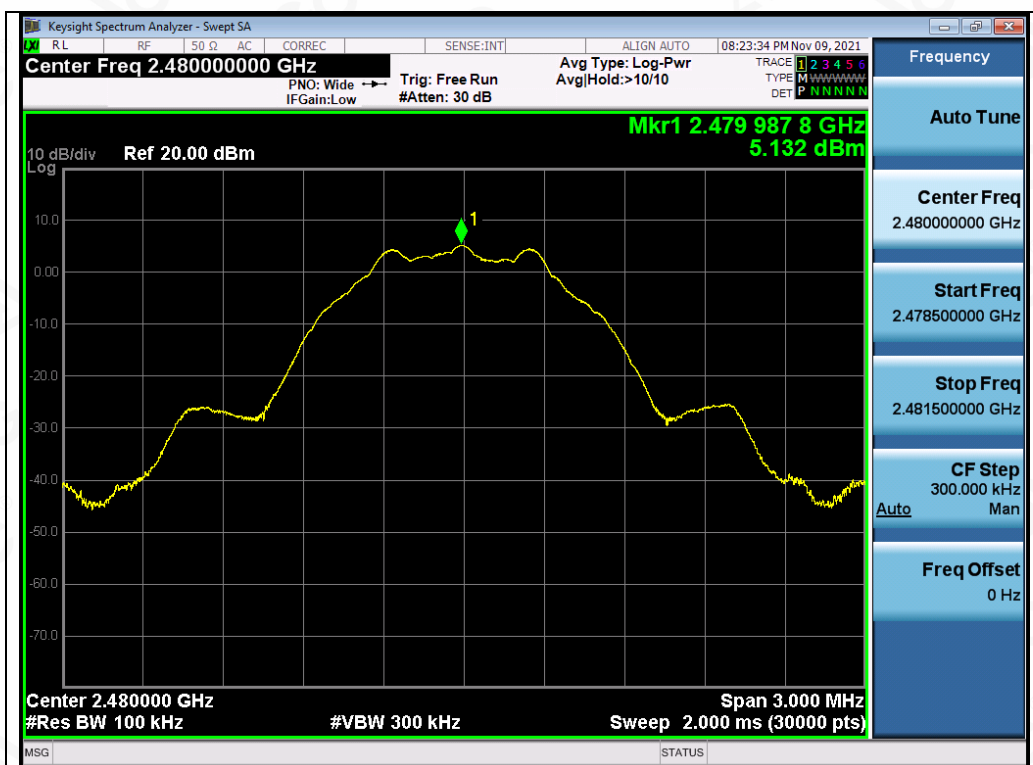

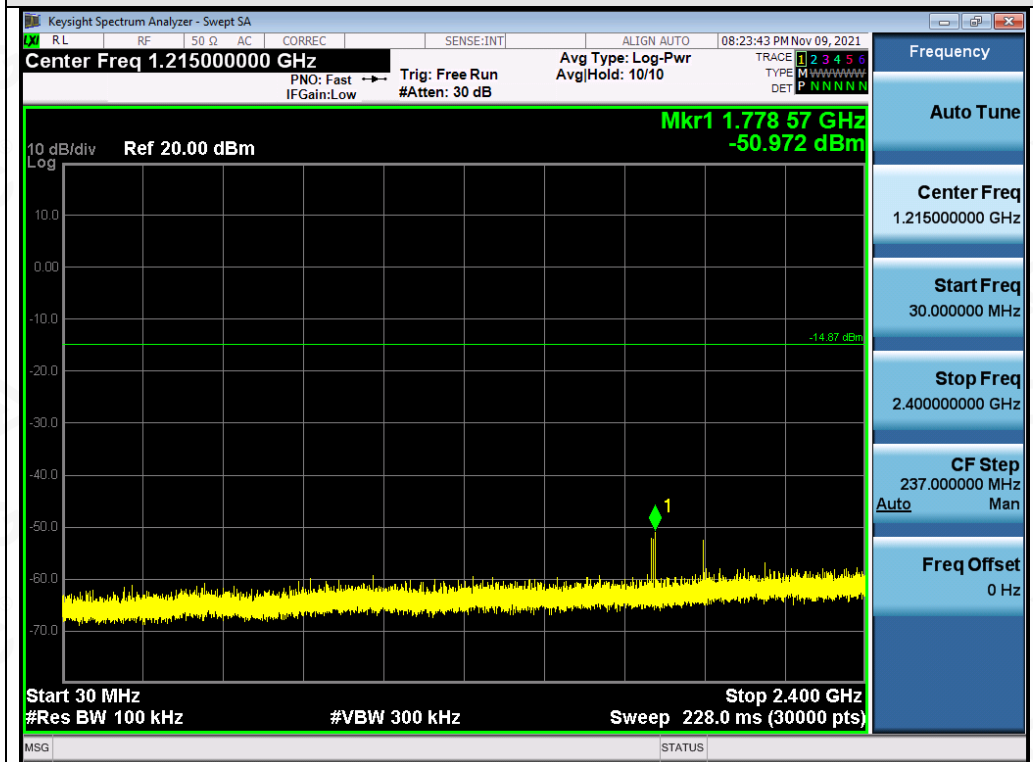

Test_Graph_LE1M_ANT1_2480_1Mbps_Reference Level

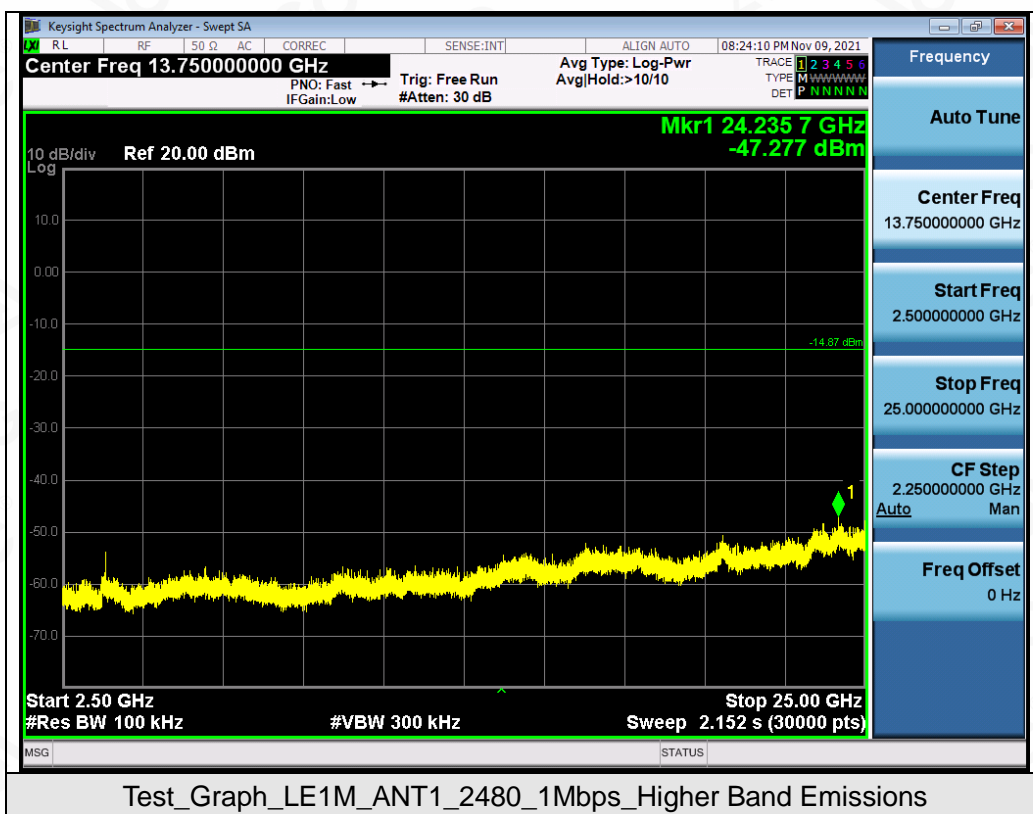

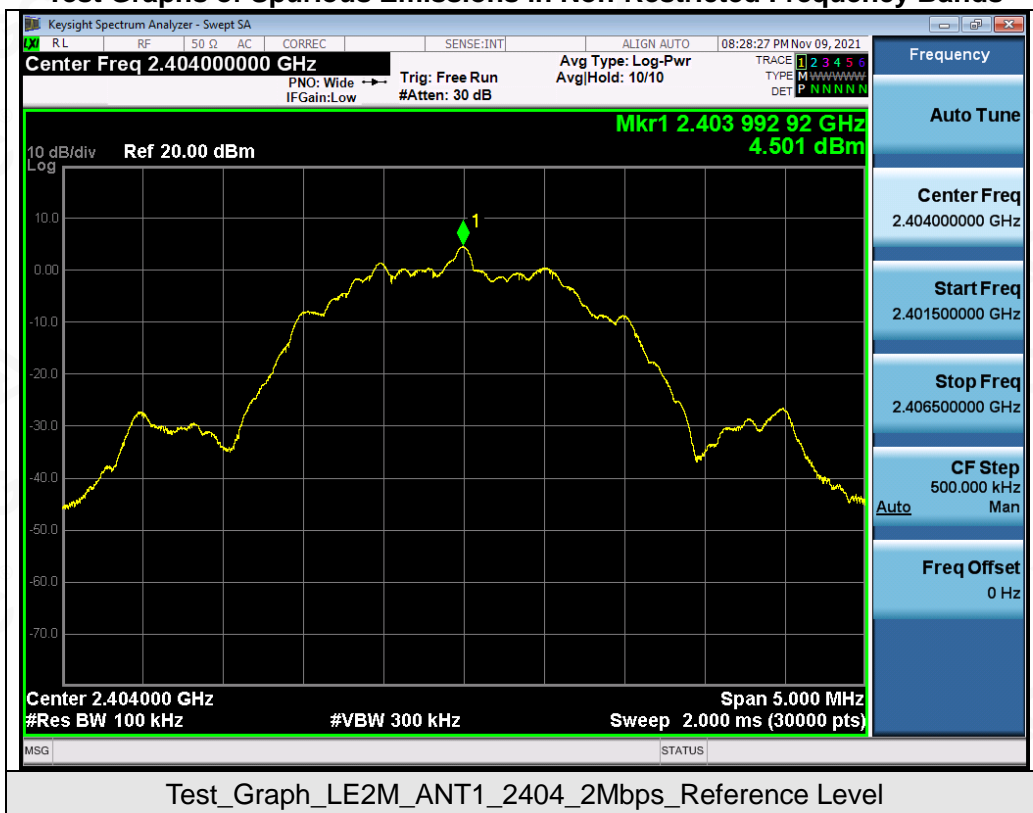

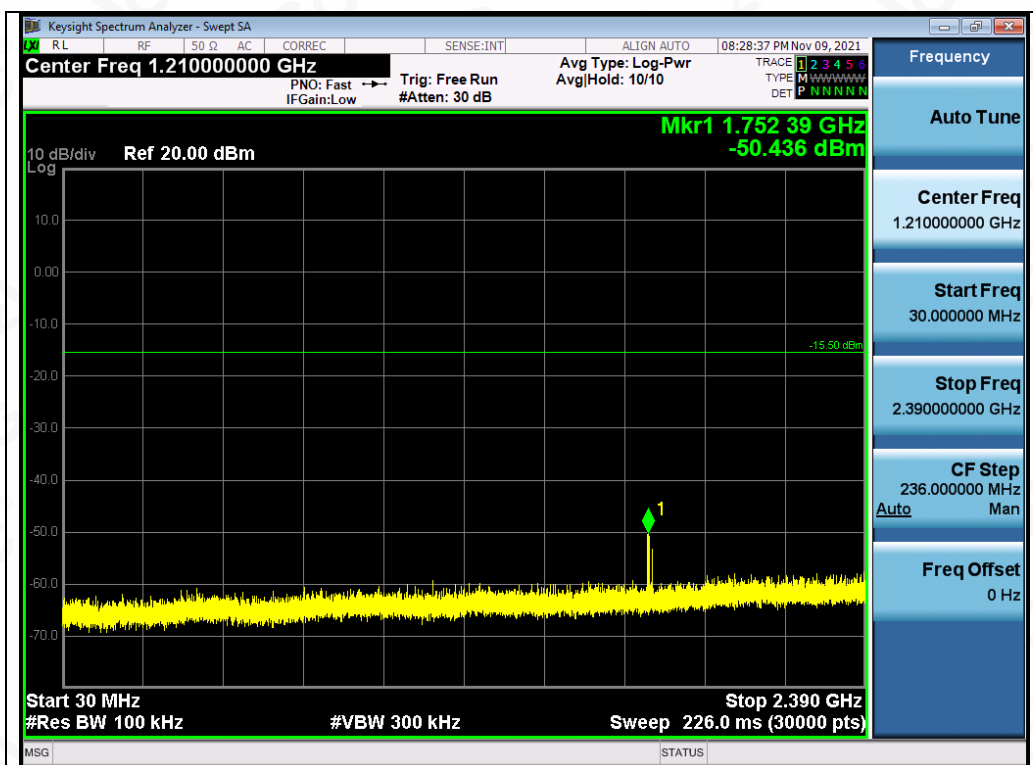
Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands

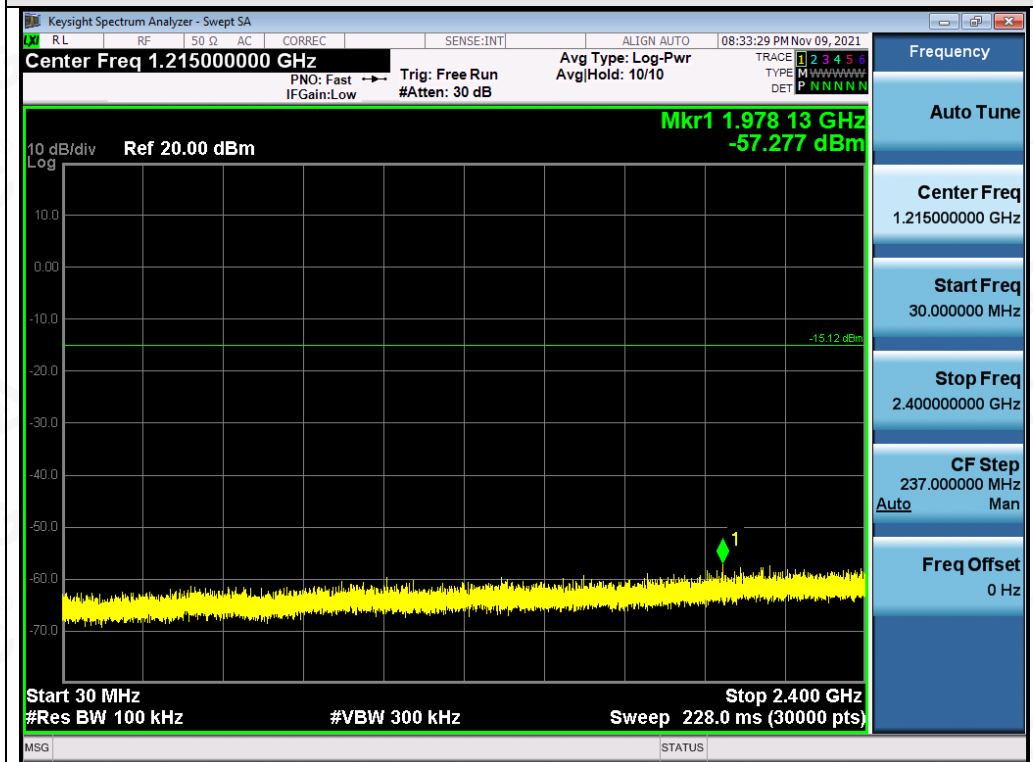

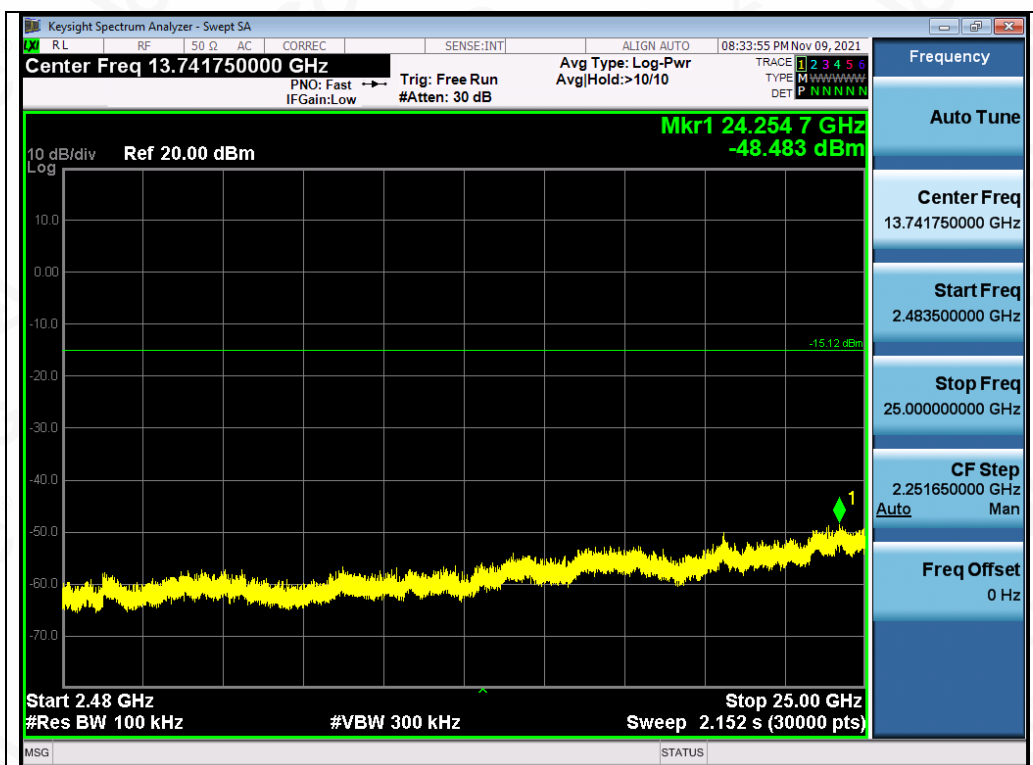

Test_Graph_LE2M_ANT1_2442_2Mbps_Higher Band Emissions

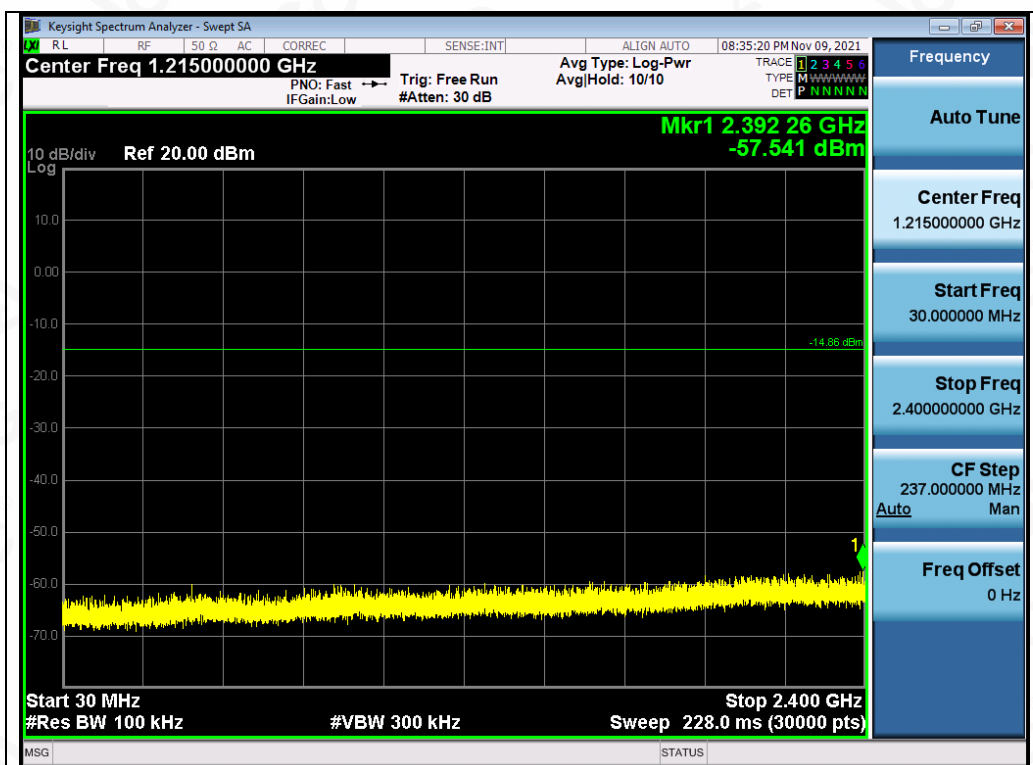

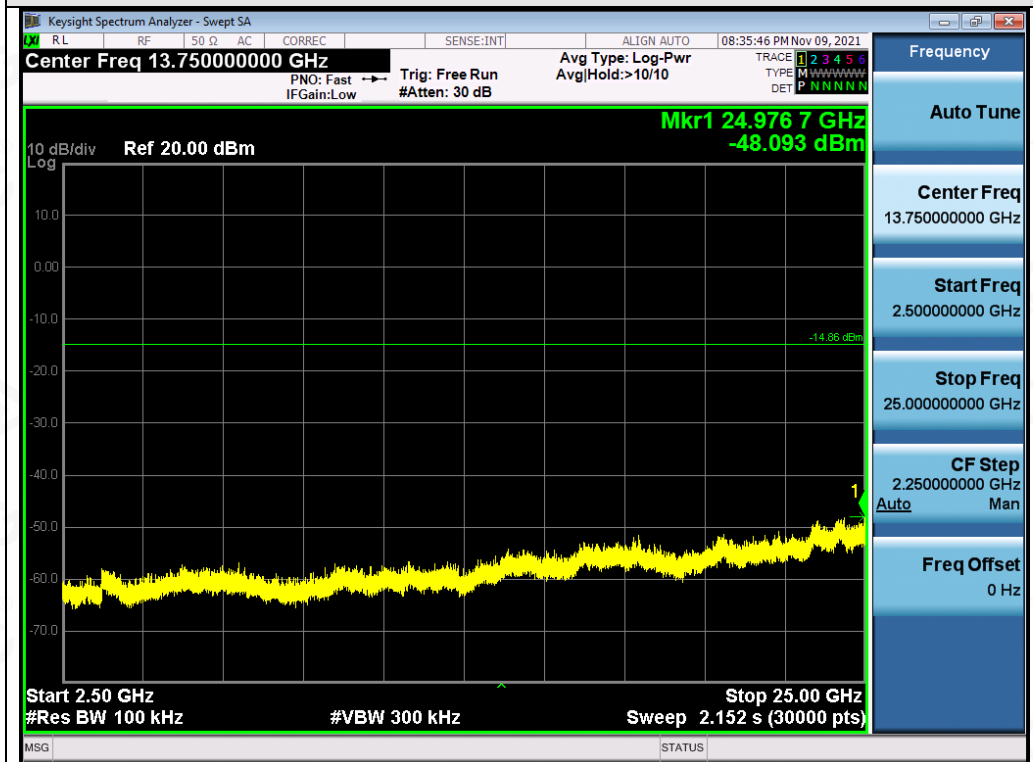

Test_Graph_LE2M_ANT1_2478_2Mbps_Lower Band Emissions



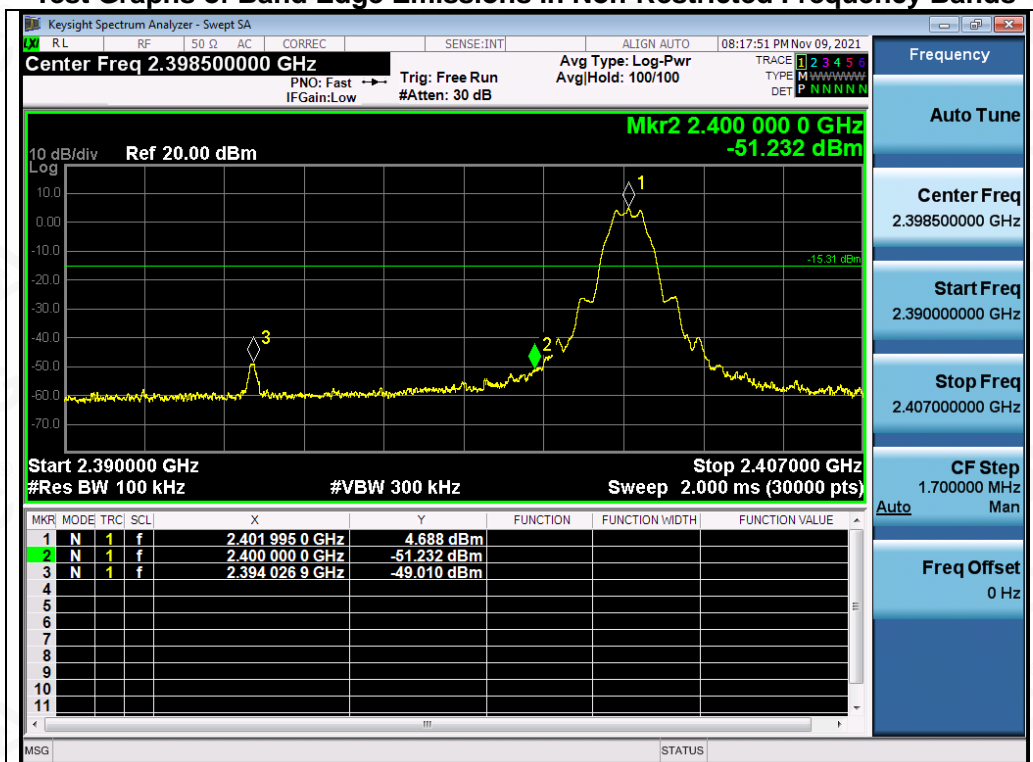

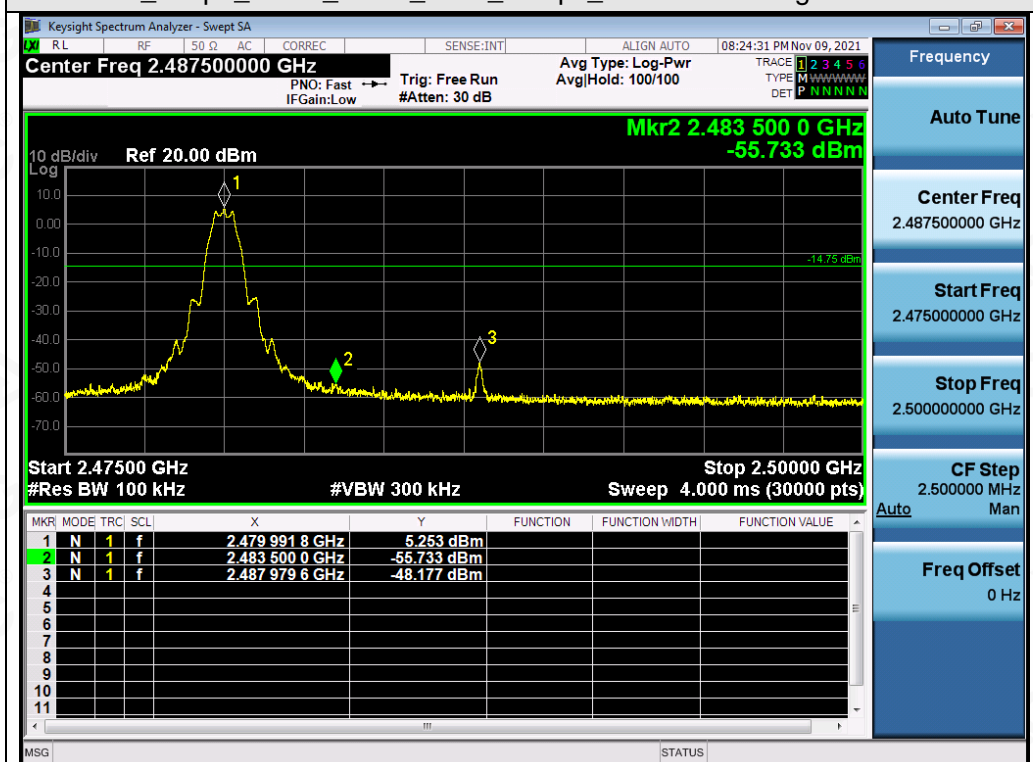

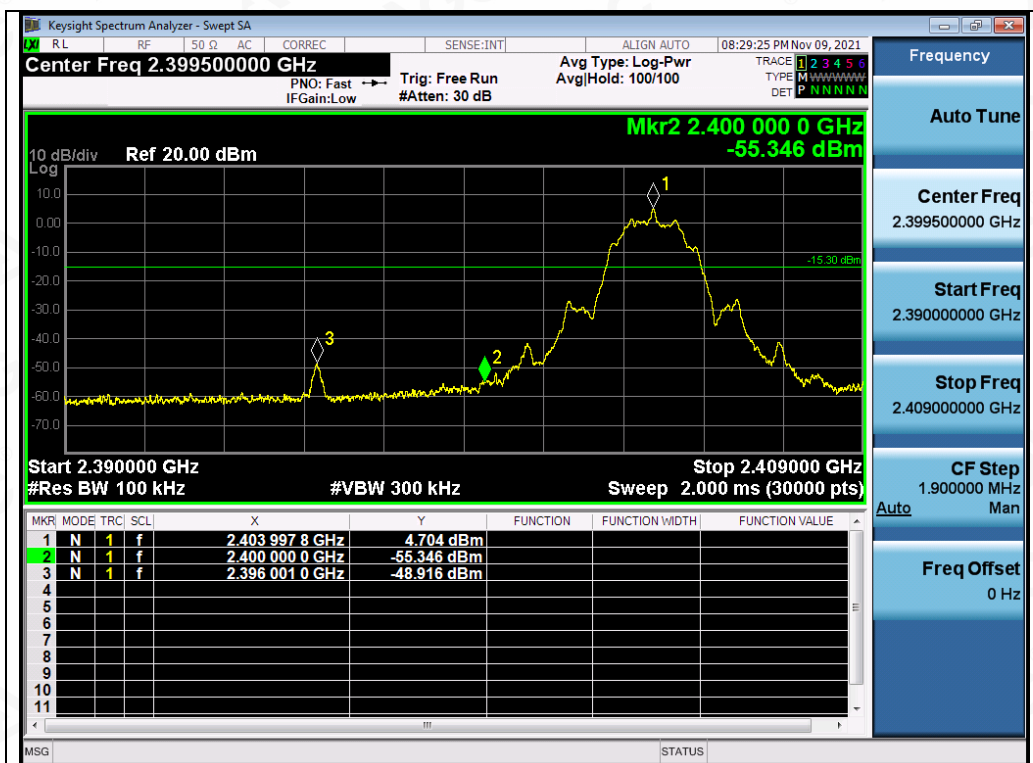

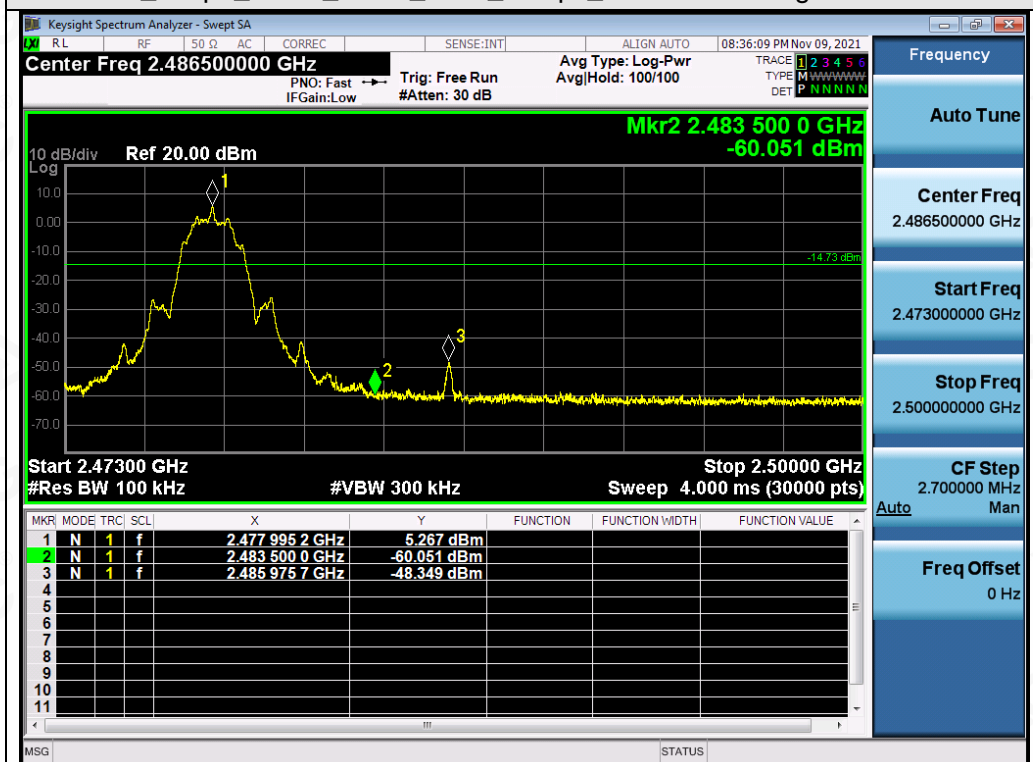
