f = frequency in MHz

Friis transmission formula: $Pd = (Pout*G)/(4*pi*r^2)$

Where

Pd = power density in mW/cm², **Pout** = output power to antenna in mW;

G = gain of antenna in linear scale, **Pi** = 3.1416;

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

If BT and WIFI work simultaneously

BLE+2.4GWIFI, the total power density is 0.00038/1+0.0056/1=0.00598<1.

BLE+5GWIFI, the total power density is 0.00038/1+0.0084/1=0.00878<1.

BLE+5.8GWIFI, the total power density is 0.00038/1+0.0144/1=0.01478<1.

Maximum power density=0.01478 <1. Then SAR evaluation is not require .
