1 For Your Safety

1.1 General Use

The Medio P200u is designed to be reliable and to provide years of trouble-free service. Please observe the following general tips:

- Take care not to scratch the device. Keep the device clean. When working with the device, use only TAGSYS-approved accessories.
- This device is not waterproof and should not be exposed to rain or moisture. Under extreme conditions, water may enter the circuitry.
- Protect the device from extreme temperatures. For example, do not place the device in a windowed area where the sun may cause extreme temperatures, and keep it away from heaters and other heat sources.
- Do not store or use the device in any location that is extremely dusty, damp, or wet.
- Use a soft, damp cloth to clean the device. If the surface of the device becomes soiled, clean it with a soft cloth moistened with a diluted window-cleaning solution.

1.2 Care and Maintenance

This device is a product of superior design and should be handled with care. The suggestions below will further increase the lifetime of this device.

2 Certification

2.1 Occupational Health

TAGSYS Medio P200u Reader has been designed and tested to be in conformity with the European Standard EN 50364 "Limitation of human exposure to electromagnetic fields from devices used in Electronic Article Surveillance (EAS), Radio Frequency Identification (RFID) and similar applications" in conjunction with the European Standard EN 50357 describing how to evaluate the exposure level.

2.2 Regulatory Notices

An RFID system typically composed of an RF emission device such as the Medio P200u connected to an antenna is subject to national regulations that may differ by country.

One important item to consider is the maximum permissible magnetic field intensity at a distance of 10 meters from the antenna that must not exceed 42 dBµA/m in Europe and 38 dBµA/m in US.

The Medio P200u meets these limits.

2.2.1 In Europe (CE and RTTE Directives)

The Medio P200u complies (CE Declaration of Conformity granted) with the European EMC directive.

CAUTION: When using Medio P200u with LSA-4 SHD antenna, one must be sure a ferrite is placed close to power supply jack connector (2 turns as shown below). The ferrite is provided with LSA-4 SHD antenna.





2.2.4 In Canada

To reduce potential radio interference to other users, the antenna type and its gain should be so chosen that the equivalent isotropically radiated power (e.i.r.p) is no more than that permitted for successful communication.

This device has been designed to operate with the antennas listed below, and having a maximum gain of -35 dBi. Antenna not included in this list or having a gain greater than -35 dBi are striclly prohibited for use with this device. The require antenna impedance is 50 ohms.

LW-1, Aero LI, LSA-3, LSA-4 and LSA-4 SHD antennas meet this requirement with a gain less than -35dBi.

3 Introduction

3.1 Product Description

The Medio P200u has been designed to be used in combination with Aero LI, LSA-3, LSA-4, LSA-4 SHD and LW-1 antennas. The Medio P200u can decode C210, C240, C270, C370, C370L, C370S and ISO15693 tags.

Due to its small size, the Medio P200u can be used either in desktop configuration or easily integrated in self check stations.

The Medio P200u Tag readers are easy to integrate because of its:

- small size
- USB 1.1 communication link

4 Installing the Reader

This section explains how best to install the Medio P200u Mid Range Reader.

4.1 Reader Connections

4.1.1 Front Panel

Figure 1 below shows the front panel, which is dedicated to the RF connection. Any of the following antennas can be connected to the standard SMA connector:

- LW-1
- Aero LI
- L-SA3
- L-SA4
- L-SA4 SHD

The red LED turns on when the reader is supplied.

4.1.2 Rear Panel

The USB serial communication link and the power supply connector are located on the rear panel as shown below.

4.2 Installing the USB Drivers

At first connection to the PC USB port, Windows® will detect the TAGSYS Medio P200u reader and will ask to install a driver. The USB drivers are located into the USB Drivers folder on the product CD-ROM.

Two drivers will be installed:

- The USB device driver.
- The virtual COM port (VCP) driver. The VCP driver emulates a standard PC COM port.

After installation of the drivers, power up and connect your Medio P200u to a spare USB port on your PC to launch the Windows Found New hardware Wizard

- Select "No, not this time" and click next to proceed with the installation.
- Select "Install from a list or specific location (Advanced)" and then click "Next".
- Select "Search for the best driver in these locations" and click the Browse button to select the TAGSYS USB Drivers folder on the Product CR-Rom. Then click "Next" to proceed.
- Windows should then display a message indicating that the installation was successful.
 Click Finish to complete the installation.

Repeat the procedure above when Windows® asks for drivers again (virtual com port).

To confirm that the installation has completed successfully, open the Device Manager and select "View > Devices by type". The TAGSYS Medio P200u reader now appears as an additional COM port.



Drivers for Windows 98 are not provided. They are available upon request (please contact TAGSYS).



5 Px Explorer

The Medio P200u reader is delivered with the Px Explorer software tool intended to easily setup the reader, test it and perform reading and writing operations according to the antenna and type of tag to be used. In addition, Px Explorer can display additional information such as the Product Reference and Firmware version and revision. This section describes how to start with Px Explorer.


5.1 Installing Px Explorer

To install Px Explorer software, insert the product CD-ROM into the disk drive on your PC and run the Setup from the Software\Px Explorer folder and click "Next"



Click the "Browse" button if you want to choose a specific installation folder.





Once the correct folder is selected, click "Next"




Click "Next" to start the installation process. A shortcut will be created on your desktop and a program group will be created in the start menu.




5.2 Running Px Explorer

Before launching Px Explorer be sure which COM port number is assigned to the TAGSYS Medio P200u reader. Open the Device Manager and select "View > Devices by type".

Power up the Medio P200u and connect the USB cable to both your PC and the Medio P200u. Run Px Explorer. If the following window is displayed click yes.



Open the Communication Settings window (CTRL+C) and check the COM port number and the communication speed. The default communication speed for the Medio P200u is 115200 Bauds.



Click OK. Now Px Explorer is ready to communicate with your Medio P200u.

5.3 Reading and Writing a Tag

Px Explorer includes a Wizard function used to guide you each step of how to read or program a tag. We recommend using the Wizard function for users who are not familiar with all Px Explorer capabilities and features.

Click on the Wizard icon (magic wand) to open the Px Explorer Wizard dialog box.



Select the type of chip from the drop—down menu or place the tag on the antenna and click the "Detect " button to automatically detect the tag type.

Select the desired operation (Read or Write) and then click OK. All the necessary windows to perform the desired action will be automatically displayed on the screen.

For more details concerning Px Explorer select the info menu and click Help (CTRL+H) to display the Px Explorer User's Guide







In any event, TAGSYS warranty is strictly limited to (at TAGSYS' sole option) the replacement or refund of the Products purchase price to TAGSYS, of Products considered as defective by TAGSYS.

The remedy provided above is in lieu and to the exclusion of all other remedies, obligations or liabilities on the part of TAGSYS for damages, whether in contract, tort or otherwise, and including but not limited to, damages for any defects in the Products or for any injury, damage, or loss resulting from such defects or from any work done in connection therewith or for consequential loss, whether based upon lost goodwill, lost resale profits, impairment of other goods or arising from claims by third parties or otherwise.

TAGSYS disclaims any explicit warranty not provided herein and any implied warranty, guaranty or representation as to performance, quality and absence of hidden defects, and any remedy for breach of contract, which but for this provision, might arise by implication, operation of law, custom of trade or course of dealing, including implied warranties of merchantability and fitness for a particular purpose.

8.2.2 How to Return Defective Products

The Buyer shall notify TAGSYS of the defects within 15 working days after the defects are discovered.

Defective Products must be returned to TAGSYS after assignment by a TAGSYS Quality Department representative of an RMA (Return Material Authorization) number. No Products shall be returned without their proof of purchase and without the acceptance number relating to the return procedure.

All Products shall be returned with a report from the Buyer stating the complete details of the alleged defect.

If returned Products prove to be non-defective, a charge will be applied to cover TAGSYS' analysis cost and shipping costs.

If the warranty does not apply for returned Products (due to age, or application of a warranty exclusion clause), a quote for replacement will be issued, and no replacement will be granted until a valid purchase order is received. If no purchase order is received within 30 days after the date of TAGSYS quote, TAGSYS will return the products and charge the analysis cost and shipping costs.

All replaced Products shall become the property of TAGSYS.
