### User Instructions and Intended Use

#### Operation

During the normal vehicle operation, Keyless Ignition Node (KIN) only provides the vehicle power mode control pushbutton function and the vehicle power status indication. However, when the key fob battery energy is exhausted and Passive Entry / Keyless Go (PEKG) function cannot be performed between the key fob and the RF Hub Module (RFHM), KIN will perform the vehicle immobilizer function with a key fob using a close-proximity 125 kHz LF transponder as the KIN pushbutton is pressed to start the engine.

The key fobs must be programmed (mated) with the vehicle to become the valid key.

Only valid keys can start up the vehicle.

With a valid key, the vehicle electrical system can be put into Off, Accessory, Run/Start mode with the specific manner the pushbutton and brake pedal are operated.

#### Note

Always keep a replacement key fob in case one is lost. If any key fobs for your vehicle are lost, take your vehicle to an authorized Chrysler dealership to remove the lost key fobs from the vehicle programming so that the lost key fob cannot be used to operate your vehicle by another unauthorized vehicle operator. Also, only authorized Chrysler dealerships can program replacement key fobs to your vehicle using a special tool.

#### Maintenance

Chrysler cannot guarantee the proper system operation if the system has been modified or if any third-party equipment has been installed on the vehicle. If you have a problem with the vehicle immobilizer system or the key fobs, consult an authorized Chrysler dealership.

### Instruções do Usuário e Uso Pretendido

#### Operação

Durante a operação normal do veículo, o Nó de Ignição Sem Chave (KIN) fornece apenas a função de botão de controle do modo de energia do veículo e a indicação do status de energia do veículo. No entanto, quando a energia da bateria do chaveiro estiver esgotada e a função Passive Entry / Keyless Go (PEKG) não puder ser executada entre o chaveiro e o RF Hub Module (RFHM), o KIN executará a função de imobilizador do veículo com um chaveiro usando um transponder LF de 125 kHz de proximidade à medida que o botão KIN é pressionado para ligar o motor.

Os chaveiros devem ser programados (acasalados) com o veículo para se tornarem a chave válida.

Apenas chaves válidas podem ligar o veículo.

Com uma chave válida, o sistema elétrico do veículo pode ser colocado em Desligado, Acessório, Modo Run/Start com a maneira específica como o botão e o pedal do freio são operados.

#### Nota

Mantenha sempre um chaveiro de substituição no caso de um ser perdido. Se algum chaveiro do seu veículo for perdido, leve o seu veículo a uma concessionária autorizada da Chrysler para remover os chaveiros perdidos da programação do veículo, de modo que o chaveiro perdido não possa ser usado para operar o seu veículo por outro operador de veículo não autorizado. Além disso, apenas autorizado

As concessionárias Chrysler podem programar chaveiros de substituição para o seu veículo usando uma ferramenta especial.

#### Manutenção

A Chrysler não pode garantir o funcionamento adequado do sistema se o sistema tiver sido modificado ou se algum equipamento de terceiros tiver sido instalado no veículo.
