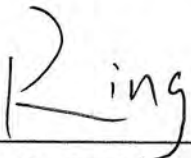
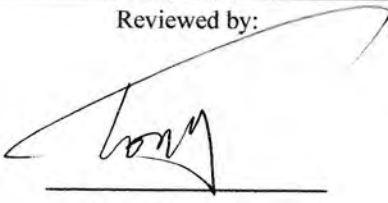

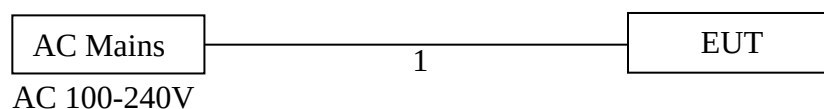

Combining all the rates, modulations, and packet types, the Pre-scans had been carried out. The worst case test mode was selected for the final test as listed below.

### 3. MAXIMUM PEAK OUTPUT POWER

#### 3.1. Limit

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

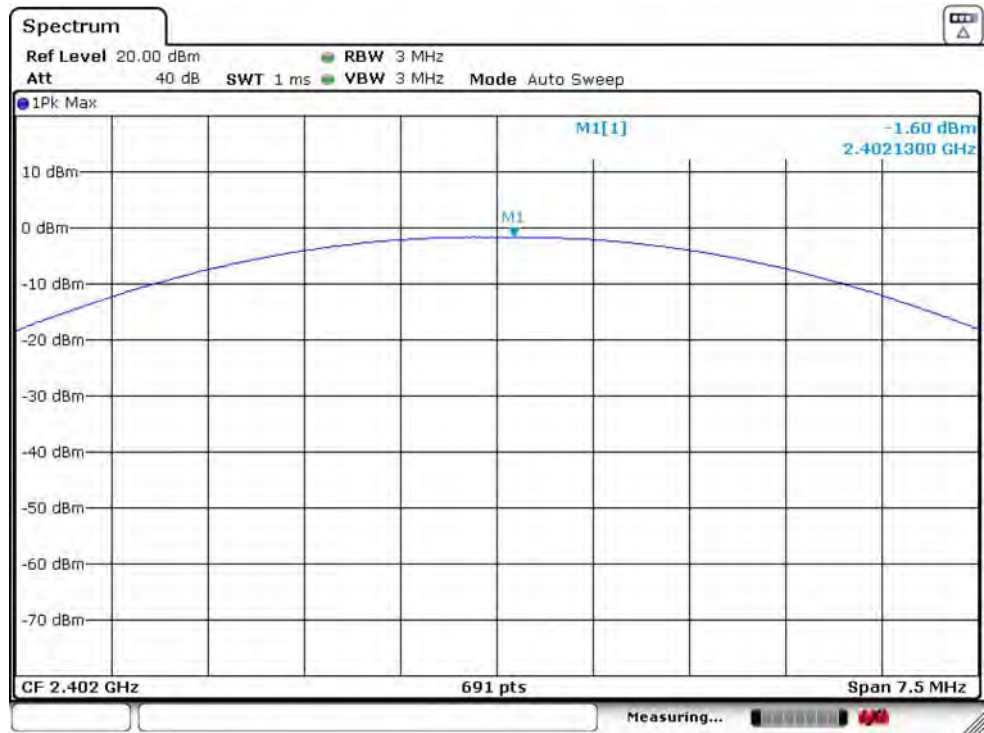
#### 3.4. Test Procedure

- Connect EUT antenna terminal to the spectrum analyzer with RF cable.
- Spectrum analyzer setting parameters in accordance with section 3.3.
- Set the EUT transmit continuously with maximum output power over fixed single hopping channel.
- Allow trace to stabilize, use the marker-to-peak function to set the marker to the peak of the emission.
- Repeat above procedures until all channels and test modes were measured.
- Record the results in the test report.

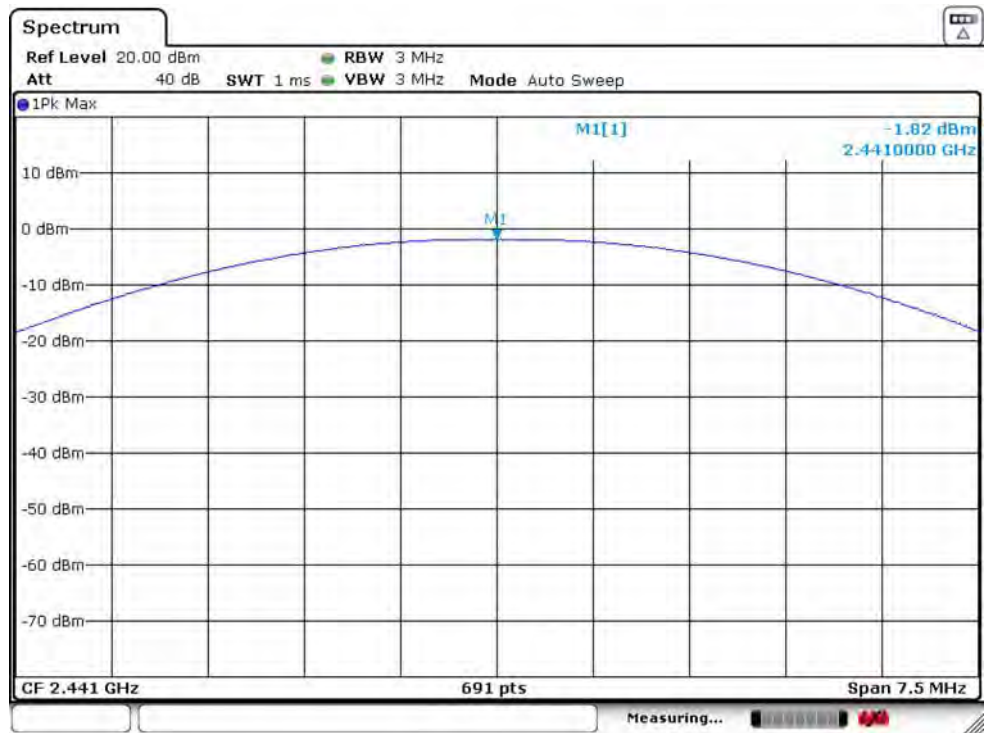

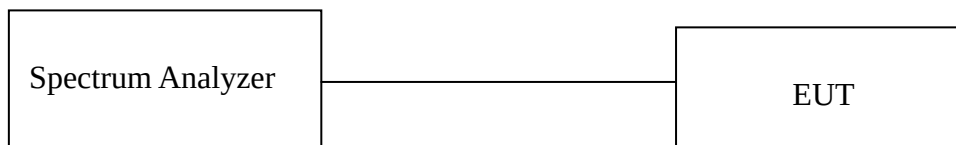


## 4. 20 DB BANDWIDTH

### 4.1. Limit

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. 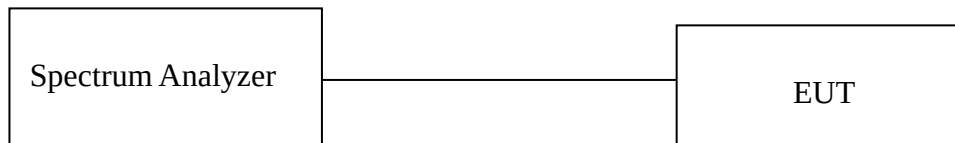


## 5. CARRIER FREQUENCY SEPARATION

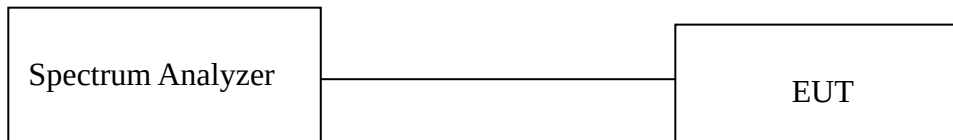


## 8. CONDUCTED BAND EDGE

### 8.1. Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

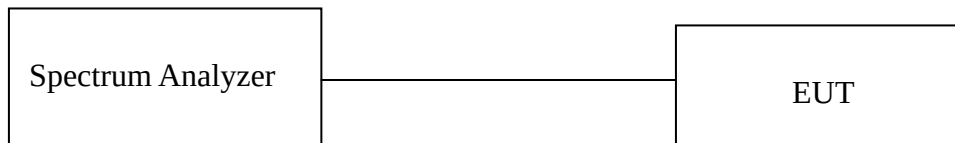


## 9. CONDUCTED SPURIOUS EMISSIONS

### 9.1. Limit

- e. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.
- f. Spectrum analyzer setting parameters in accordance with section 10.3.
- g. Repeat above procedures until all channels and test modes were measured.
- h. Record the results in the test report.

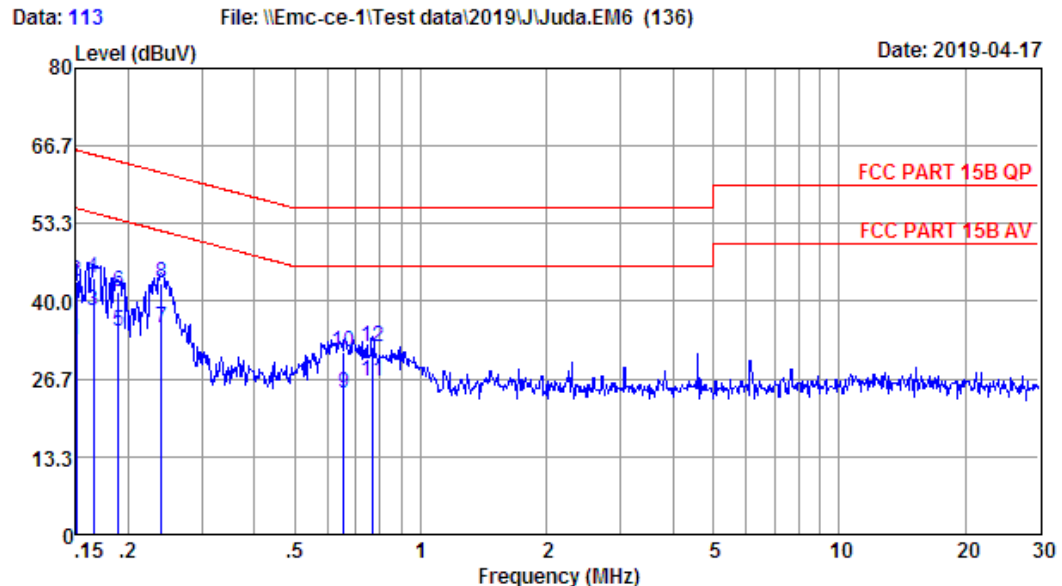
### 11.4. Test Procedure

- a. The EUT was placed on a non-metallic table, 80cm above the ground plane.
- b. The EUT Power connected to the power mains through a line impedance stabilization network.
- c. This provides a 50 ohm coupling impedance for the EUT (Please refer the block diagram of the test setup and photographs).
- d. Set the EUT transmit continuously with maximum output power.
- e. Spectrum analyzer setting parameters in accordance with section 11.3.
- f. The AC line are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10: 2013 on Conducted Emission Test.
- g. Record the results in the test report.

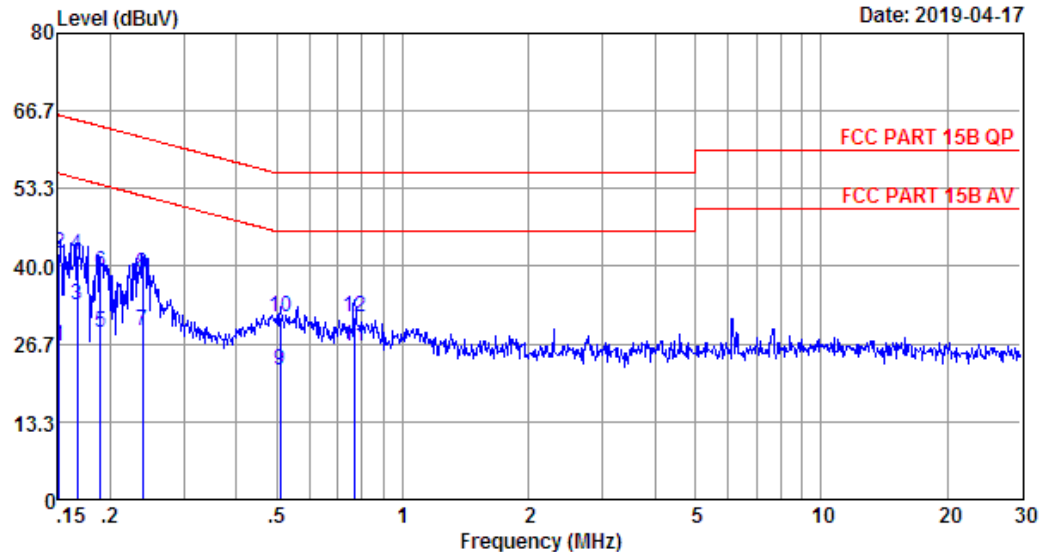

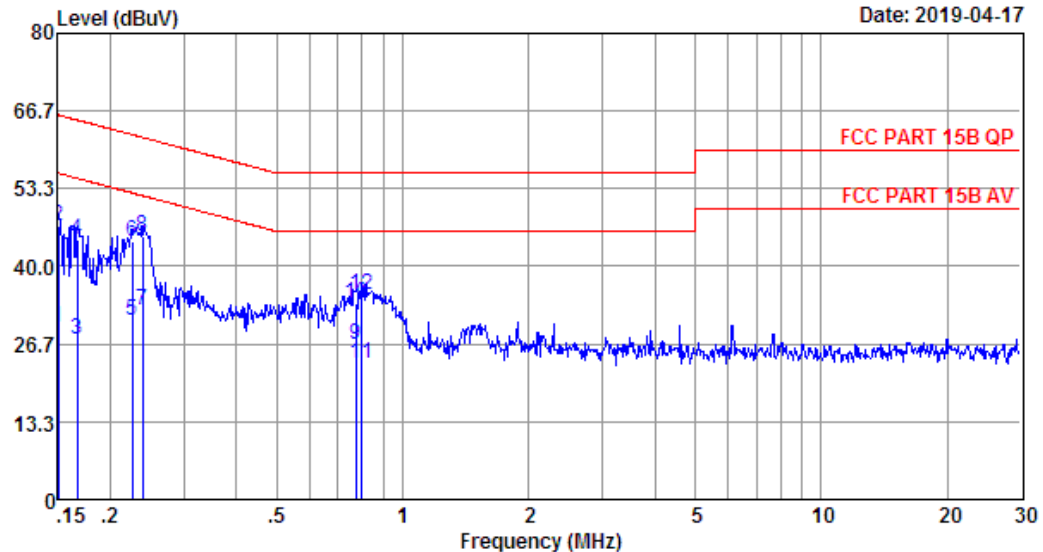

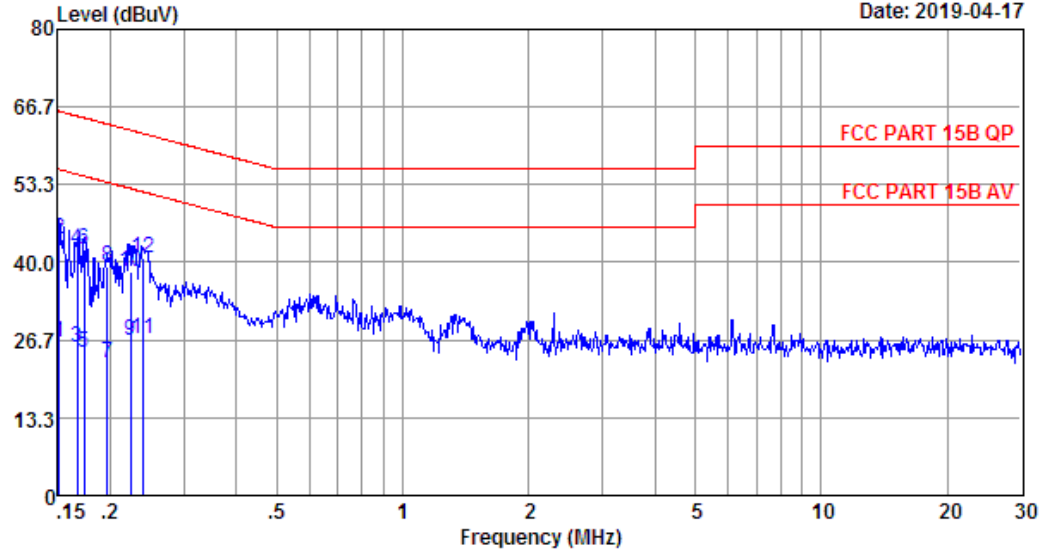

## 12. ANTENNA REQUIREMENTS

### 12.1. Limit

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §§15.211, 15.213, 15.217, 15.219, 15.221, or §15.236. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.
