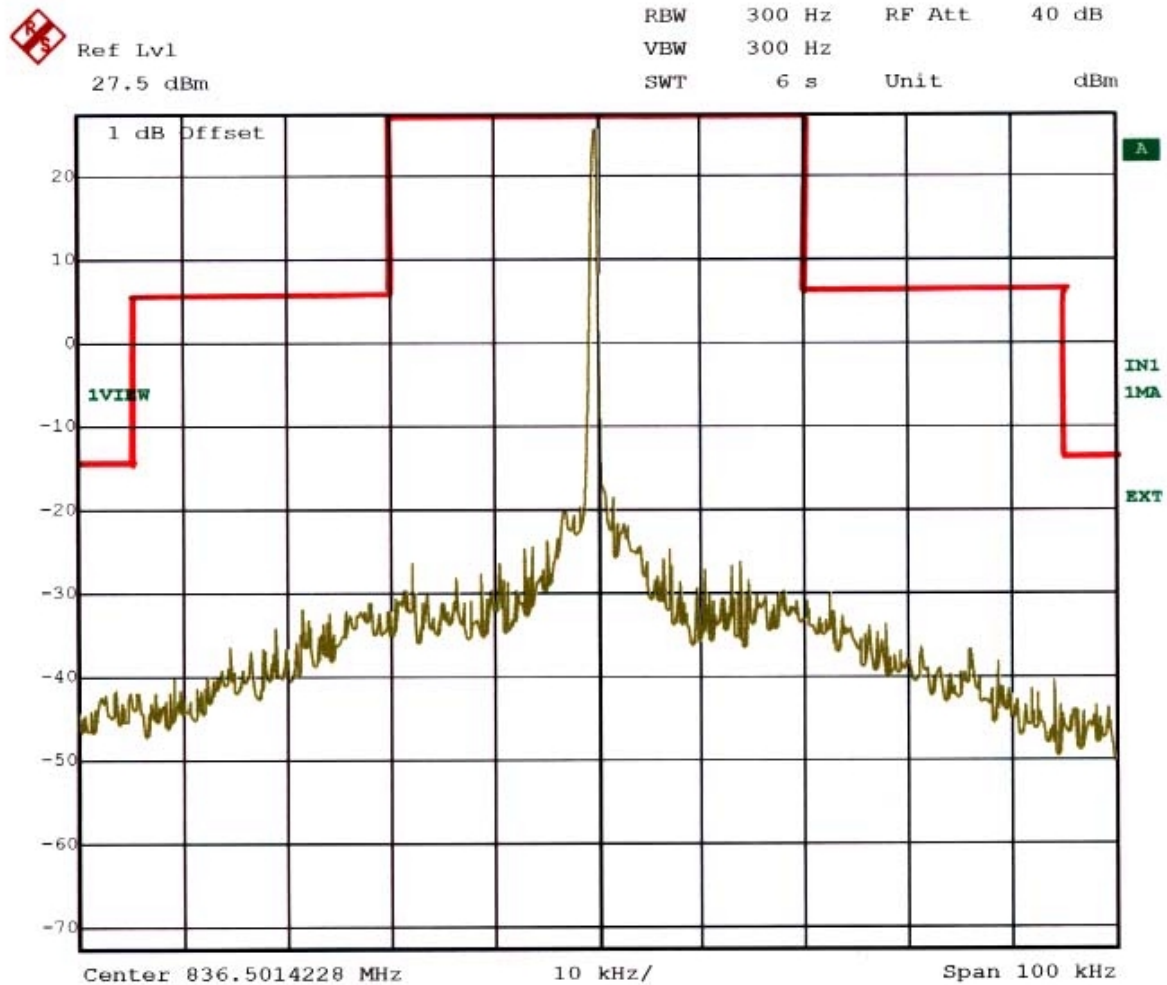

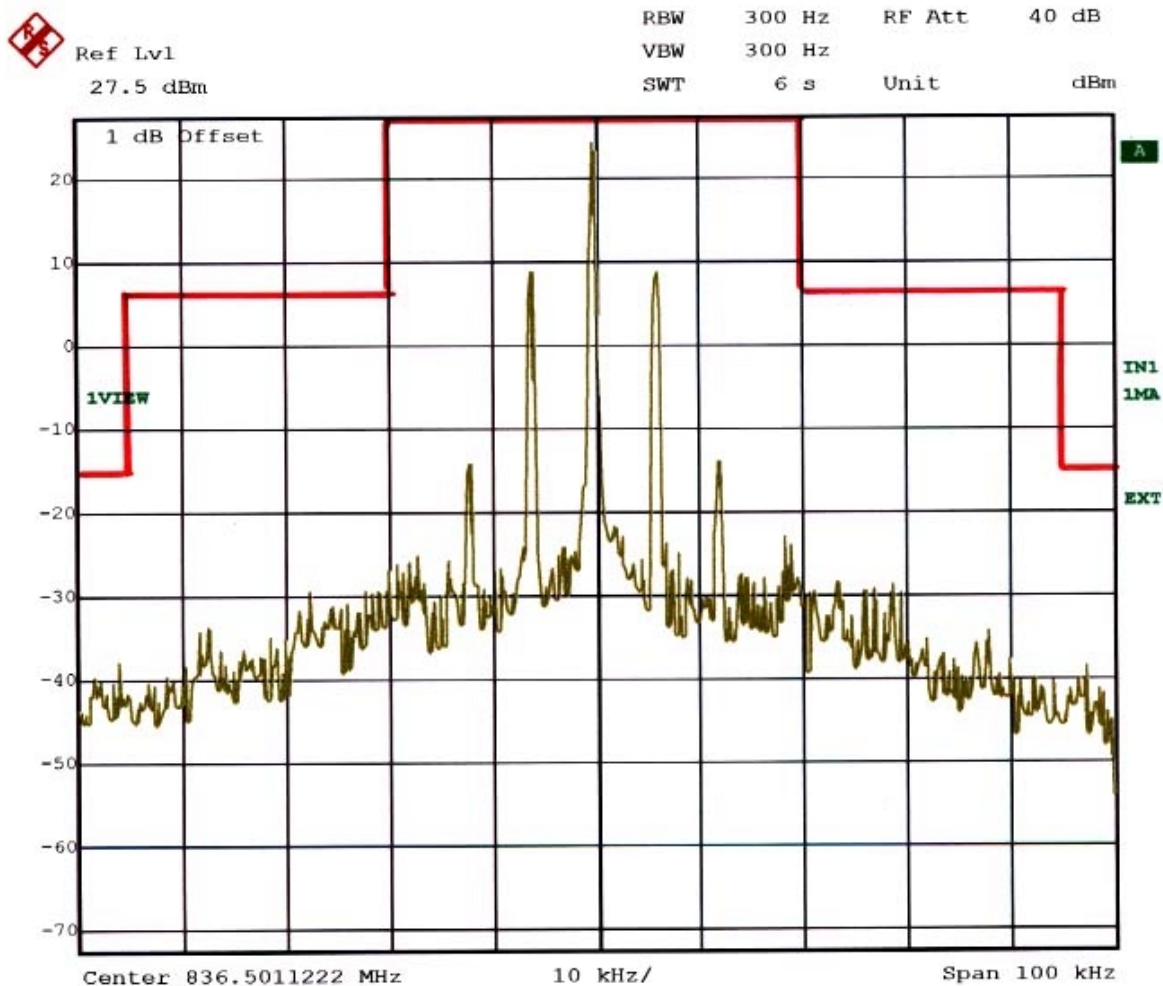
€ AMPS MODE (0383 CH.) Test Mode: Unmodulated Signal

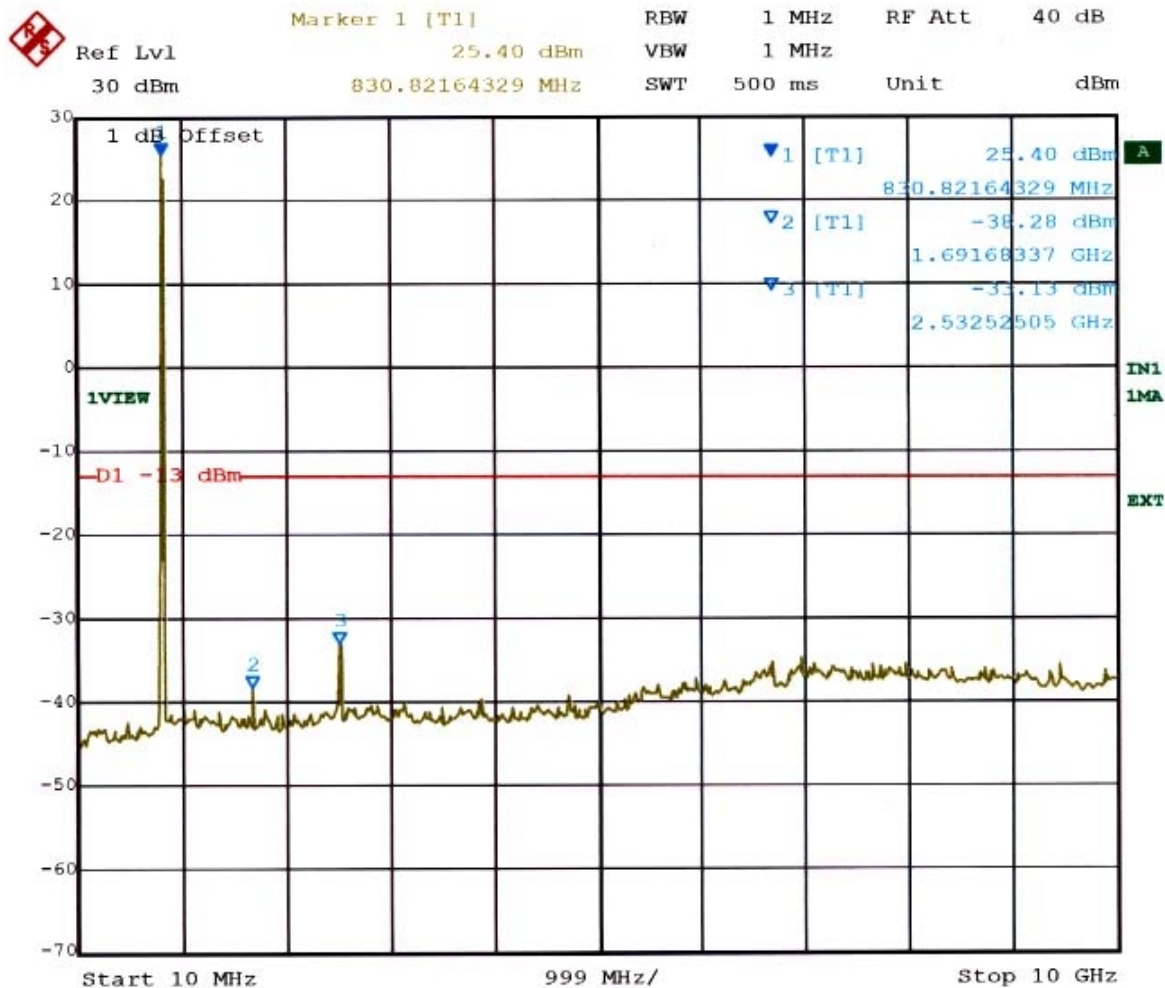

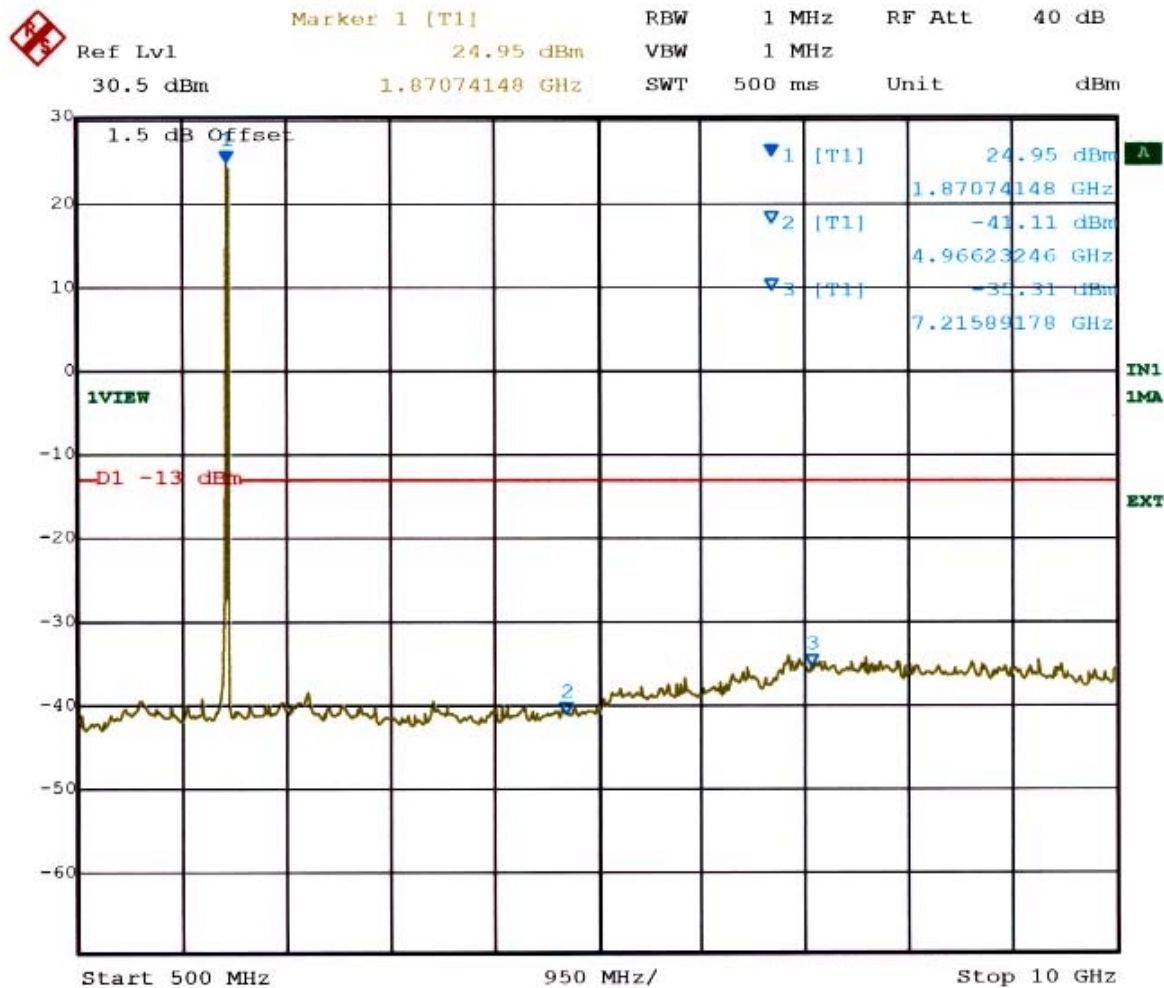

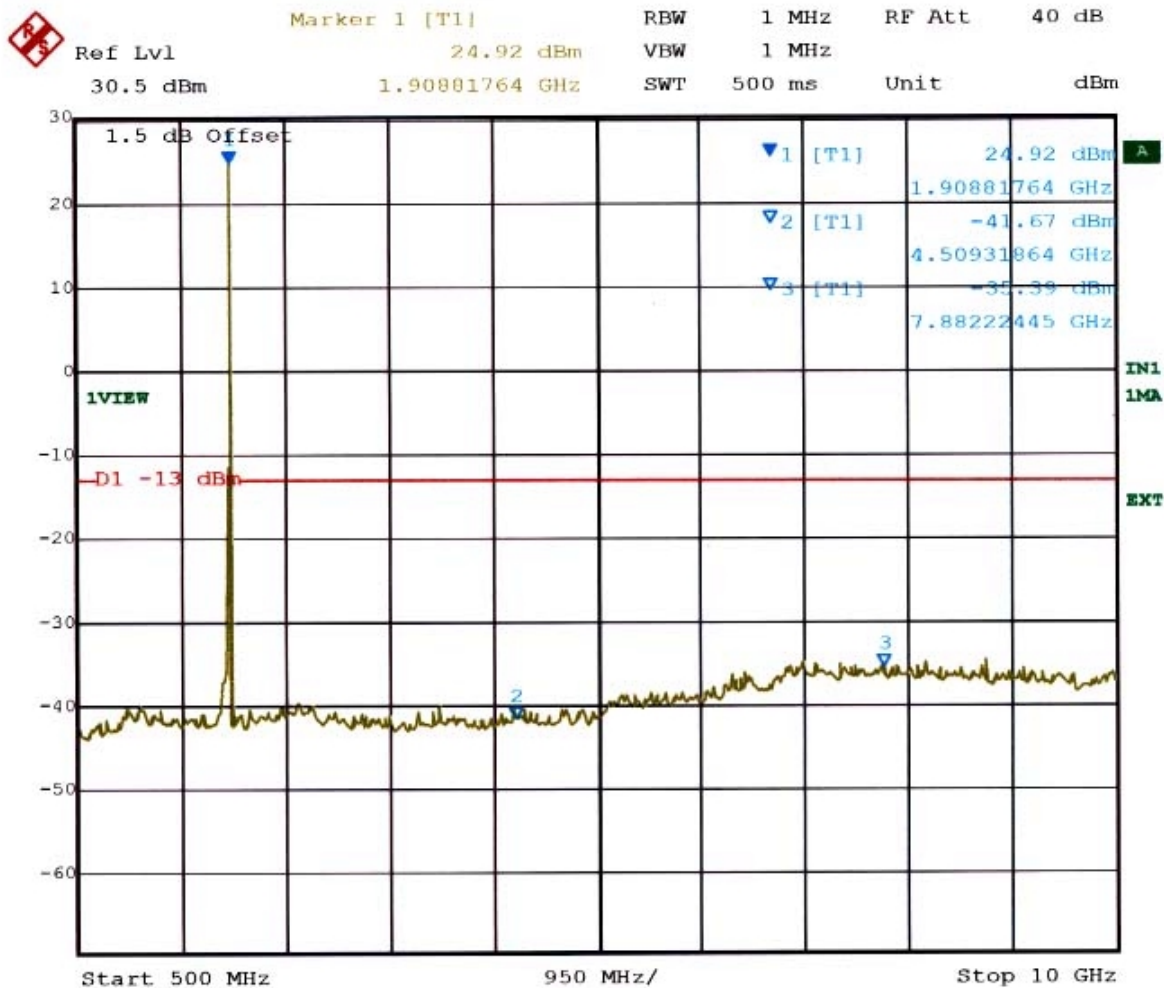

PCS CDMA MODE (1175 CH.) Conducted Spurious



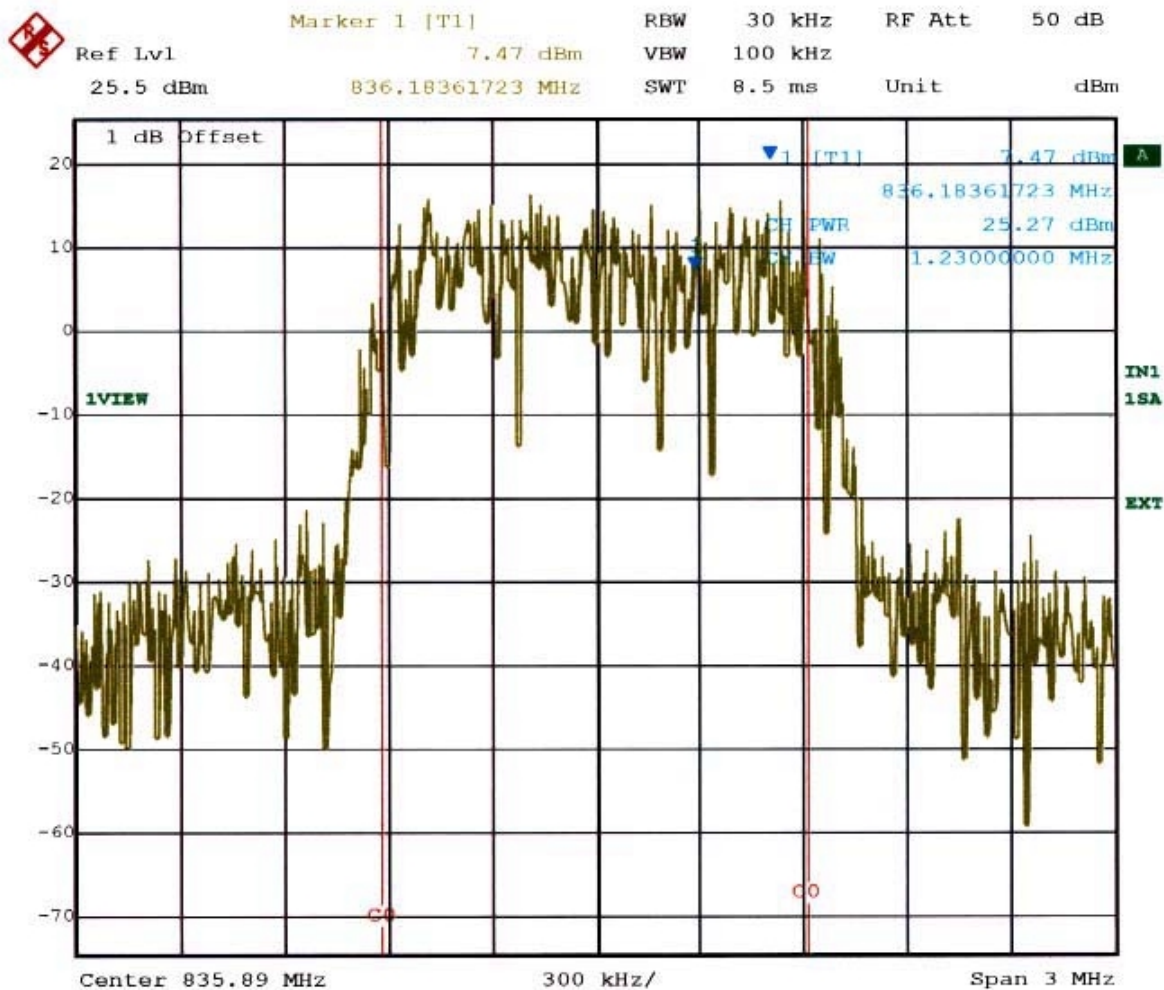

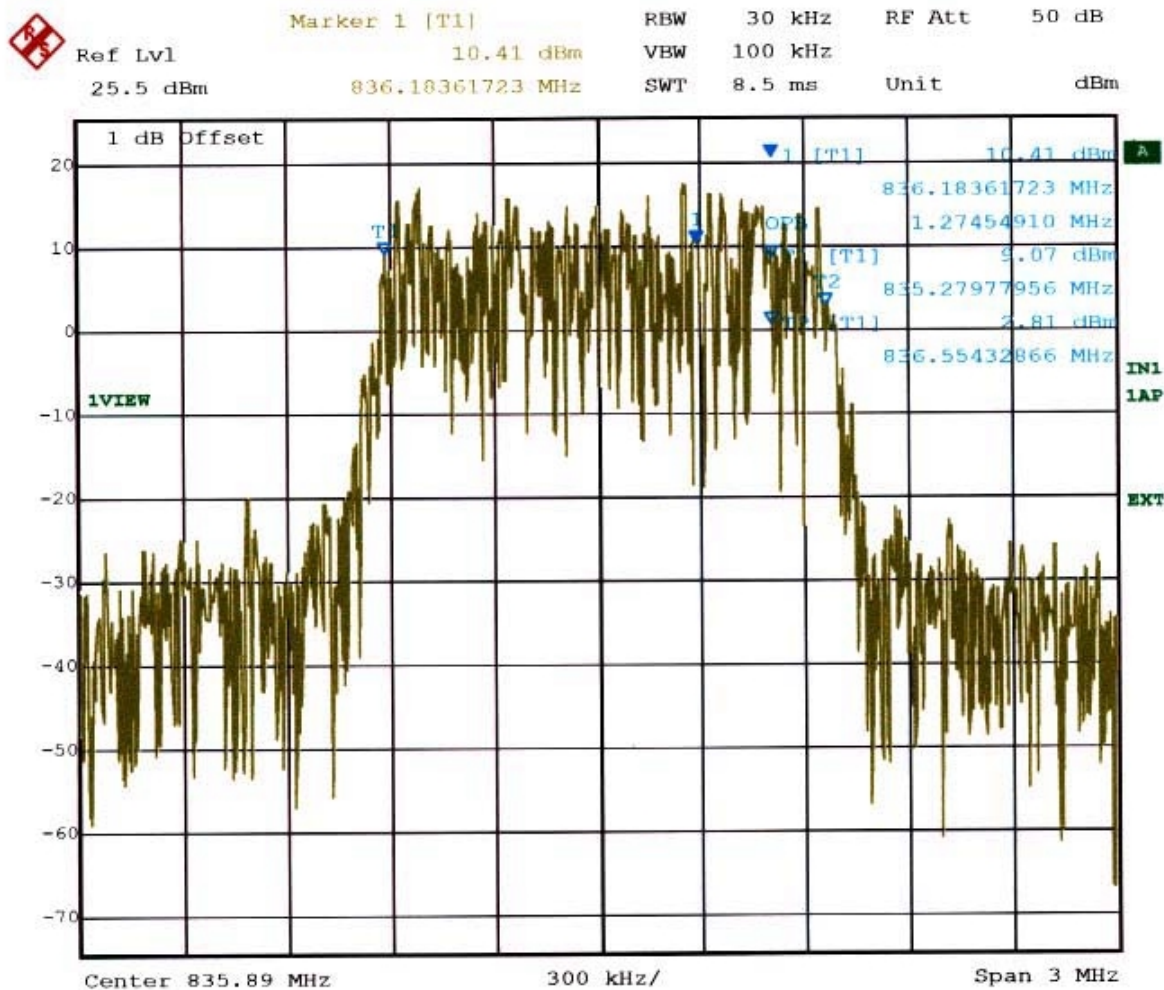

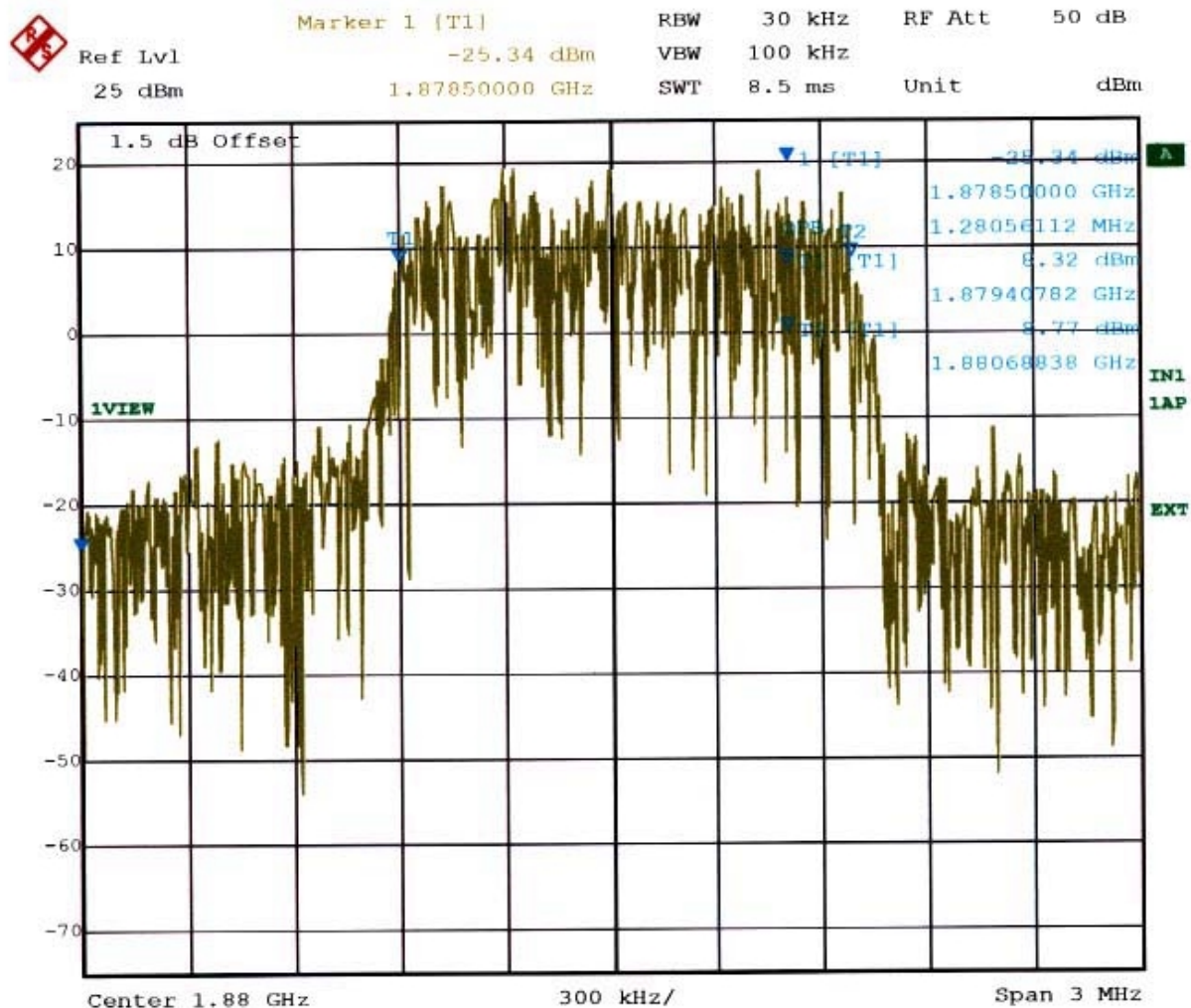

€ CDMA Mode (0363 CH.) : Occupied Bandwidth

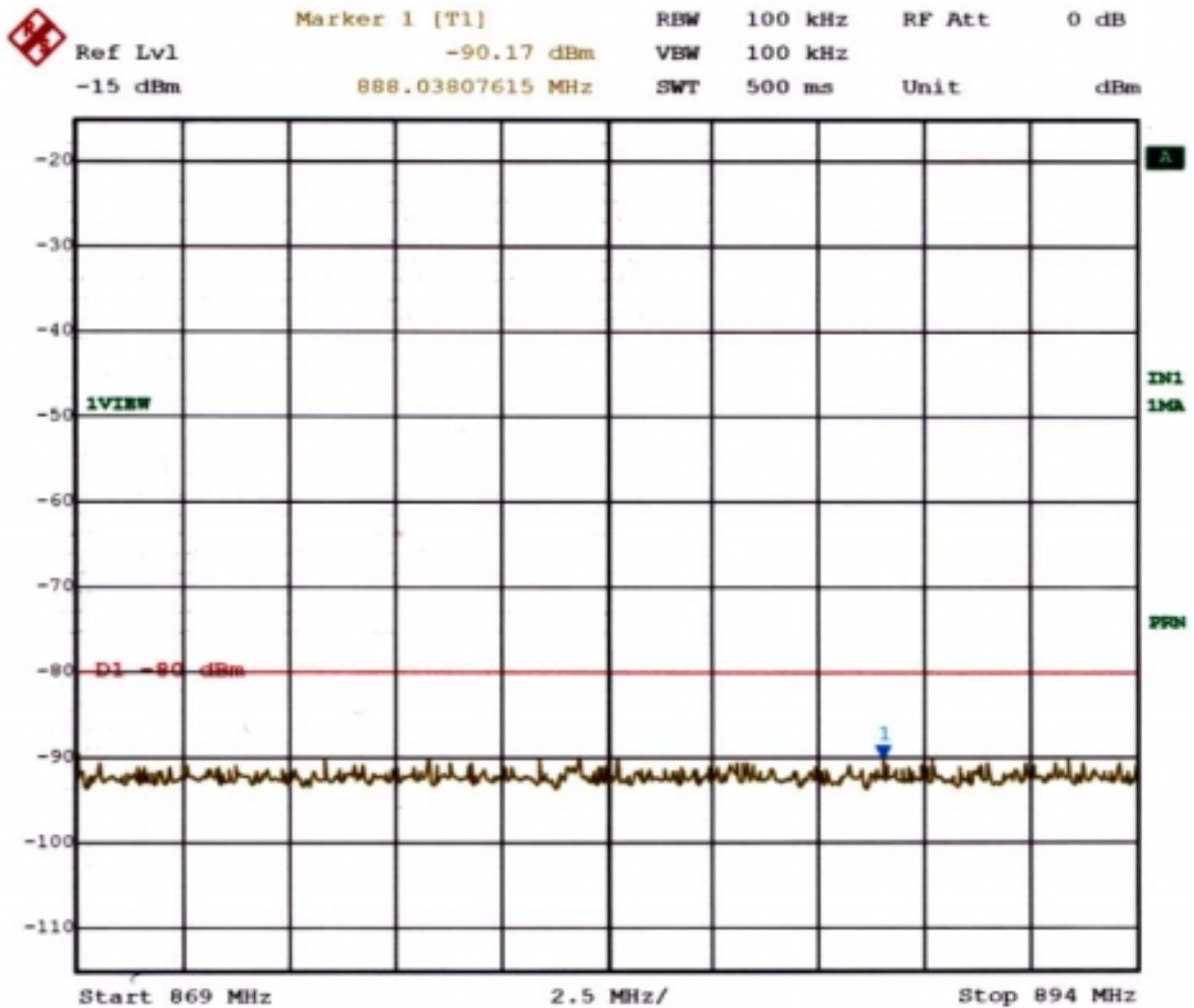

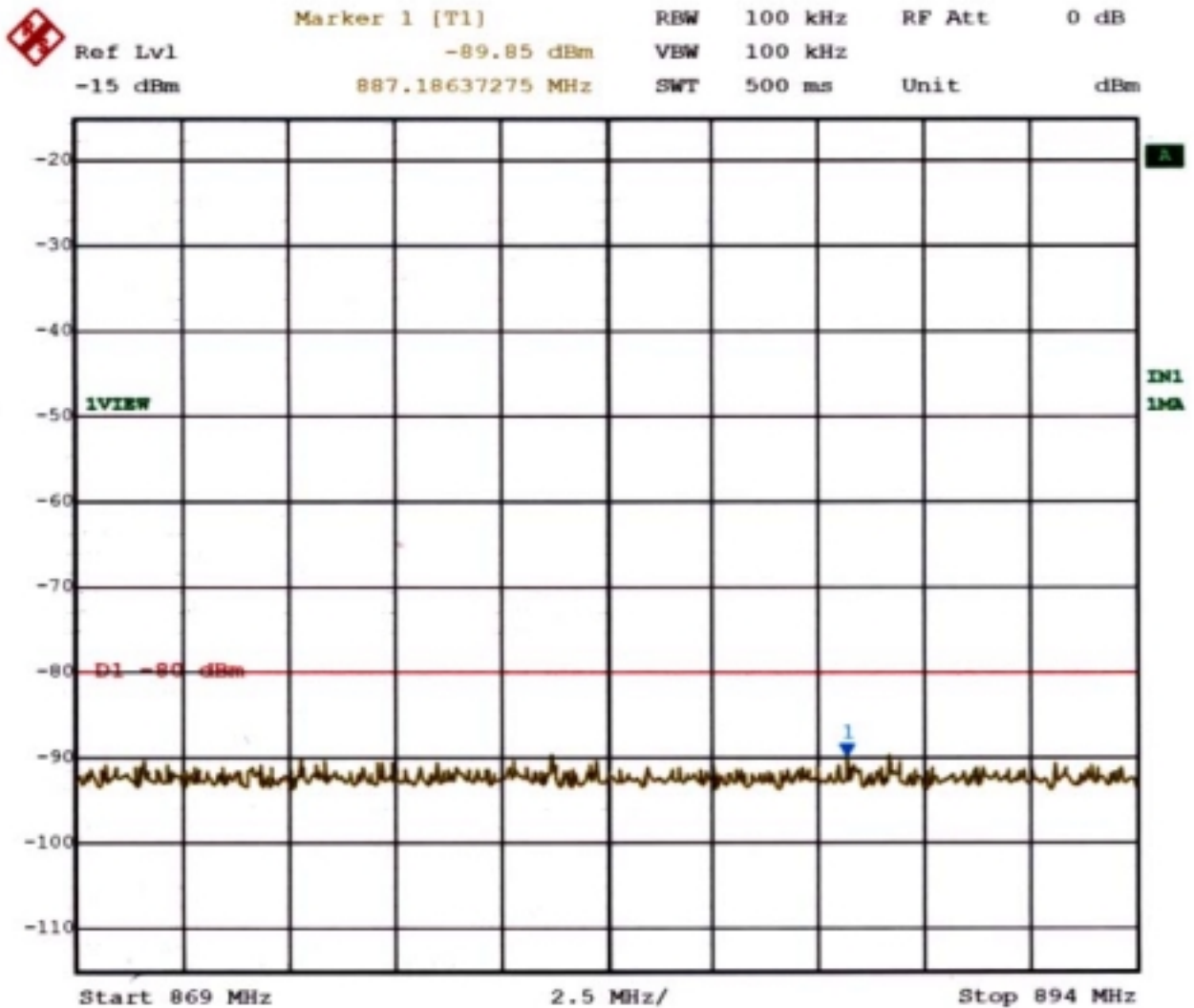
PCS CDMA Mode (0600 CH) : Occupied Bandwidth



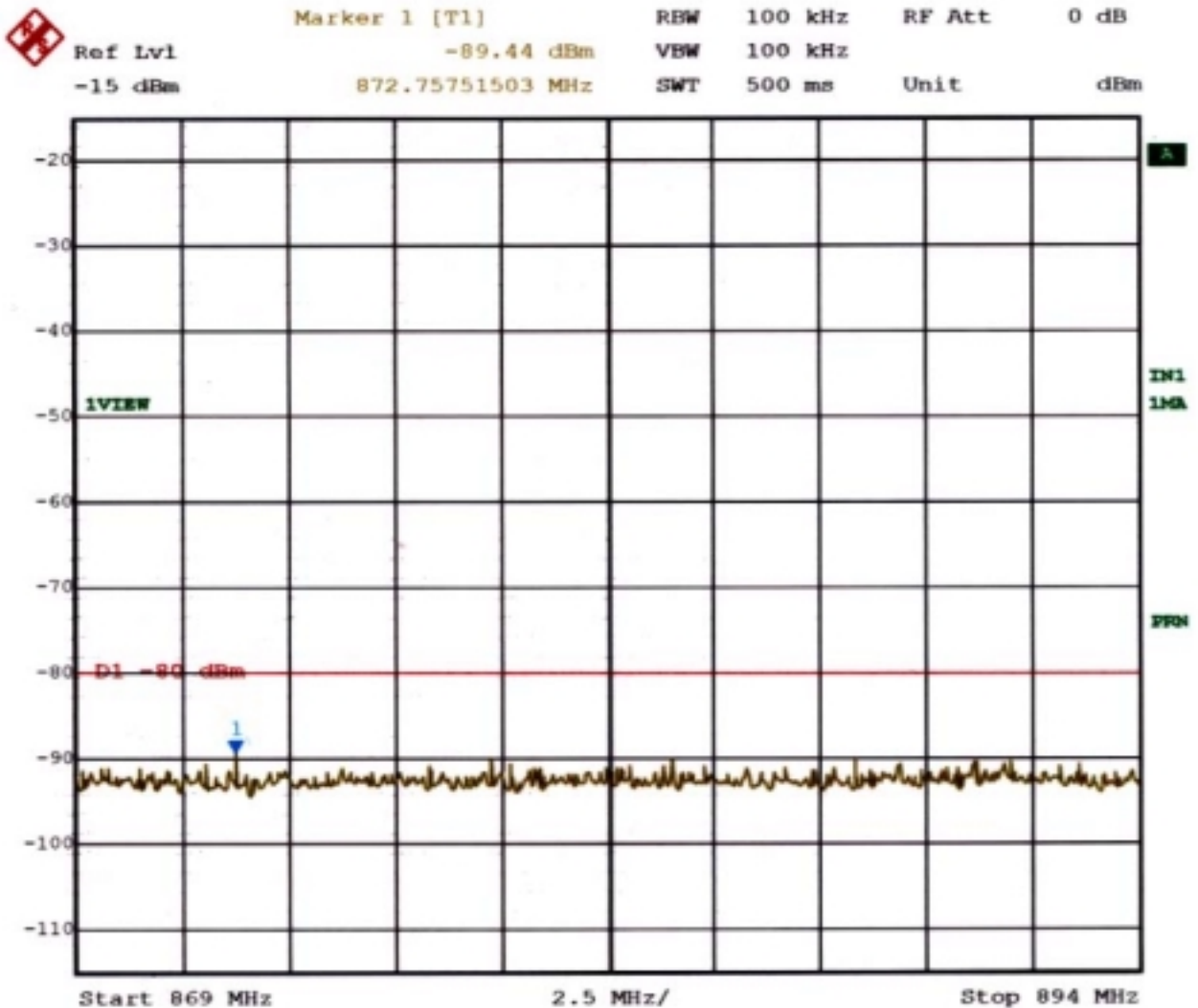

€ CDMA Mode Band Edge (1013 CH.)



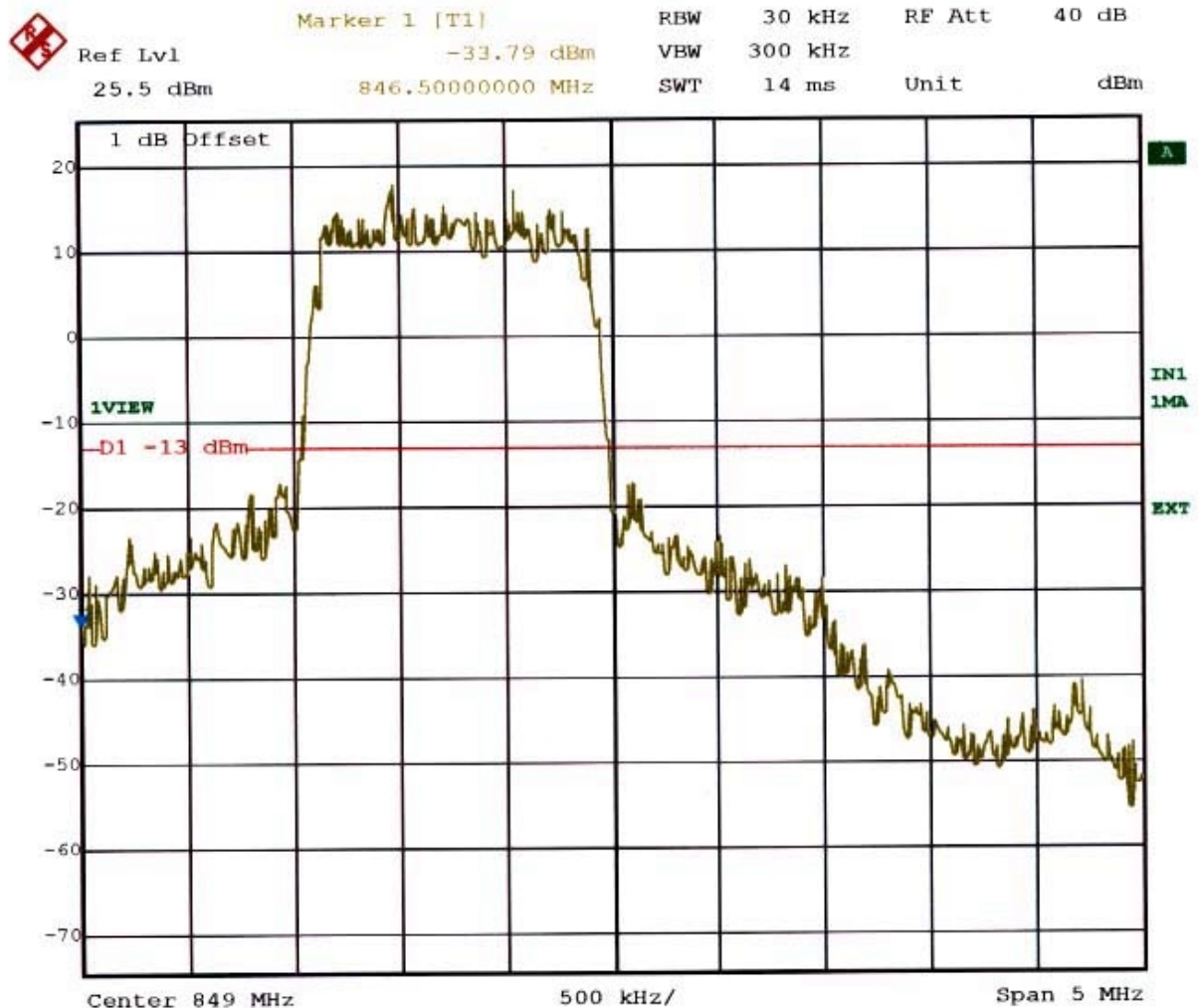

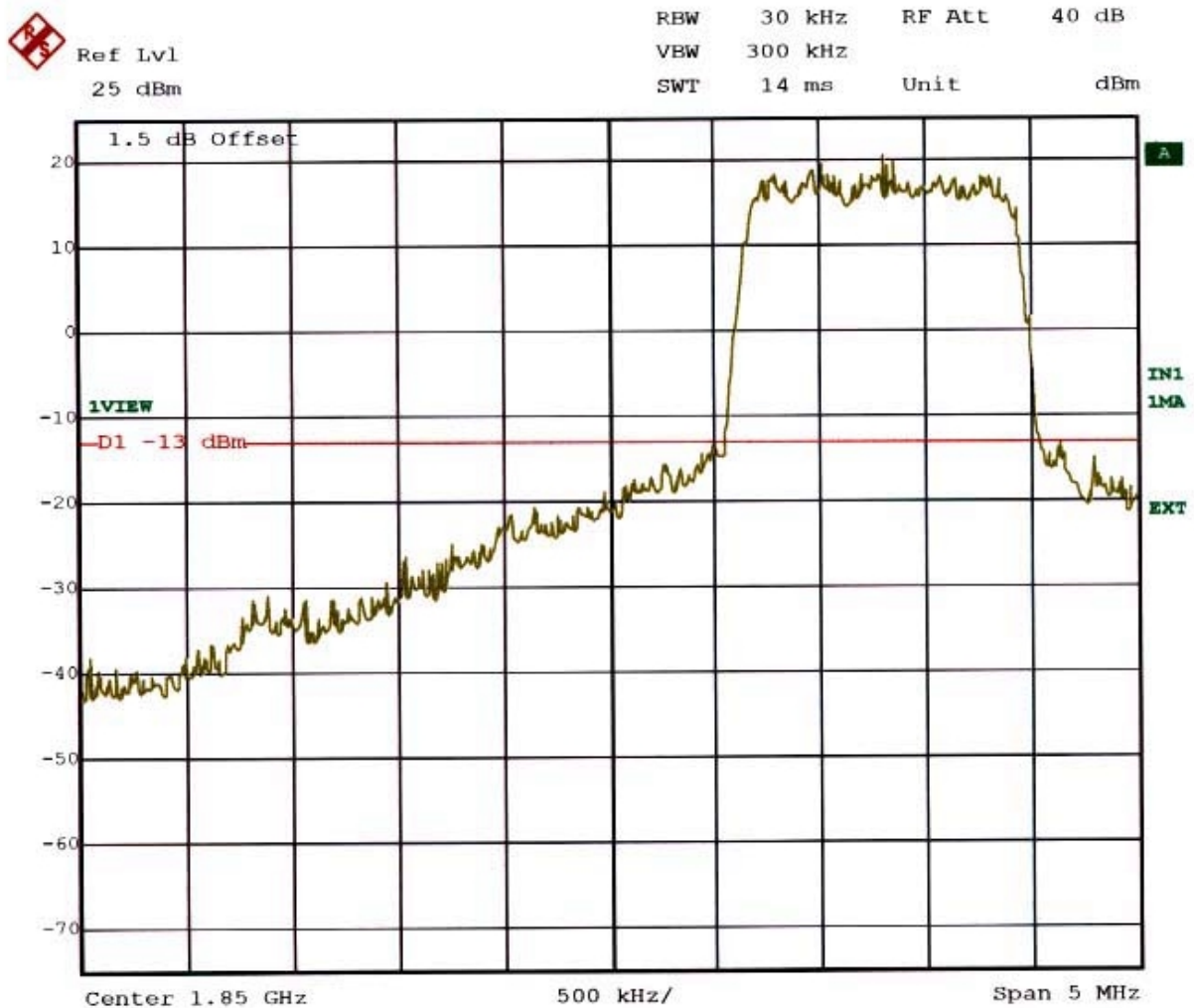

€ CDMA Mode Band Edge (0777 CH.)



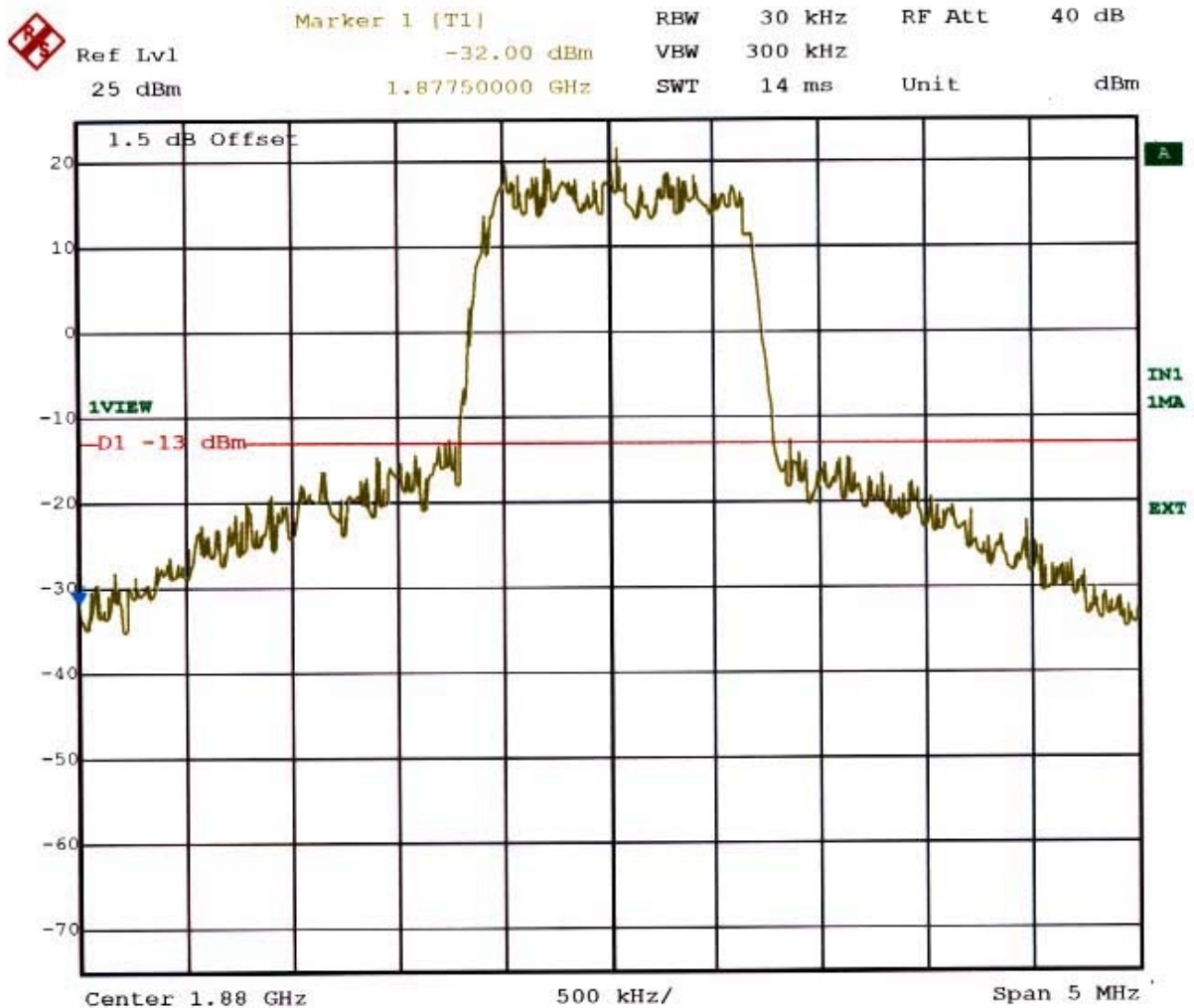

€PCS CDMA Mode Band Edge (0025 CH.)



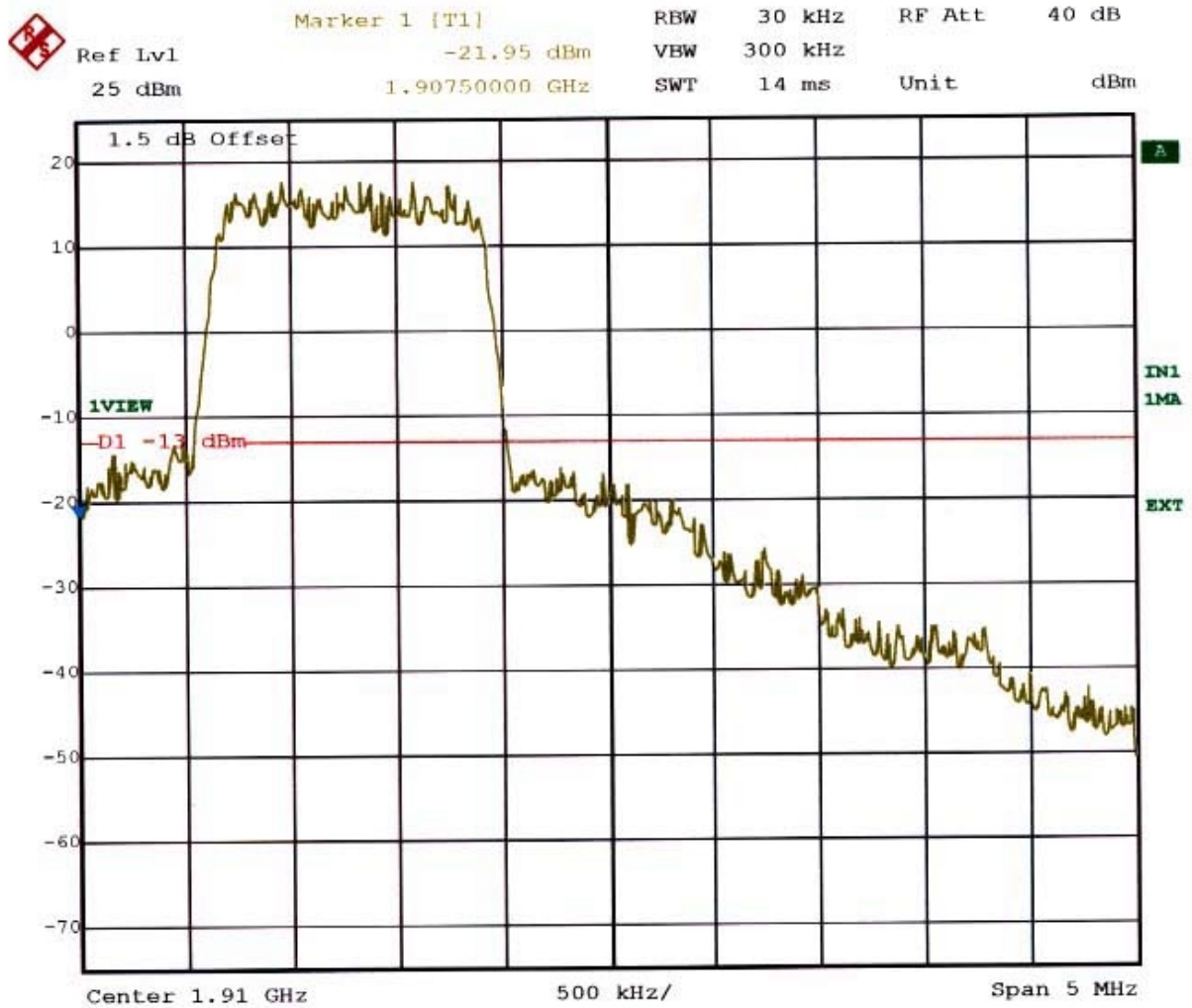

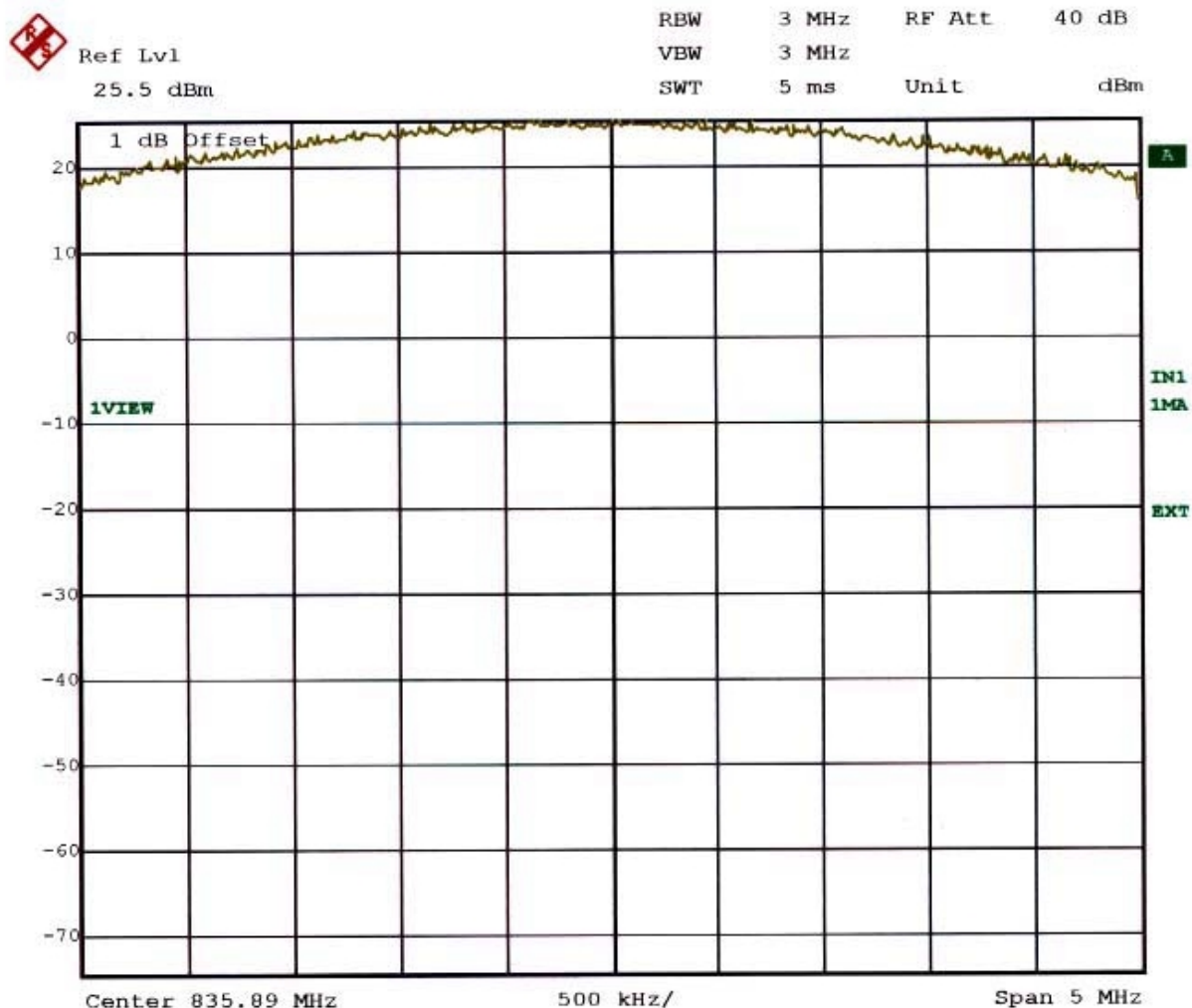

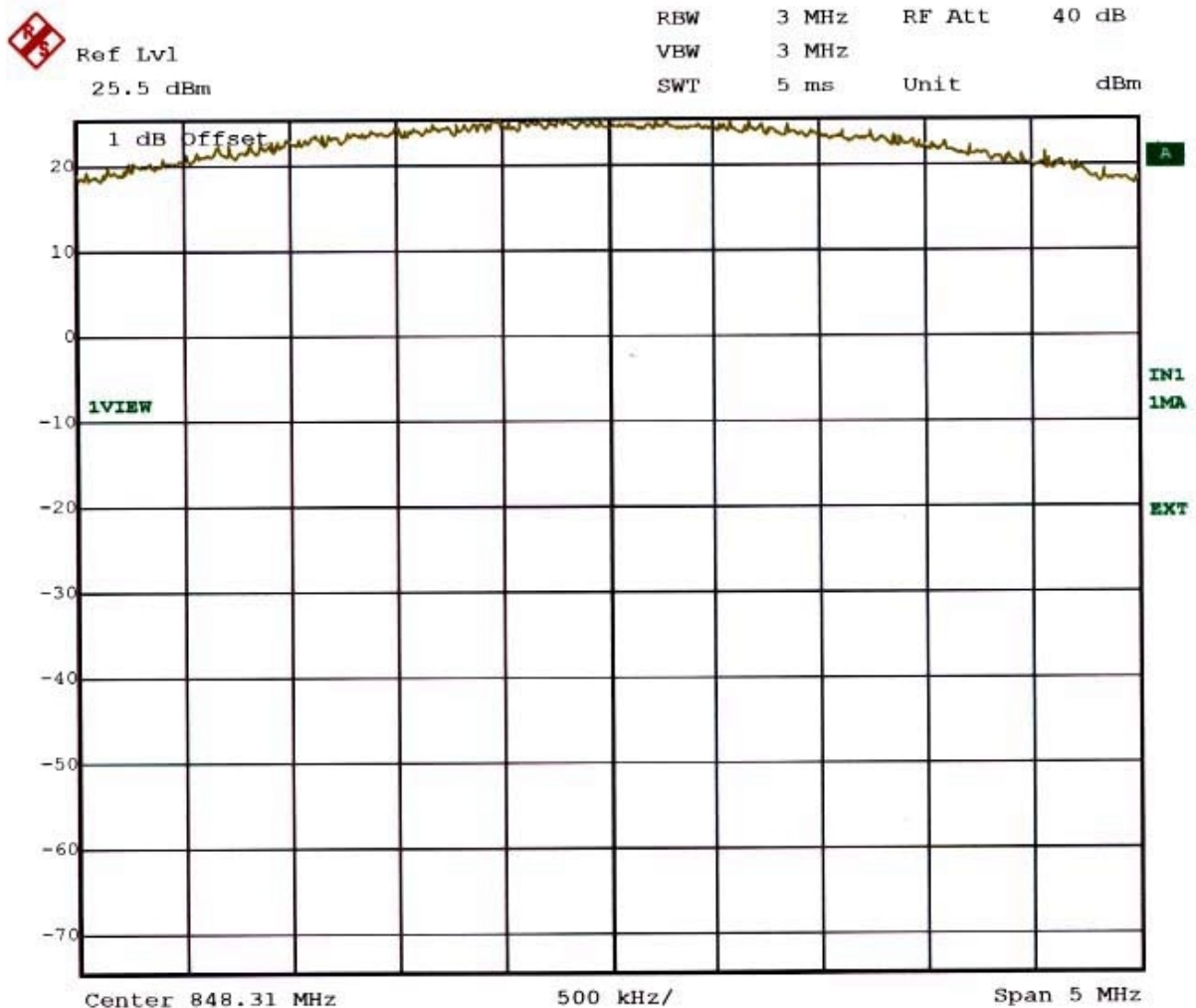

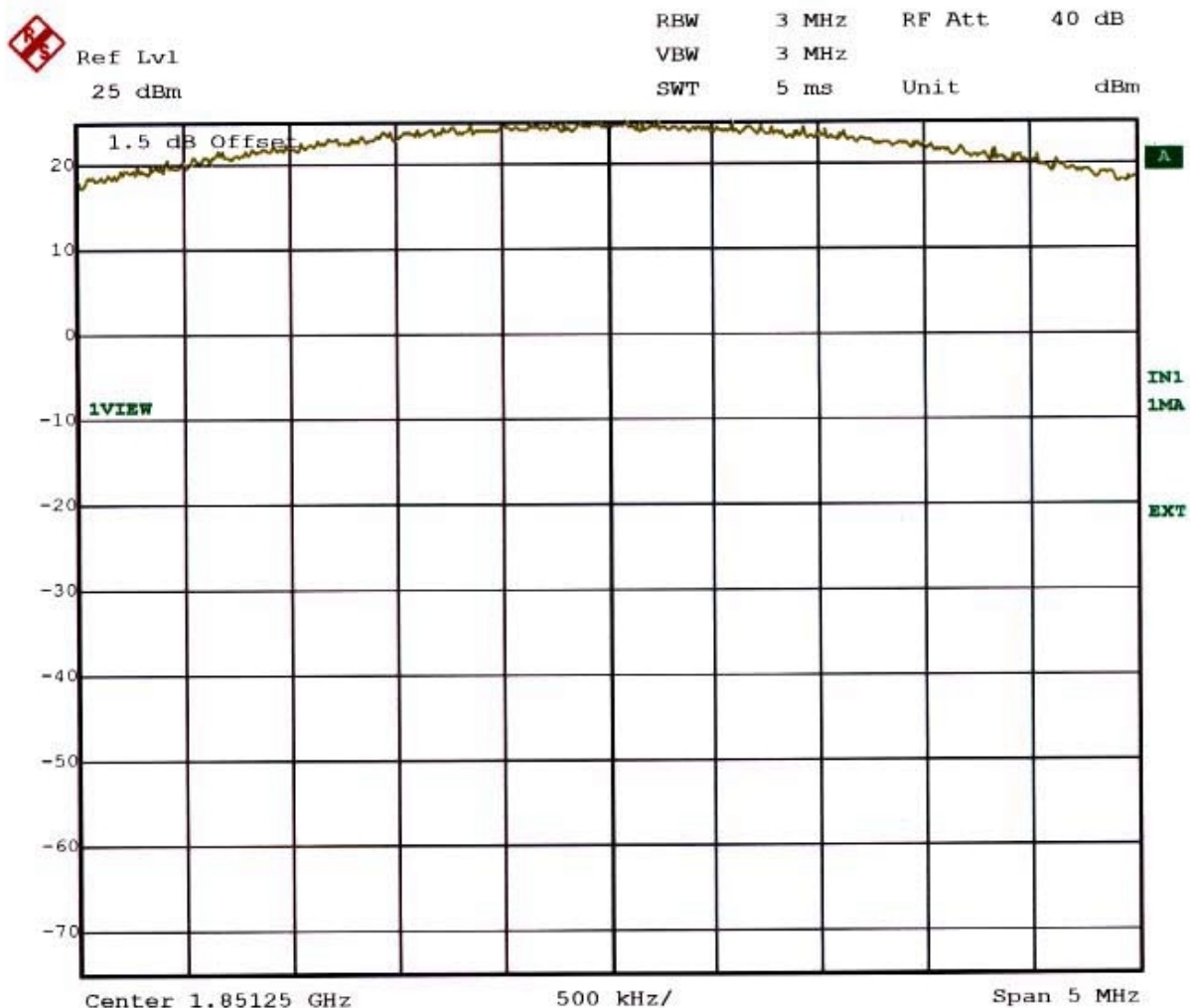

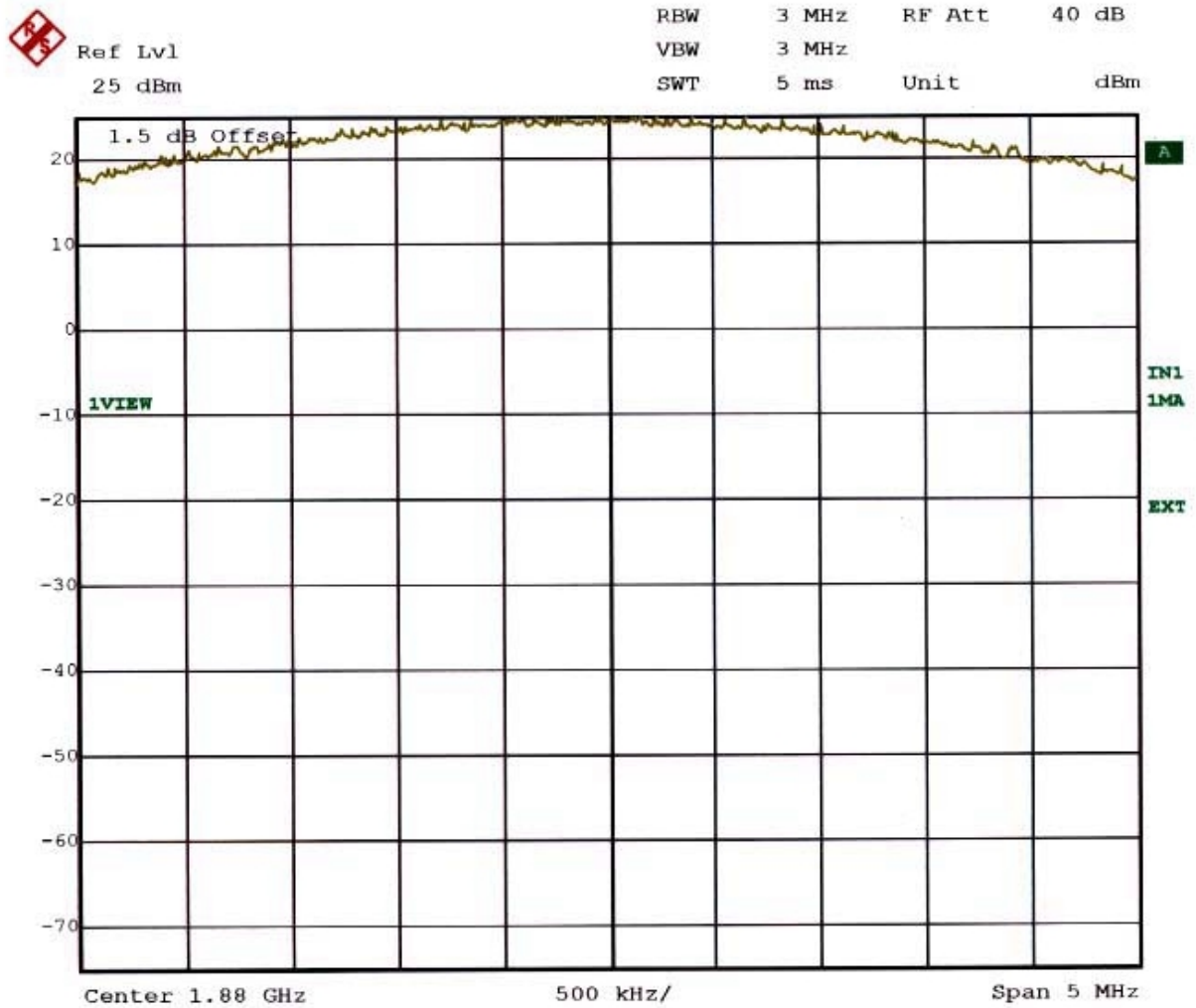

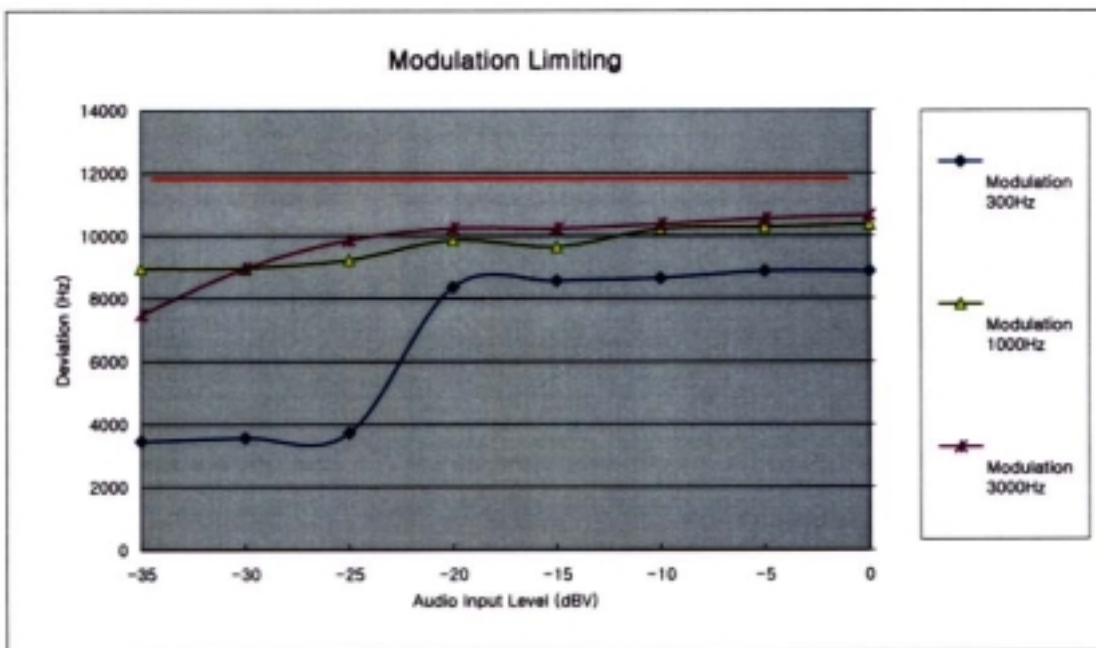

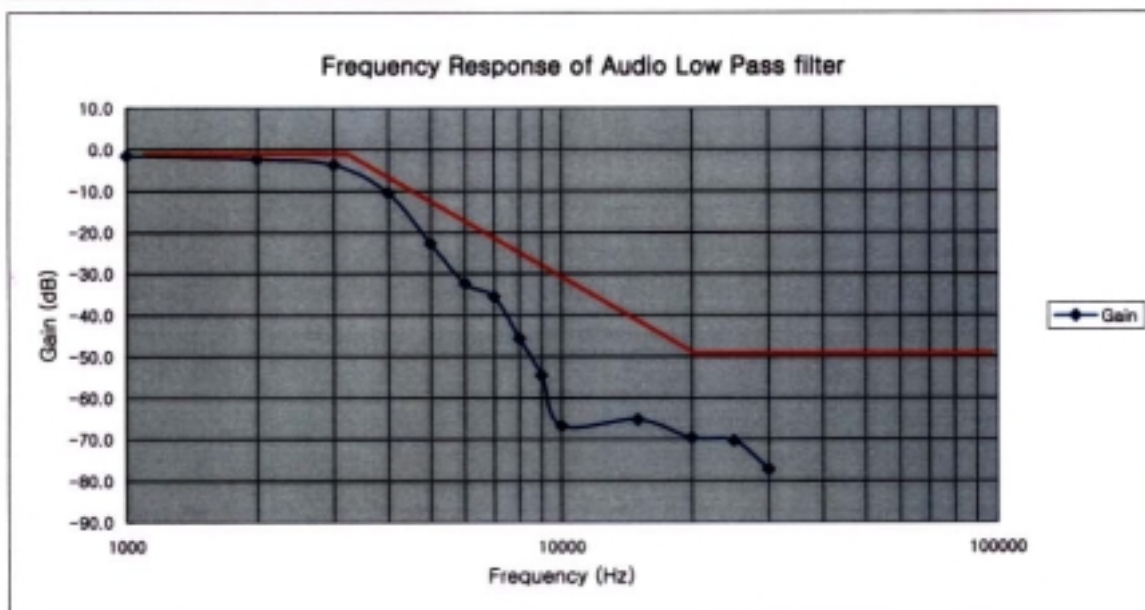
